With reference to the 1st Cited letter, applicant has requested for the approval of residential layout in Ariyalur District ,Udayarpalayam Taluk , Jayankondam Municipality , Jayankondazolapuram Village , Comprised in S.F.No: 130/1A1B1A,1A2B1, with site extent of 6745.00 Sq.m or 1.66 Acres has applied to the District Town and Country Planning Office, Ariyalur for concurrence. In the continuation, with reference to the 2nd cited letter, road pattern for Residential Layout has been issued by the District Officer on 25.03.2026. Further the applicant. Thiru. Senthilkumar and Three others has gift deeded the road, road splay and Common areas has been handed over to The Comissioner jayankondam Municipality and SE/TANGEDCO, on 02.04.2026. Hence, the proposed Residential Layout has been approved and the Approval No. is LA/DTCP(AD).No.17/2026.Also, Layout Developer/owners have to develop the infrastructure works and other procedures to be followed:

- 1.The applicant should submit the original Gift deed to the concerned local body.
- 2.Layout Developer/owners should be obtained Final approval from concerned Local body and it is requested to send a copy to this office by the Local Body.
- 3.After the final approval of the local body. It is mandatory to send the approved layout copy to the concerned sub-registrar office and Land Survey department at Ariyalur District.
- 4.It is requested to send the acknowledgment of receipt after obtaining the online approved layout and proceeding orders.
- 5.It is detailed that the final approval should be given only after the proposed sub-division roads, public use (A) and TANGEDCO (B) are handed over to the concerned local authority and its original deed is received.
- 6.In 13th reference cited, it is requested to send the proceeding orders and copy of layout to the concerned Thasildhar for updating in Tamil Nilam website.

Special Conditions

1.a) In Reference 10th and 11th cited letter, If the proposed site located within the Municipal/ Corporation areas, Collecting the necessary fees including the charges for providing amenities like roads, storm water drains and street lights from the applicants. After collecting the necessary fees, the final layout sketch, permit of planning authority along with approval of Local Body shall be issued to the applicant(s) directly.

b) Other than Municipal/ Corporation areas: Shall collect the necessary fees and issue the final layout sketch, permit of planning authority along with the permit of local body to the applicant (s) directly, only after ensuring that the applicant lays tar roads, provide other amenities like storm water drains, water supply facilities by constructing required OHT, provide necessary street lights etc., as per the standards specified by the local body

2. In 12th and 13th cited, the concerned local body should issue the final approval after the completion of revenue sub-division which was earlier handed over the road area and park area through registered Gift deed to local body.

3.In Rule 13, TamilNadu Combined Development and Building Rules 2019, Cancellation of permit – “The Planning permission or building permit if secured by any person by any misrepresentation or by

production of false documents, such planning permission or building permit will be cancelled after issuing a show cause notice."

4.The Tamil Nadu Government in G.O.Ms.No.112, Housing and Urban Development Department, dated 22.06.2017 have approved the Tamil Nadu Real Estate (Regulation & Development) Act 2016, The promoter has to advertise, Market, book sell or offer for sale or invite persons to purchase in any manner any plot, apartment or building, as the case may be, in any Real Estate Project or part of it only after registering the Real Estate Project with the Real Estate Authority. The applicant has requested to follow the protocols as per instruction given by TNRERA.

5.Plots reserved for Economically Weaker Section (EWS) should not be amalgamated or rearranged. But in rural areas, if the EWS plots are not sold out more than 3 years, after the plot approval, as per G.O.16, Municipal Administration and Water Supply Department, dated:31.01.2020, should be applied in appropriate permission for amalgamation of EWS plots.

6.The applicant shall adhere to the guidelines in 20th reference cited.

7.The applicant shall adhere to the guidelines provided by the TNRERA Official in 21th reference cited.

8.The Local body has to ensure about the approach road details of proposed residential layout prior issuing of Final Approval.

1.In G.O.79 Housing and Urban Development Department, dated: 04.05.2017,

I.Rule 3 of Non-Planning area that local body has to levy of Rs.1000/- for each and every plots in the approved layout as a scrutiny fee.

II.Rule 9, concerned local body should collect 3% Market Land Value as Land Conversion Charges prior issuing of final approval. The account detail is below:

2.According to the Circular No. 12544/14 / CB dated: 04.07.2014 stating that, The Directorate of Town and Country Planning Department has not legally certified the title to the ownership by granting technical clearance and planning permission. Only the applicant's entitlement to development is verified in the documents submitted with the applicant's application (lease deed, sale deed, gift deed, etc.) Any person wishing to purchase the property must individually assert ownership of the property to the applicant. Also, if anyone else dispute arises individual rights over it, they can settle it before the appropriate competent court. The Directorate of Town and Country Planning Department is not the right organization to decide this.

3.In the reference 17th cited that the simplification of the development of Infrastructure works to be carried out by the developers/owners in the approval of layout that are follows:-

"The owners / developers shall be allowed either to carry out infrastructure development works as per the standards specified by the local body concerned or to pay the estimate cost to the local body. Concerned local body shall prescribe the standards for the provisions of basic infrastructure like roads, drains, water supply etc. for the layout, as per existing rules. Before taking over the infrastructure developed by the owners / developers, the local bodies shall ensure the quality of the works done by the owners / developers. Reasonable period to be prescribed for up keep/maintenance of the roads and drains by the owners/developers. Wherever layouts develop at a slow pace, the maintenance period shall be extended till 60% of the plots developed in the layout or 5 years whichever is later."

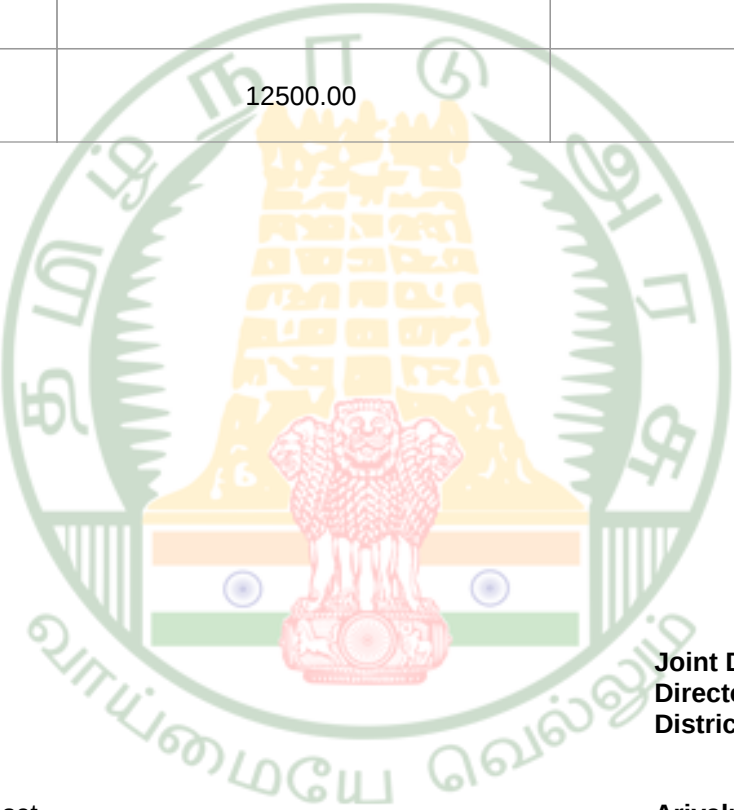
