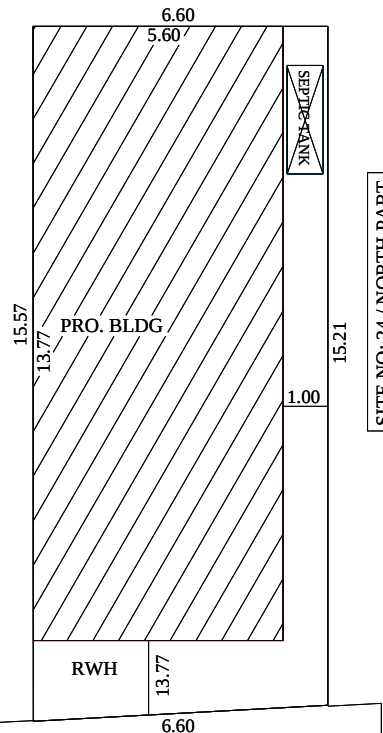
ELEVATION

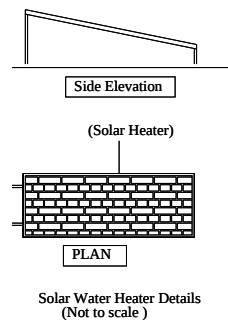
