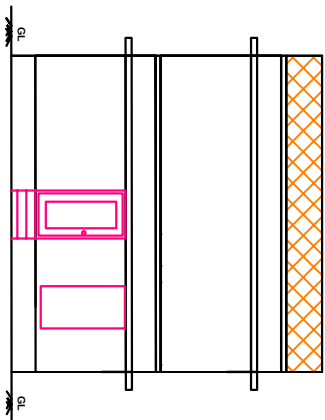

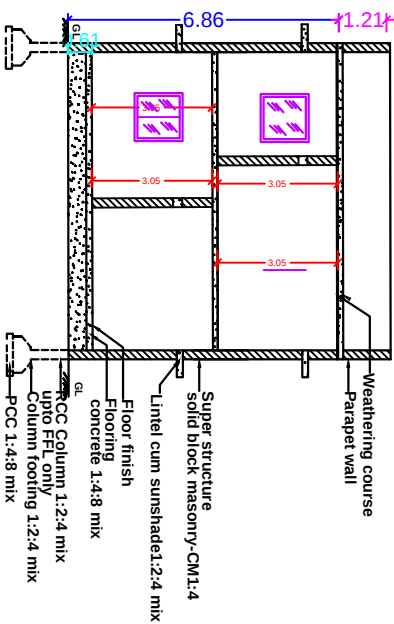

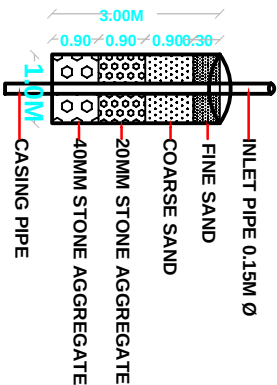

FRONT ELEVATION

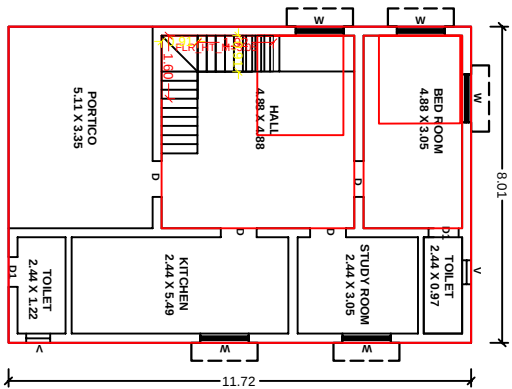


SECTION ELEVATION

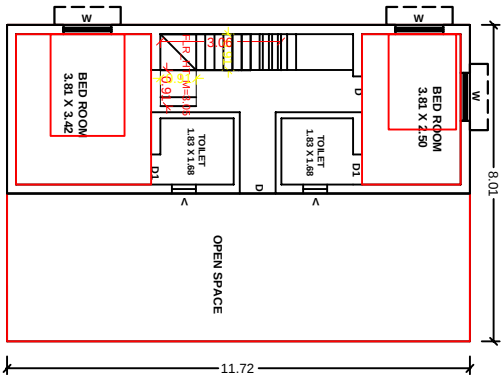


DETAILS OF RAIN WATER
HARVESTING STRUCTURES

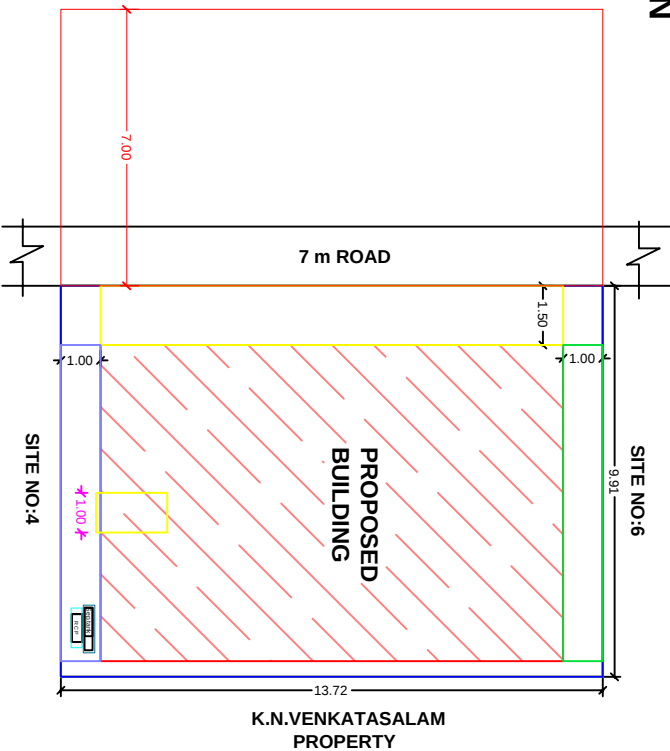

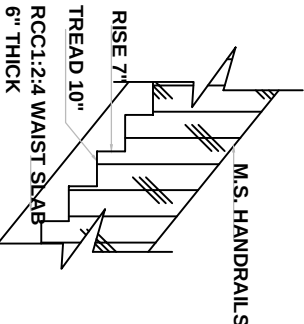
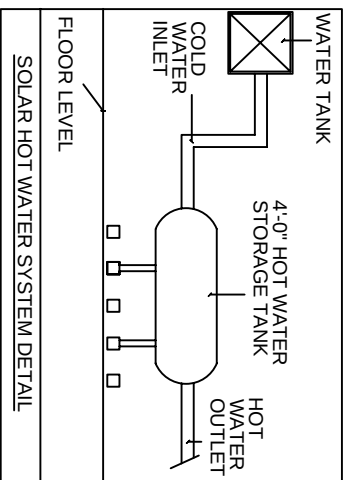
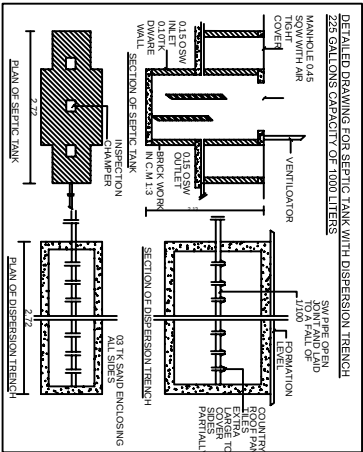
GROUND FLOOR PLAN

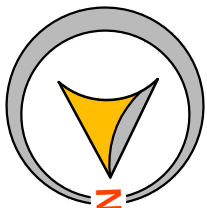
