AT VELLANAIPATTI VILLAGE AND PANCHAYAT, ANNUR TALUK AND COIMBATORE DISTRICT.



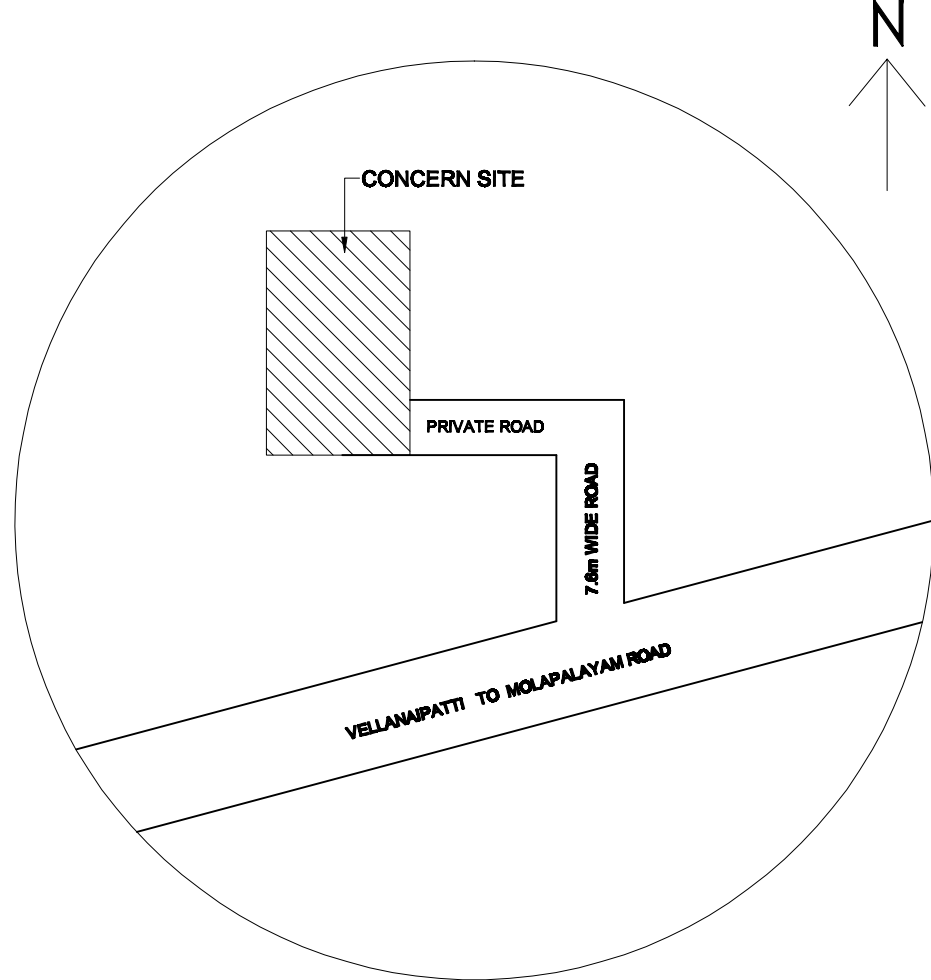
FRONT ELEVATION



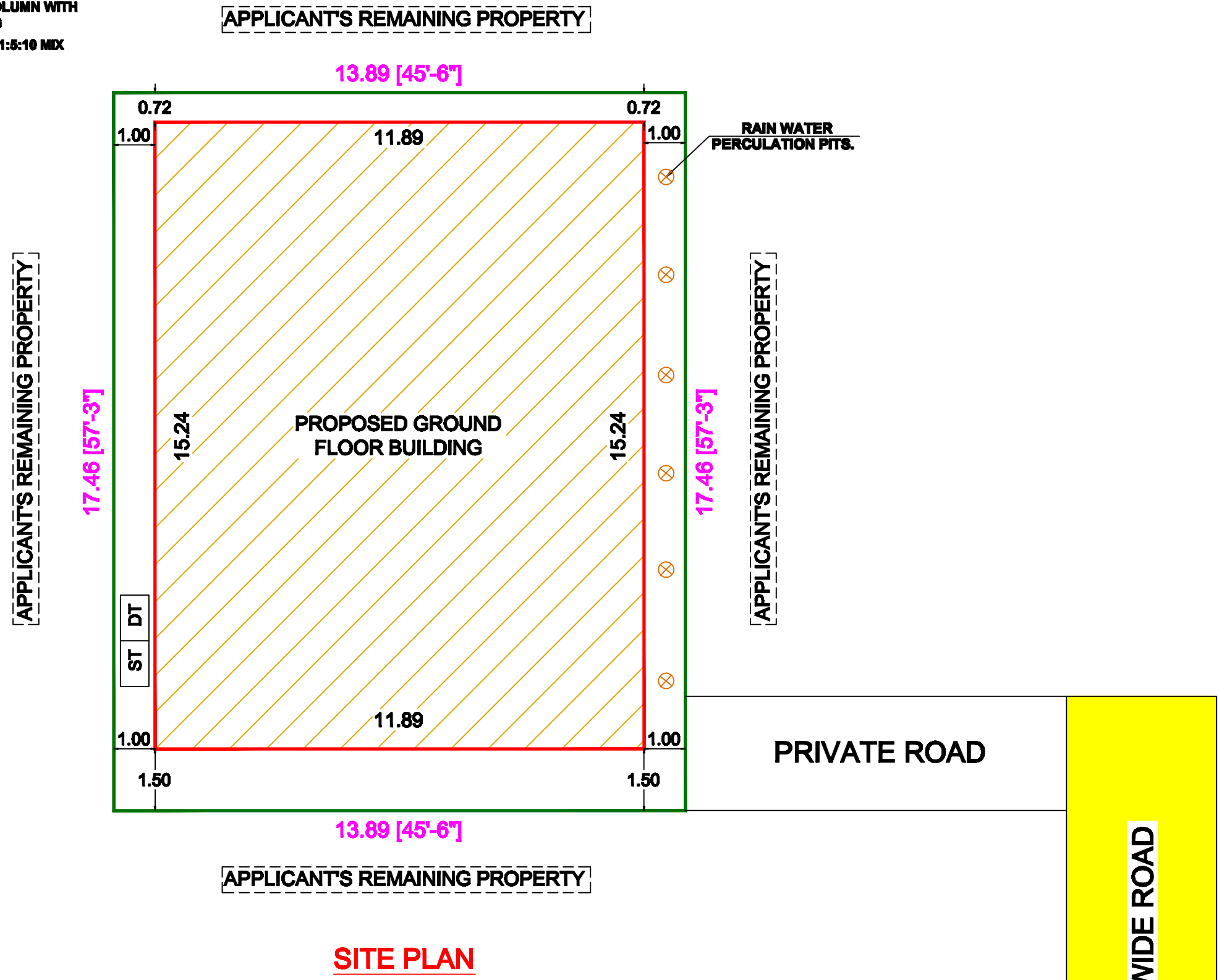
CROSS SECTION A-A
