ORDER :

As per Plot Pattern Technical Concurrence issued by Directorate of Town and Country Planning, Chennai vide SWP Application Number: 12SF3YBT-2025-TCP7 on 18.02.2025 as reference 18,
The application seeking technical Approval for the proposed formation of Residential Layout to an total extent of 30890.00 Sq.m in the land bearing S.F.No 867/2C1B3 at Adhiyamankottai
Village / Panchayat of Nallampalli Panchayat Union / Taluk of Dharmapuri District was processed as per the prevailing rules and after perusing the records the applicant was directed to handover the portion of land earmarked for Road, Park, Public purpose Meant for Local body and TANGEDCO vide reference 15th cited above

On Receipt of Gift deeds vide reference 16th cited above, the Plot Pattern Technical Concurrence issued by Directorate of Town and Country Planning, Chennai vide SWP Application Number: 12SF3YBT-2025-TCP7 on 18.02.2025 As Concurrence number assigned to the layout is LP/DTCP No.18/2025 and On receipt of payment of Centage charges vide reference 17th cited above, the technical Approval is issued to the mentioned Residential Layout subject to the following conditions.

- 1) Conditions and Order of Plot Pattern Technical Concurrence issued by Directorate of Town and Country Planning, Chennai vide SWP Application Number: 12SF3YBT-2025-TCP7 on 18.02.2025 must be followed.
- 2) The Technical Approval is issued to the above mentioned Residential Layout Following the order of Plot Pattern Technical Concurrence issued by Directorate of Town and Country Planning, Chennai vide SWP Application Number: 12SF3YBT-2025-TCP7 on 18.02.2025 and the number is assigned as SWP /DTCP/Dharmapuri / Layout Approval No :16/2025
- 3) The local authority shall accord permission duly following the rules / regulations/ Orders issued from time to time under the respective acts.
- 4) The Local authority shall accord Final approval after collecting requisite fees / charges as applicable and the copy of the approval issued shall be forwarded to this office for record.
- 5) Also, the local authority shall forward the copy of such Final approval to the office of Sub registrar of Registration department and the office of the Assistant Director of Survey and land records concerned for information and for making mutation in their records.
- 6) Also, the local authority shall forward the copy of such Final approval to the Tahsildar concerned with a direction to the applicant to pay the requisite charges for making mutation in the Tamil Nilam /Collabland website.
- 7) The acknowledgement of receipt of proceedings and drawing shall be forwarded to this office through mail.

SPECIAL CONDITIONS:

- 1) This office has not legally certified the title to the ownership by granting the technical clearance and planning permission. Only the entitlement to develop the land by the applicant is verified through the documents uploaded in the web portal. Any person wishing to purchase the property must individually ascertain the ownership of the property of the developer / seller. If any dispute arises towards the ownership, the same shall be settled through the appropriate forum. This office is not the appropriate authority to decide on this.
- 2) The owners / developers shall be allowed either to carry out Infrastructure development works as per the standards specified by the local body concerned or to pay the estimate cost to the local body. local body shall prescribe the standards for the provisions of basic infrastructure like roads, drains, water supply etc. for the Residential Subdivision, as per existing rules. Before taking over the Infrastructure developed by the owners/ developers, the local bodies shall ensure the quality of the works done by the owners/ developers Reasonable period to be prescribed for up keep / maintenance of the roads and drains by the owners / developers. Wherever layouts develop at a slow pace, the maintenance period shall be extended till 60% of the plots developed in the layout or 5 years whichever is later as envisaged under the directions issued by the Government Order vide references 6th,8th, 9th and 14th cited above.
- 3) As envisaged under the " Tamil Nadu Real Estate (Regulation & Development) Act 2016, the promoter has to advertise, market, book, sell or offer for sale or invite persons to purchase in any manner any plot, apartment or building, as the case may be, in any Real Estate Project or Part of it only after registering the real Estate project with the Real Estate Authority. The applicant has to comply the said provisions.
- 4) If the Residential Subdivision is located in an area other than planning area, the local authority shall also

collect the Scrutiny fee Rs.1000/- per plot and 3% of market value of land as land use conversion charges before issuing the final approval as envisaged in Government Order under the reference 3rd cited above. The payment of charges shall be made under the following head of account.

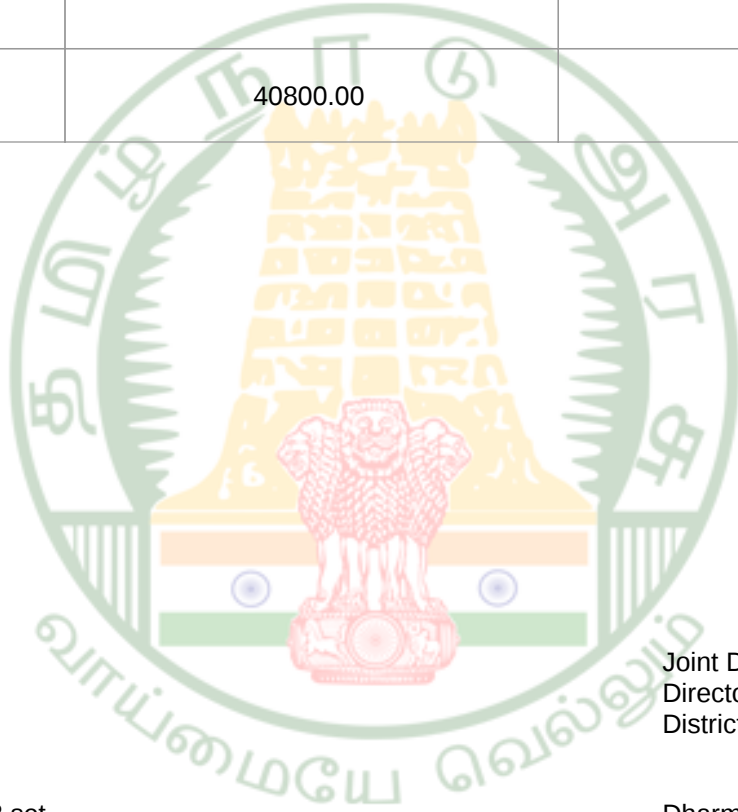
