With reference to the letter in the 1st cited, applicant has requested for the approval of Residential Subdivision in Dharmapuri District, Nallampalli Panchayat union / Taluk, A.Jettihalli Panchayat , A.Jettihalli Village, S.F.No. 475/1N2, 475/1O2, 475/1P2 , Site extent of 981.50 sqm (0.24 1/4 Acre)

As per circular cited in 12th Rule No.47,(h)(6)(b) of the TNCDBR 2019 provides for conversion The land reserved for public purpose use in approved layout vide L.P/D.T.C.P.NO.413/1993 has remained vacant and unused for the intended purpose had been for a long period and applicant like that therefore As per cited in 18th the land use has been converted from public purpose use to residential use .

Further the applicant has paid the Centage Charges ,Subdivision Charges and Development Charges on 03.07.2026. Hence, The Technical Clearance is issued to the said subdivision subject to the following conditions.

1. As per the condition, Subdivision for Residential use has been approved and approved number is issued as SWP/DTCP/DHARMAPURI/SUBDIVISION APPROVAL No.116/2026 and enclosed with 2 set of original maps has been forwarded with it for further action.

2. Further, when the final approval is given by the local body, it is requested to send a copy of the proceedings to this office immediately.

3. After the approval of the local body, It is requested to send the approved residential subdivision map to the concerned registration department office and land survey department for information and appropriate action.

4. It is requested to send acknowledgment of receipt of having receipt of maps and proceeding orders.

5. As per circular in 11th cited, it is requested to send the proceeding orders and maps to the concerned Tahsildar to update in Tamilnilam website.

Special Conditions

1. The Tamil Nadu Government in G.O.Ms.No.112, Housing and Urban Development Department, dated 22.06.2017 have approved the Tamil Nadu Real Estate (Regulation & Development) Act 2016, The promoter has to advertise, Market, Book sell or offer for sale or invite persons to purchase in any manner any plot, apartment or building, as the case may be, in any Real Estate Project or part of it only after registering the Real Estate Project with the Real Estate Authority. The applicant has requested to follow the protocols as per instruction given by TNRERA.

2. According to the Circular no.12544/14/CB dated 04.07.2014 stating that, the Directorate of Town and Country Planning Department has not legally certified the title to the ownership by granting technical clearance and planning permission. Only the applicant's entitlement to development is verified in the documents submitted with the applicant's application (lease deed, sale deed, gift deed, etc.) Any person wishing to purchase the property must individually assert ownership of the property to the applicant. Also, if anyone else dispute arises individual rights over it, they can settle it before the appropriate competent court. The Directorate of Town and Country Planning Department is not the right

organization to decide this.

3. As per G.O.79 Housing and Urban Development Department, dated: 04.05.2017, in-case of non-planned area rule 3 it has been requested to collect Rs.1000 as scrutiny fee for each plot. And under rule 9 concerned local body should collect the 3% Market Land Value as Land conversion charges, before issuing the final approval

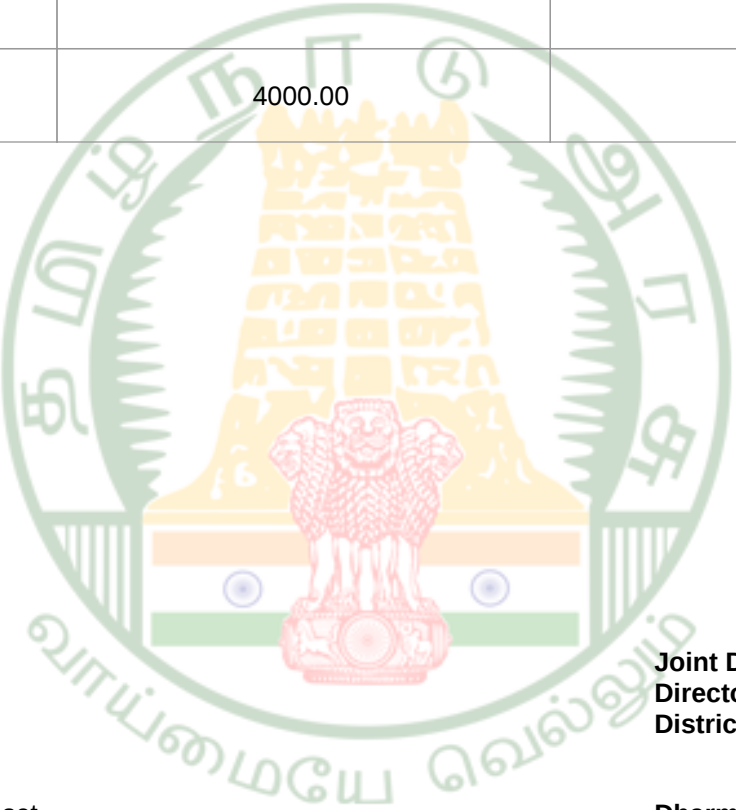
