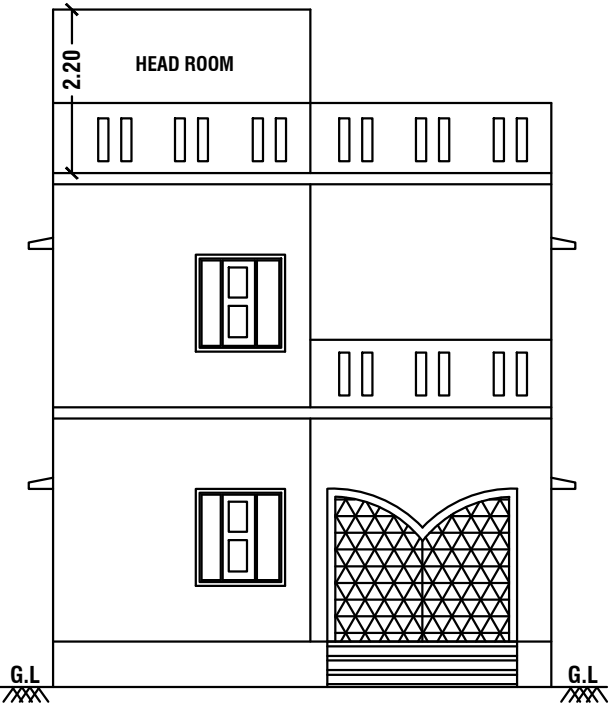

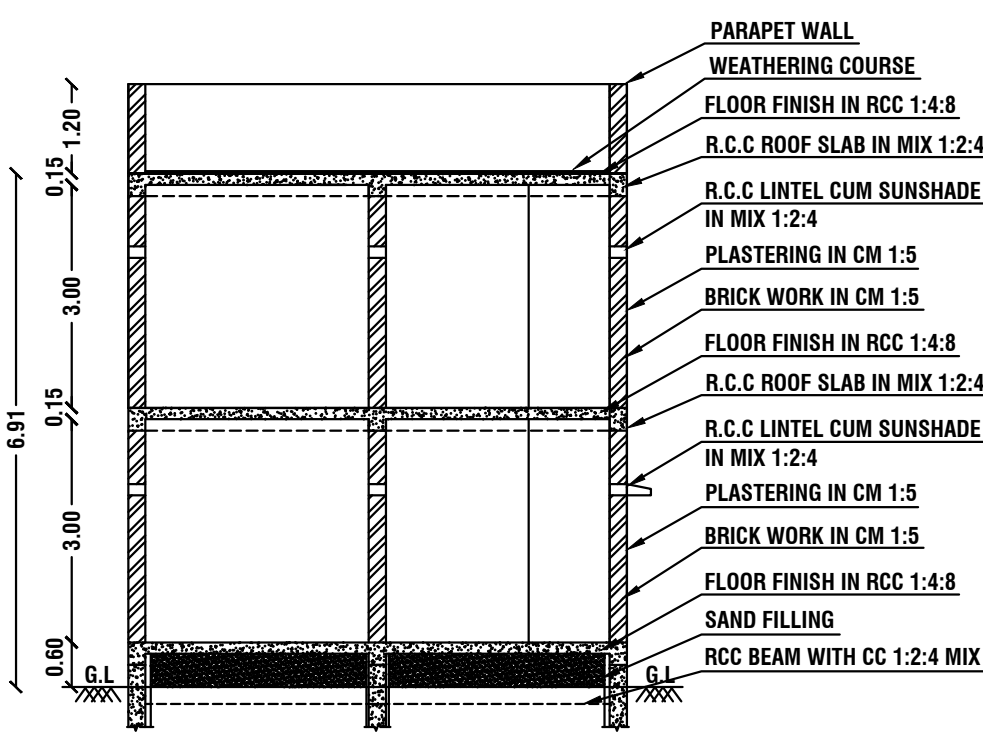

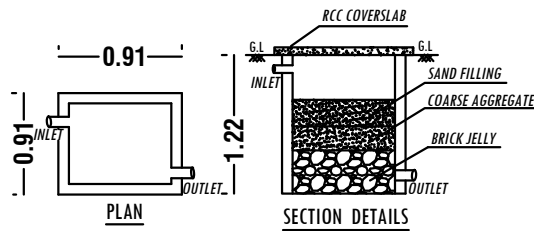

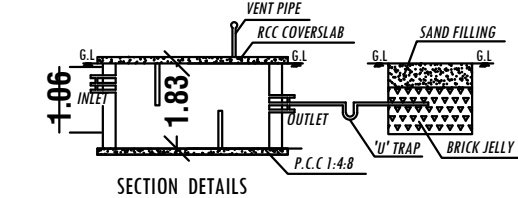

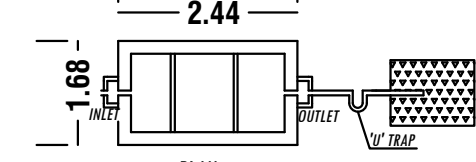

RAINWATER HARVESTING SYSTEM

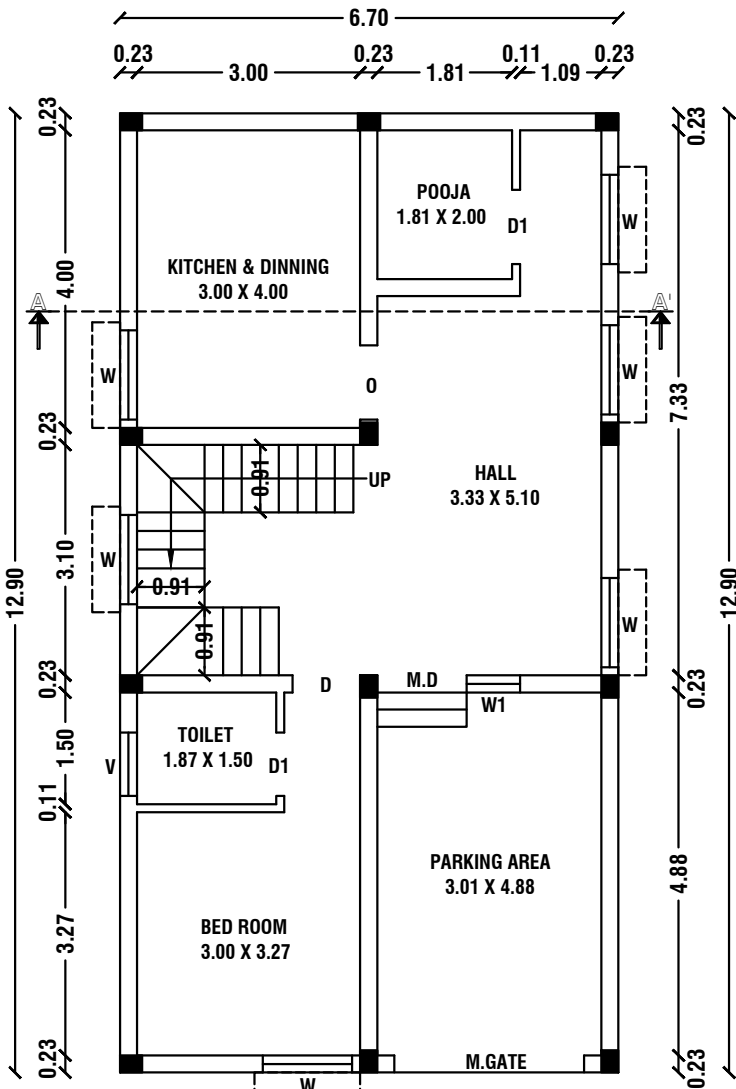


SEPTIC TANK AND DISPERSION TRENCH DETAILS

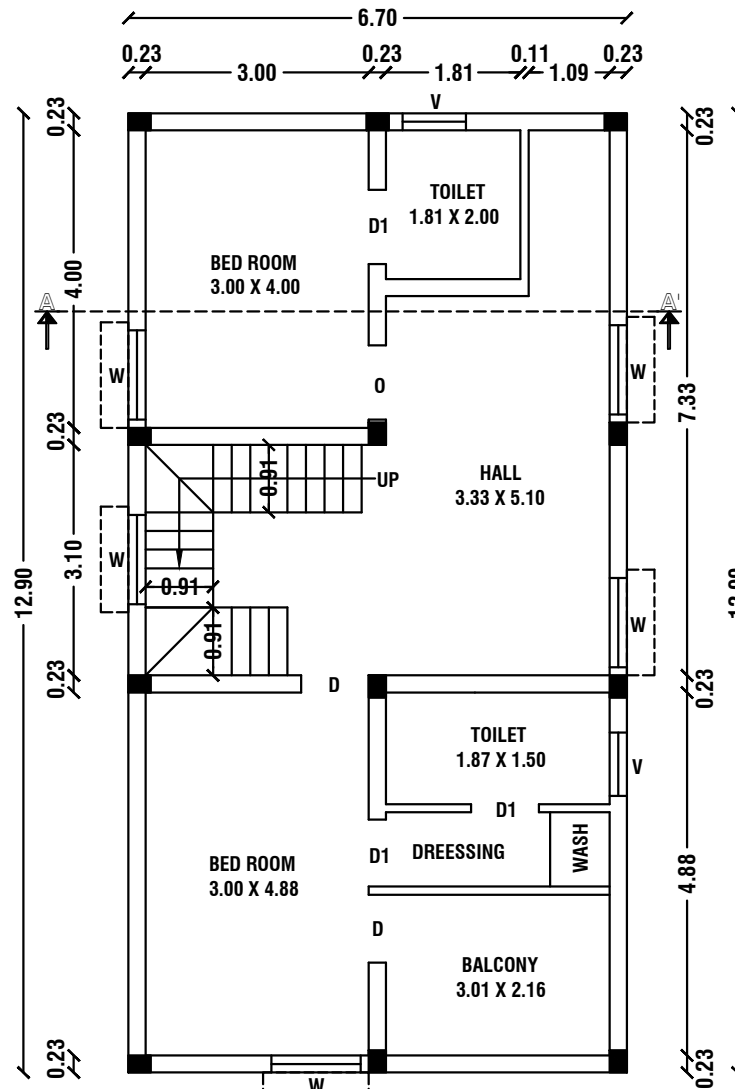

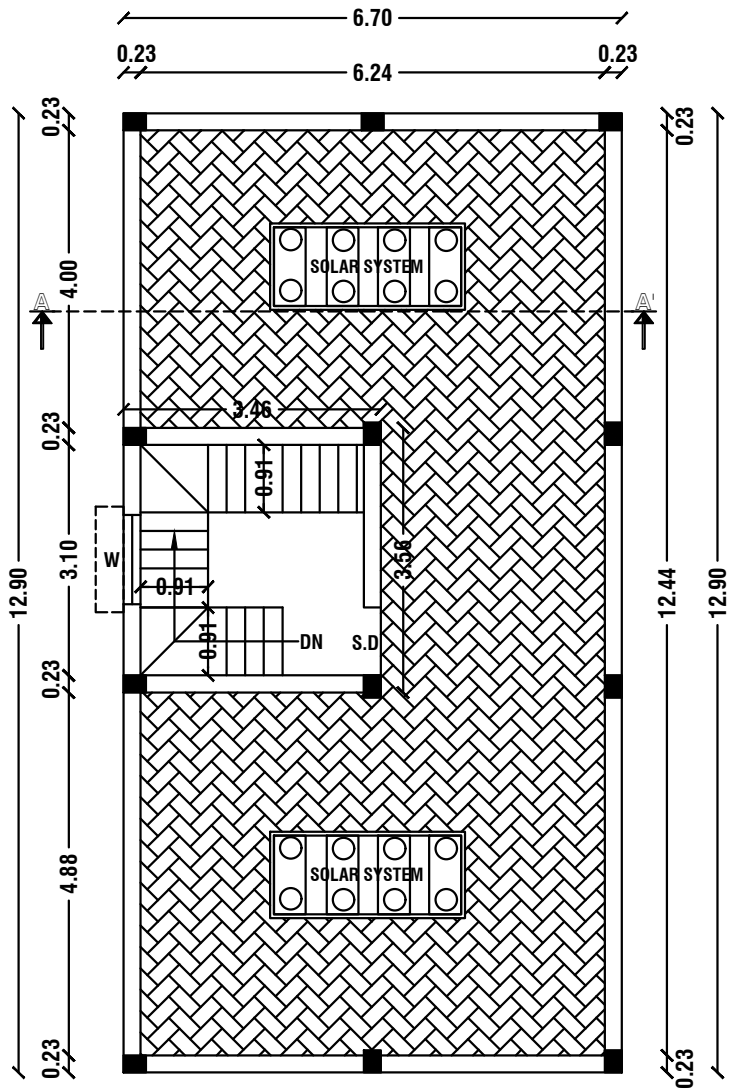

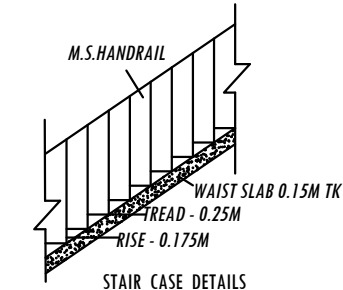
GROUND FLOOR PLAN



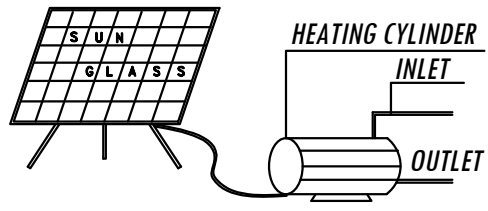
FIRST FLOOR PLAN



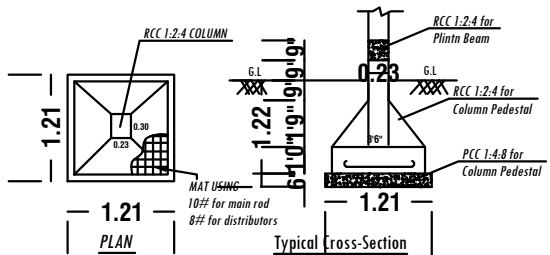
OPEN TERRACE FLOOR PLAN



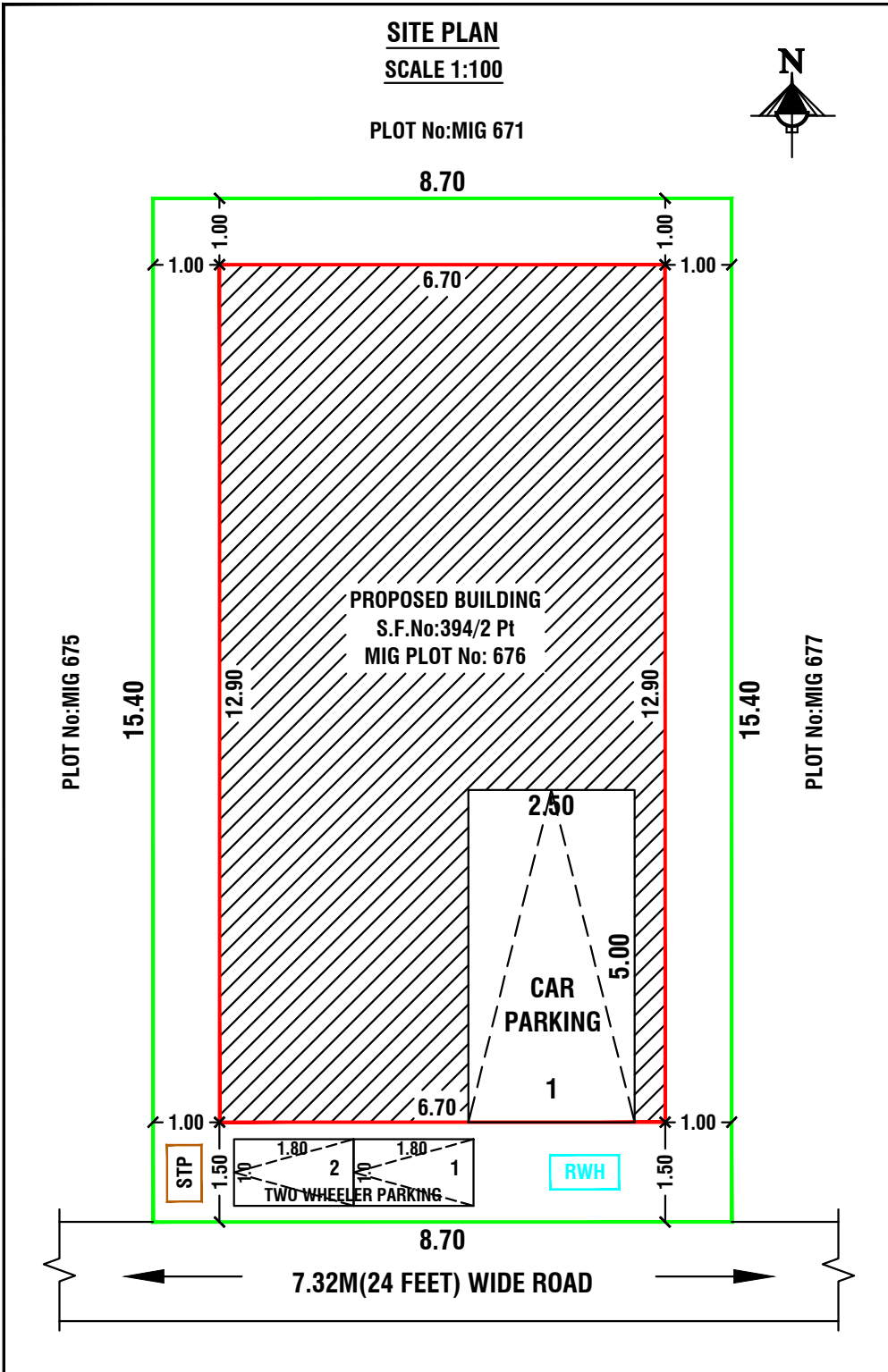

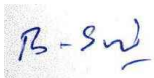
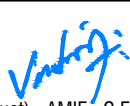
