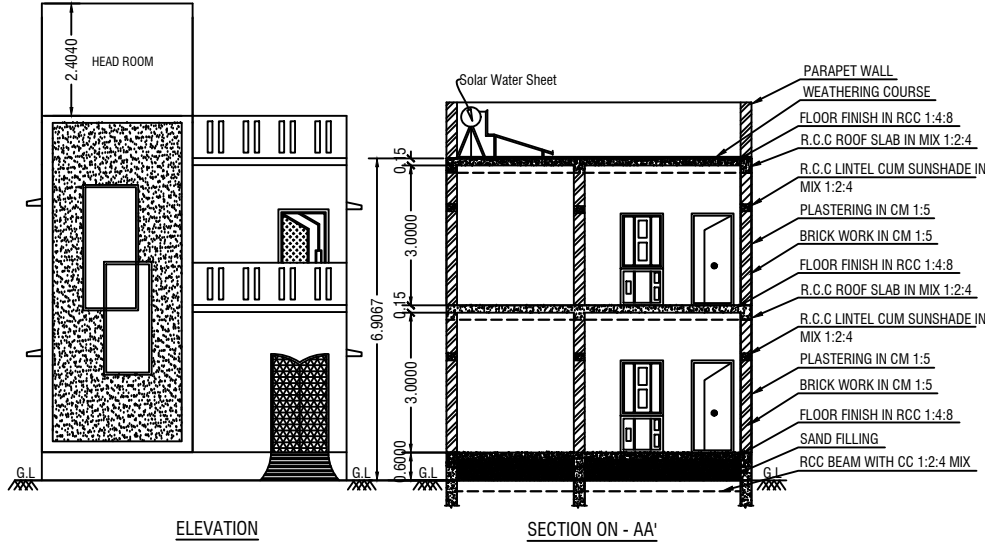

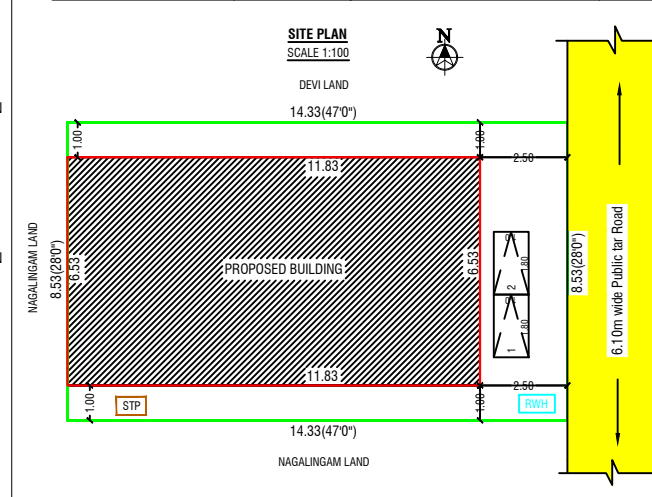

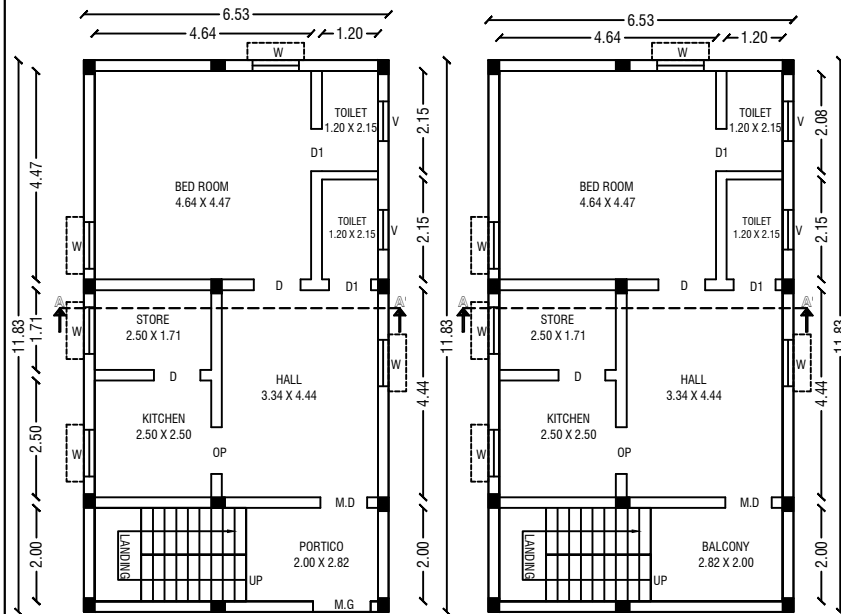

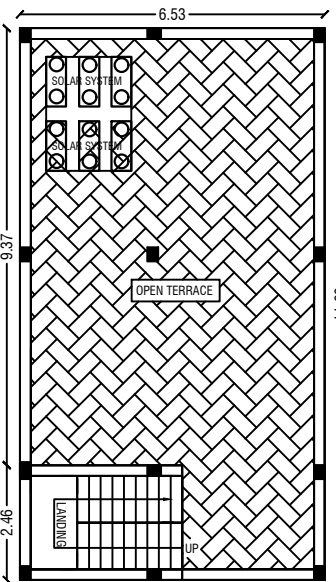

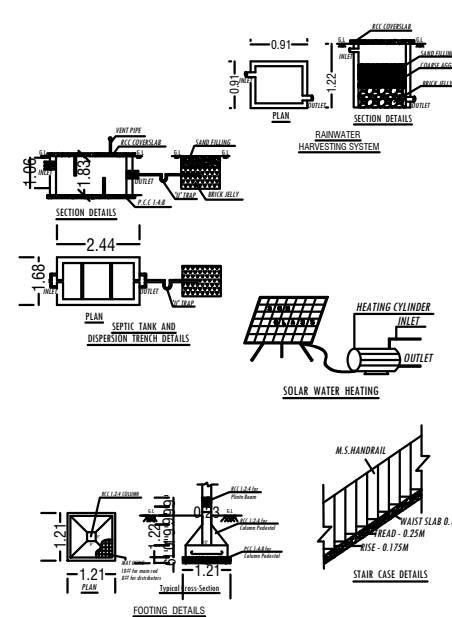


GROUND FLOOR PLAN
