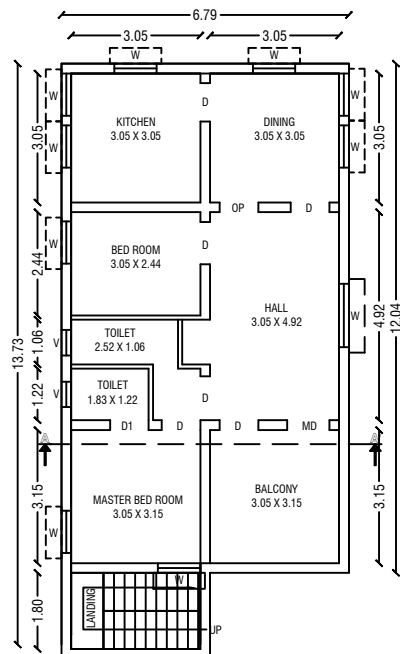

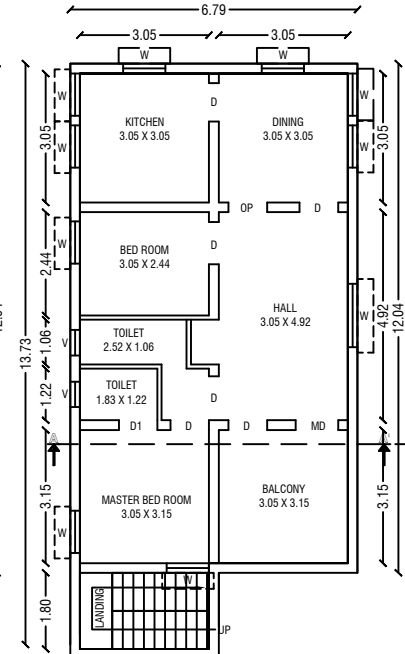

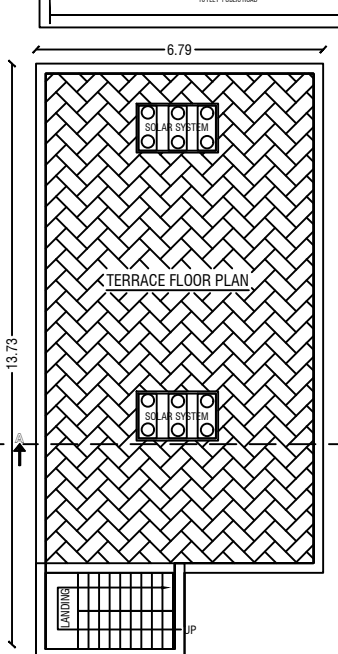
**GROUND FLOOR PLAN
