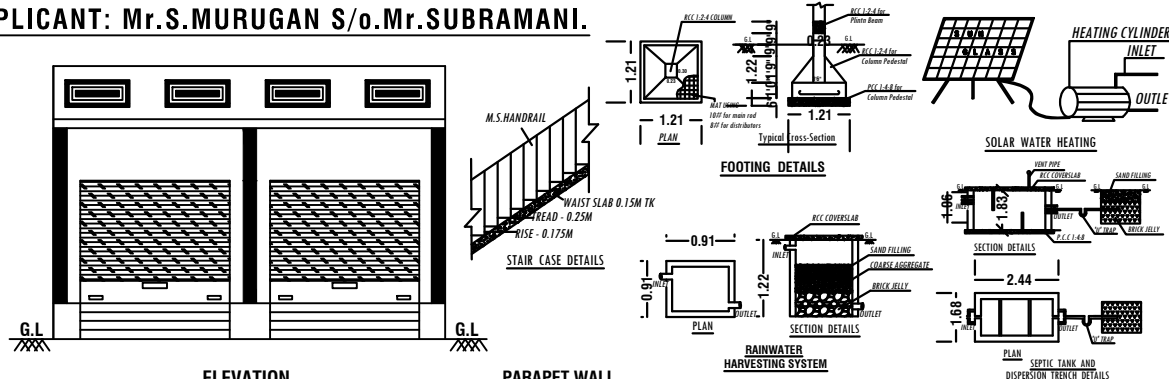

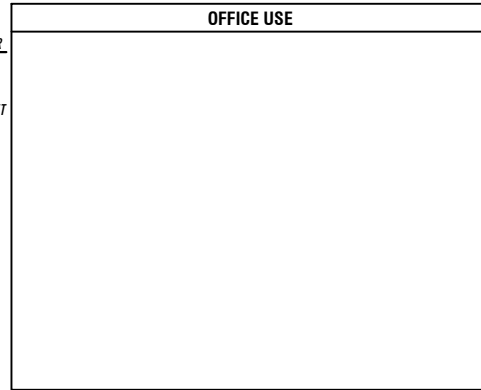

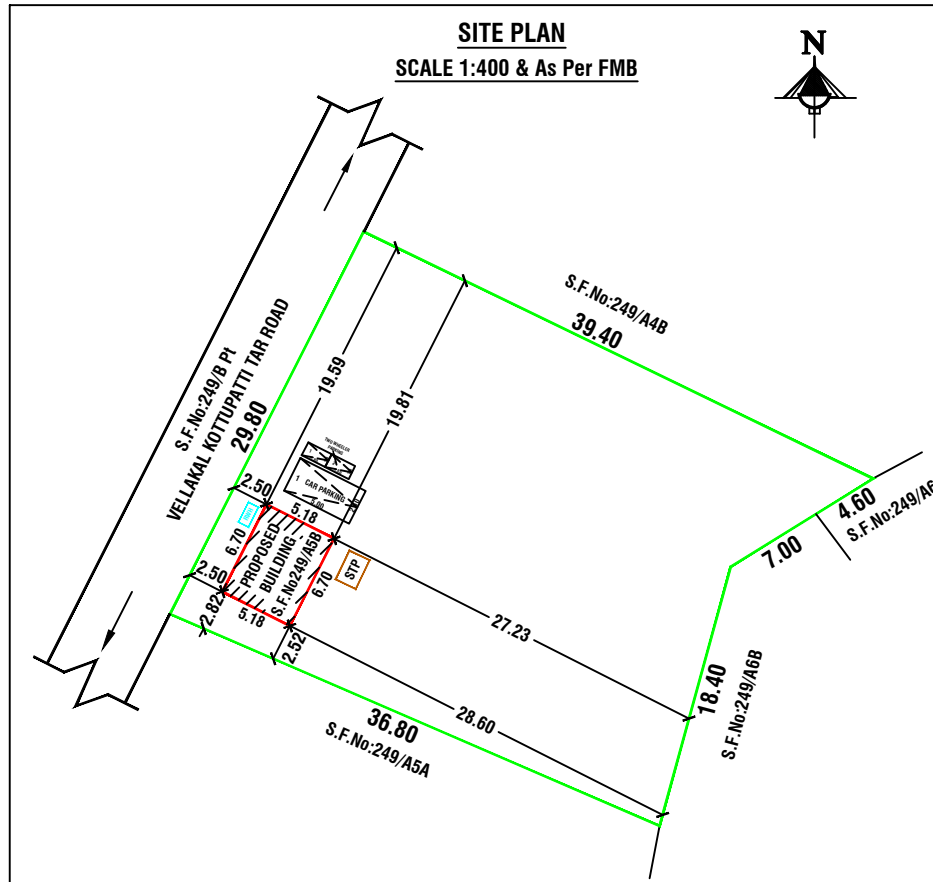


GROUND FLOOR PLAN
