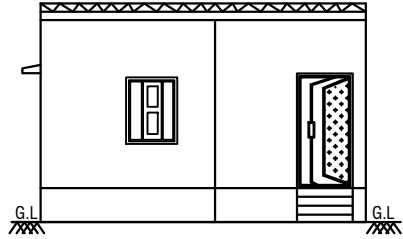

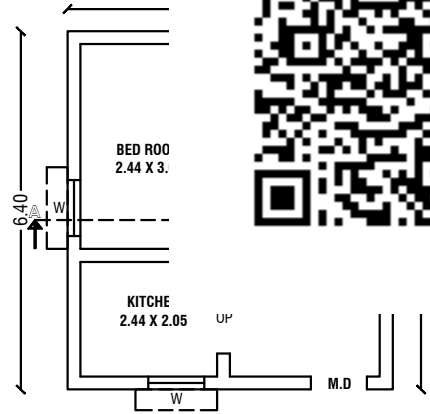

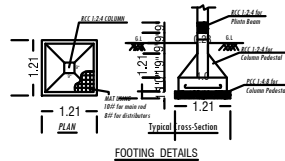

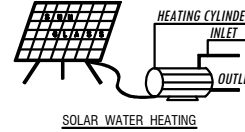
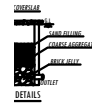
**ELEVATION**

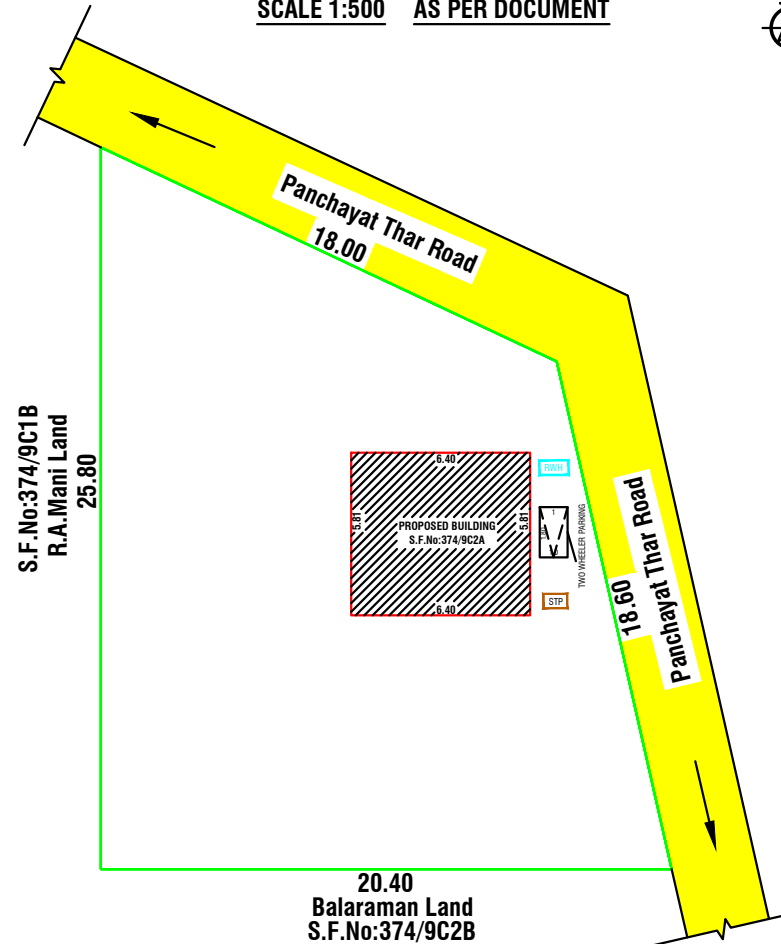
