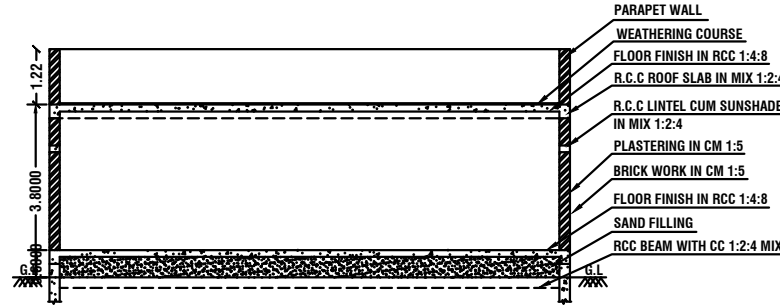

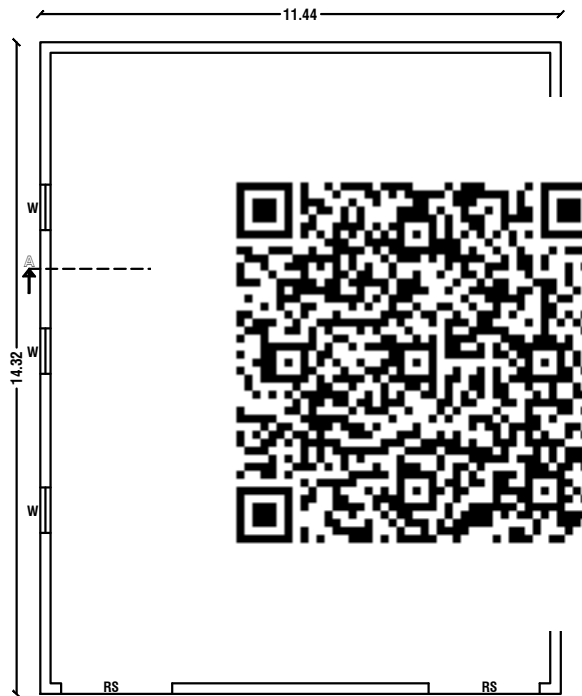

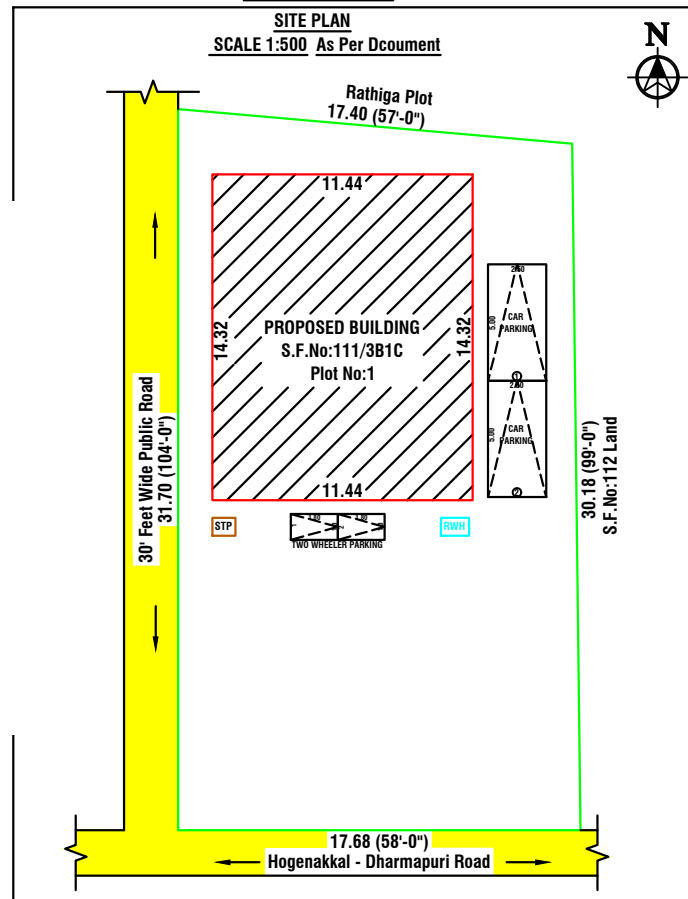

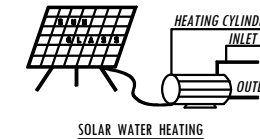
SECTION ON - AA'



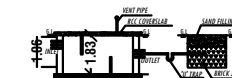
GROUND FLOOR PLAN



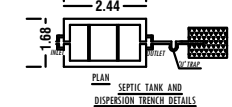
**SITE PLAN

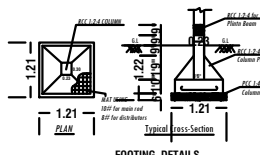

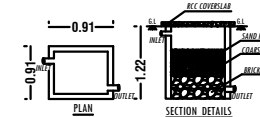
