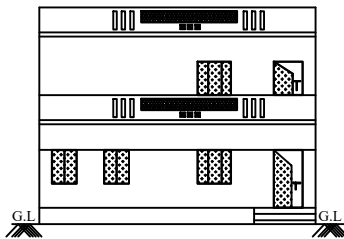

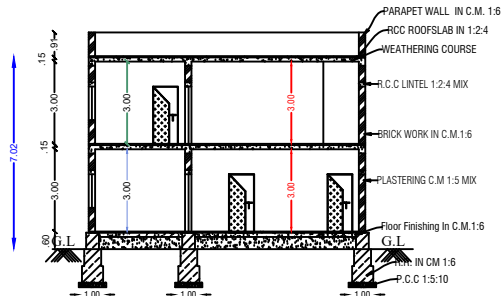

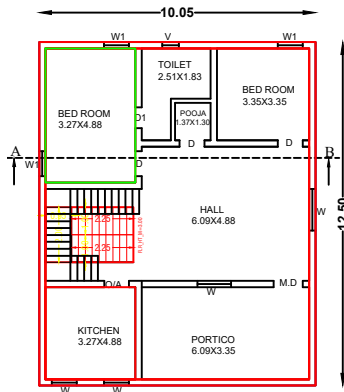

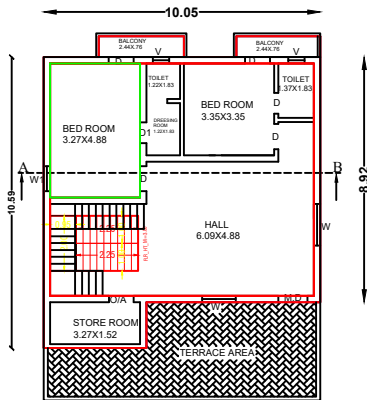
Front Elevation



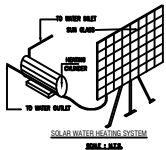
Section ON-'AB'



Ground Floor Plan



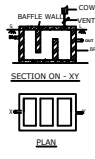
First Floor Plan



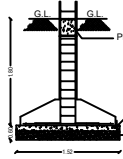
SOLAR WATER HEATING SYSTEM



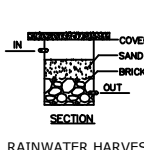
