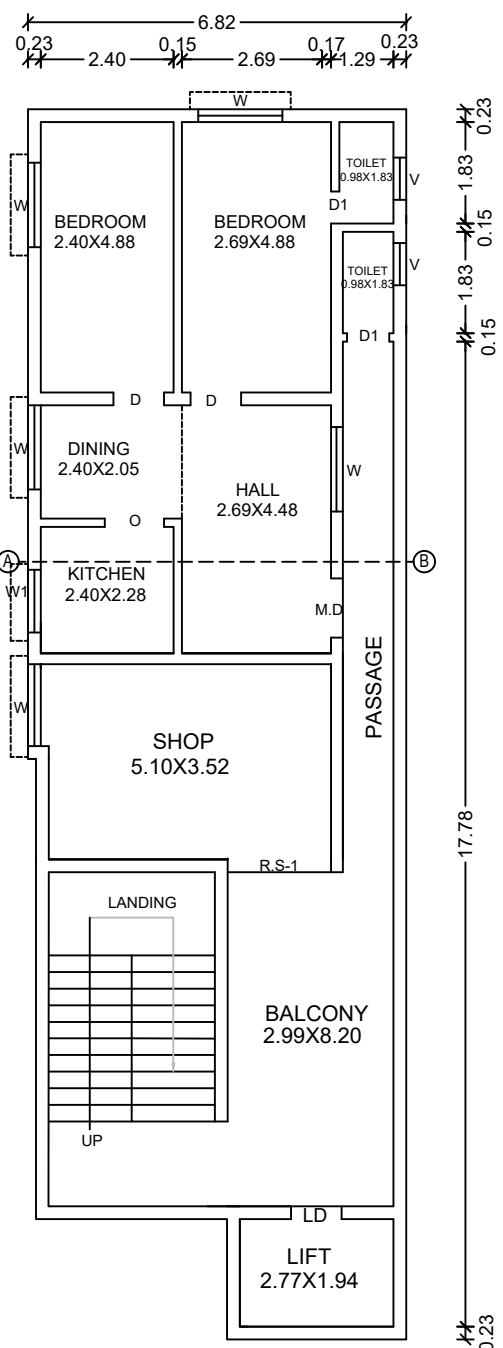

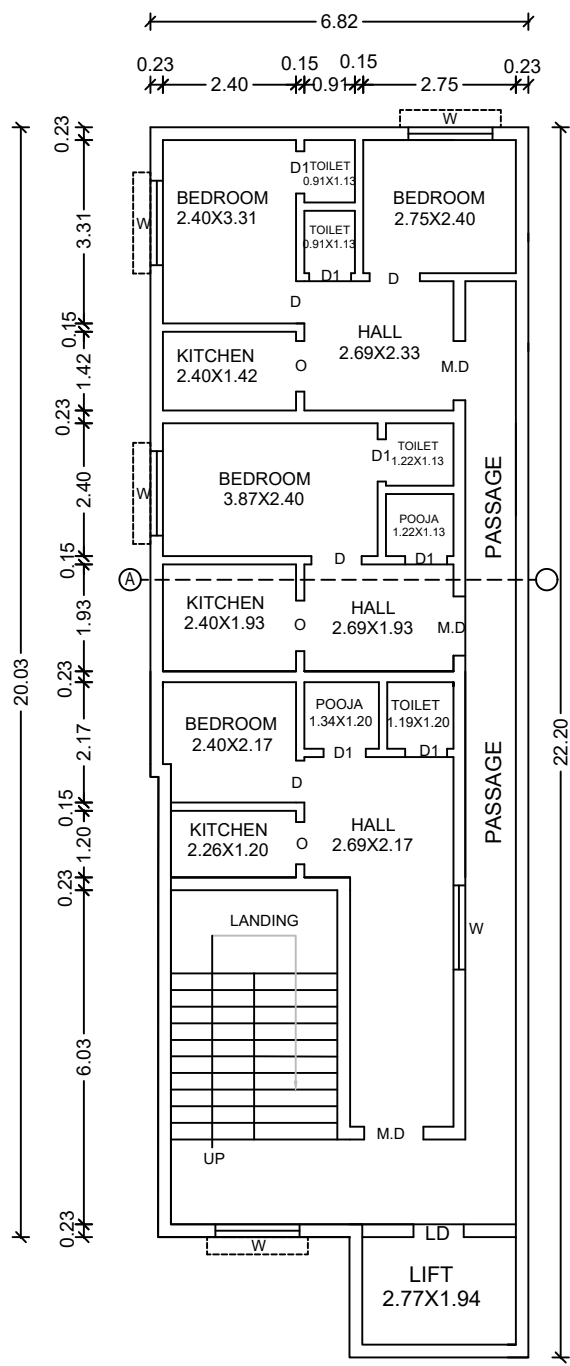
TERRACE FLOOR PLAN



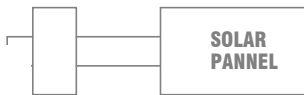
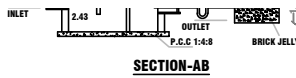
EXISTING APPROVED GROUND FLOOR PLAN



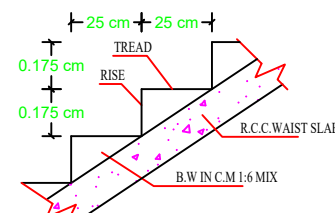
PROPOSED FIRST FLOOR PLAN



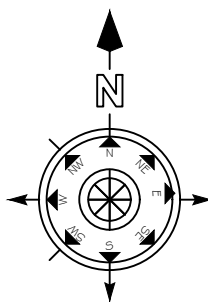
PROPOSED SECOND FLOOR PLAN

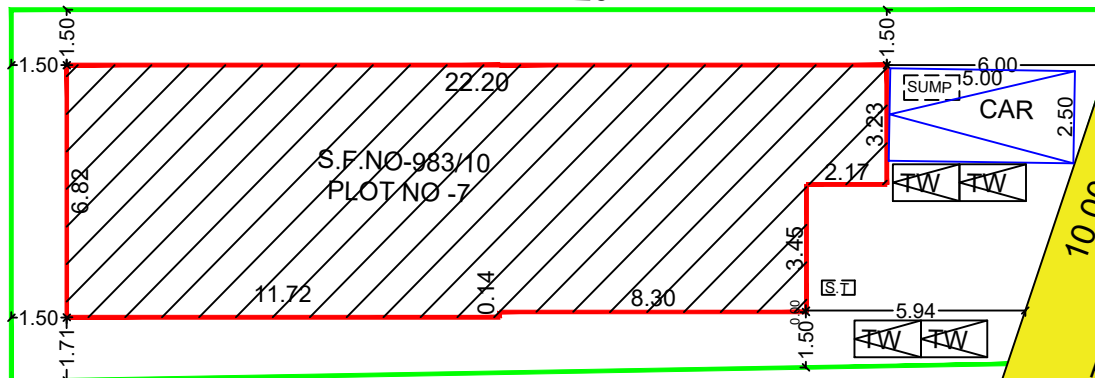

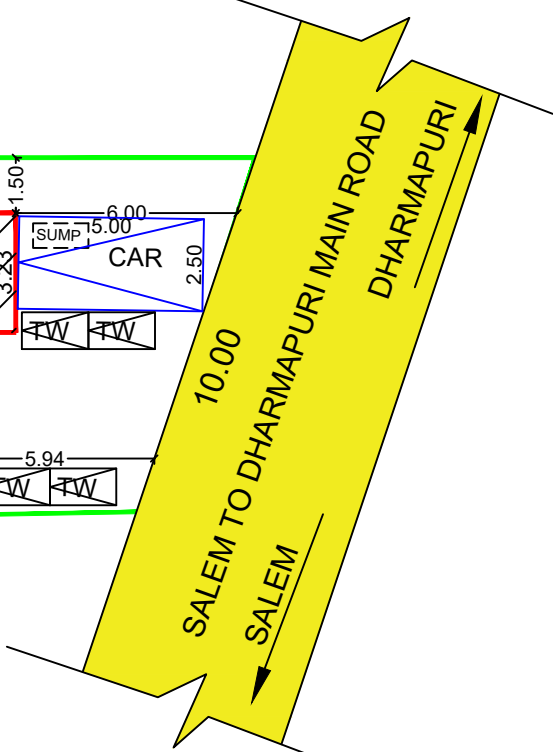
