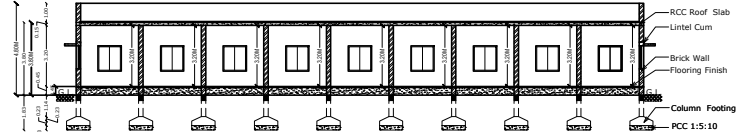

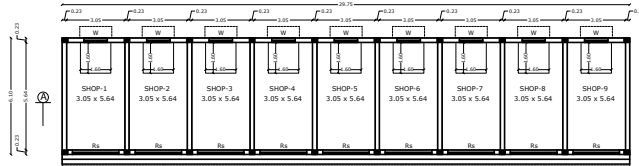
PLAN SHOWING THE PROPOSED GROUND FLOOR COMMERCIAL BUILDING IN PATTa No : 460,

PAPPIREDDIPATTI TALUK AND DHARMAPURI DISTRICT.



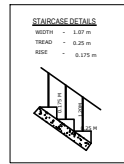

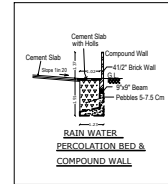

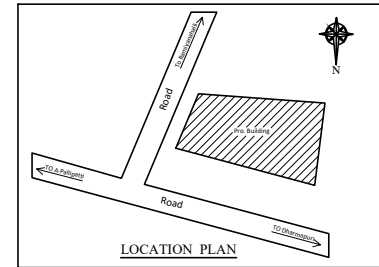
GROUND FLOOR PLAN



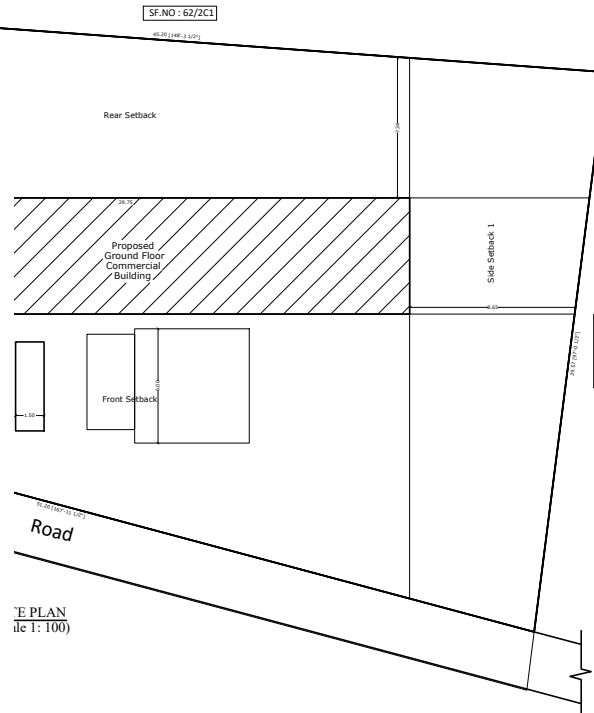
STAIRCASE DETAILS



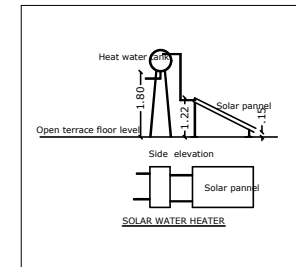
RAIN WATER PERCOLATION BED & COMPOUND WALL



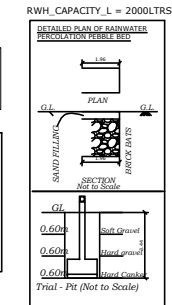
LOCATION PLAN



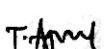
