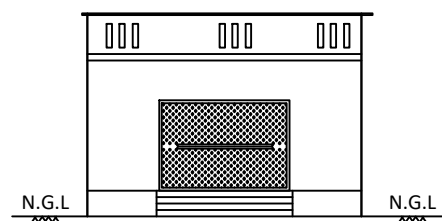
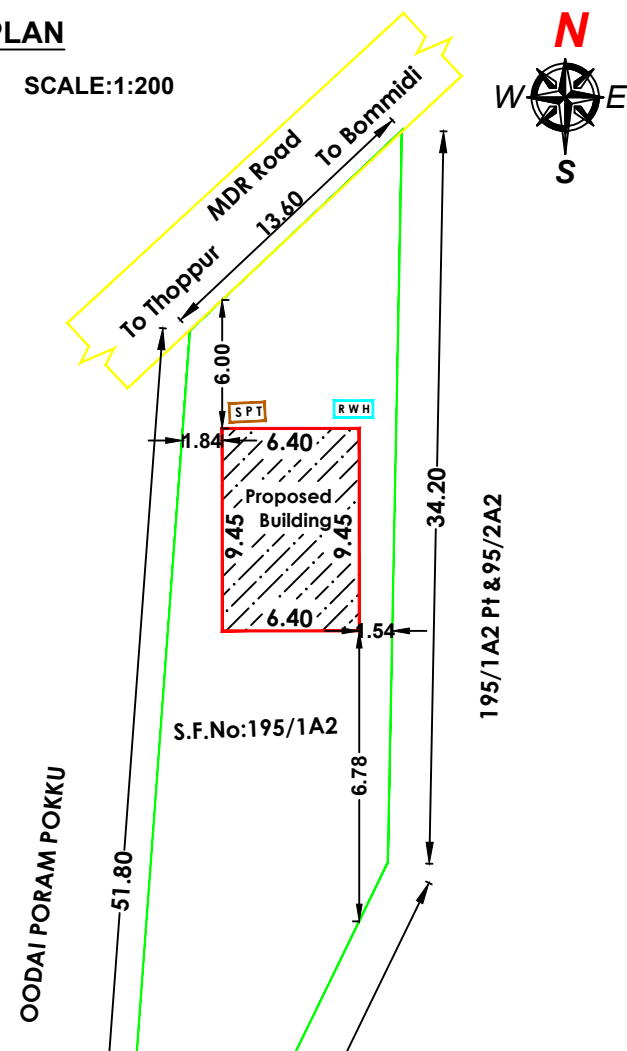

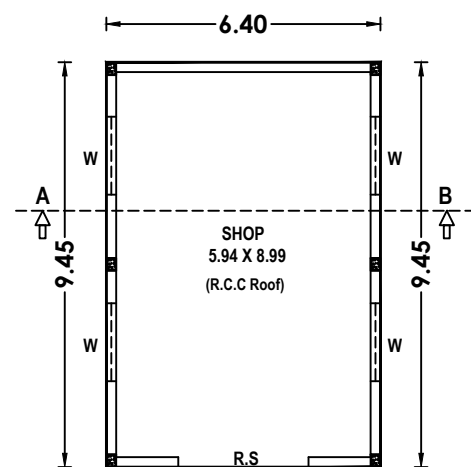

**SITE PLAN**

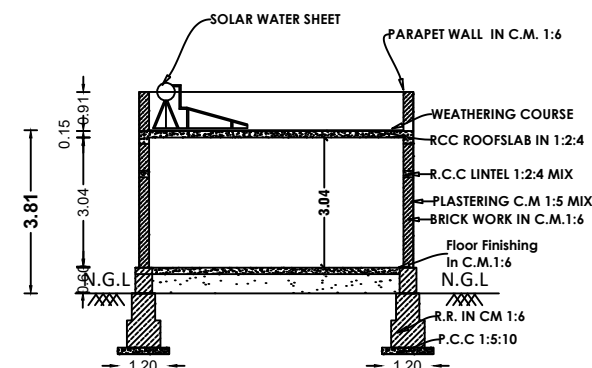

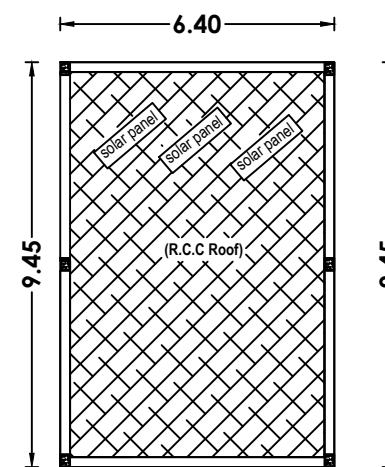
**Elevation Plan**



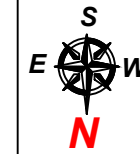
**Ground Floor Commercial Plan**

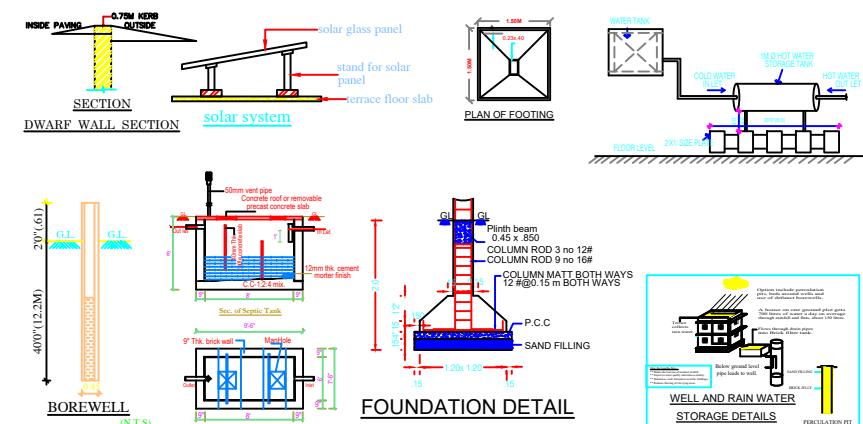
