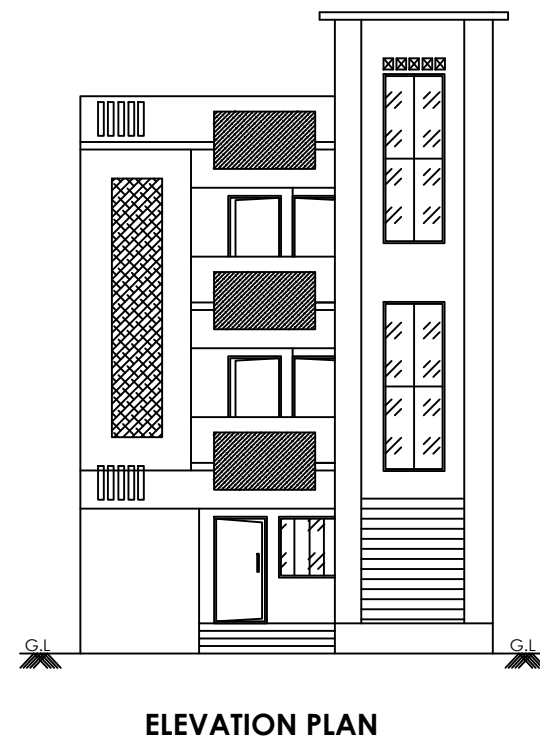

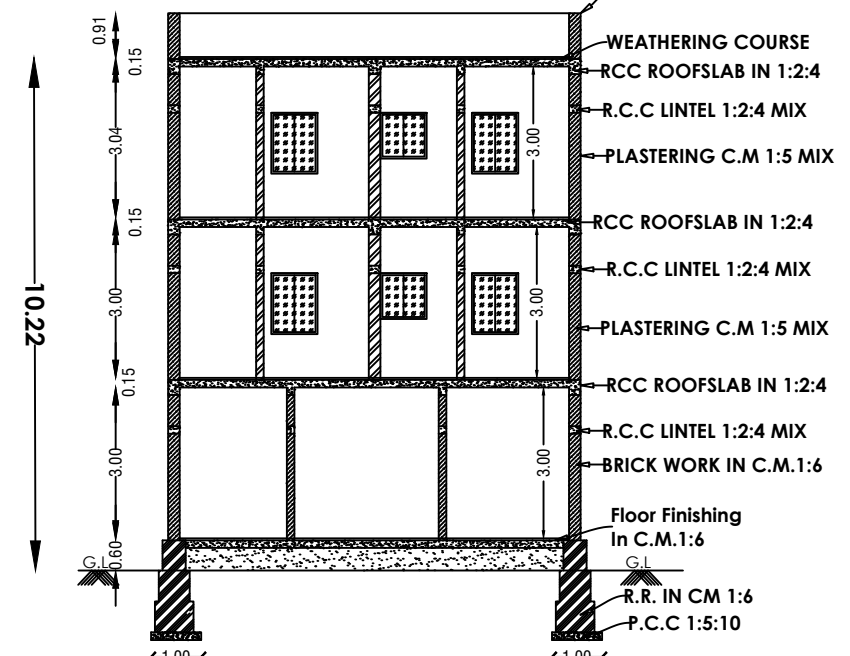

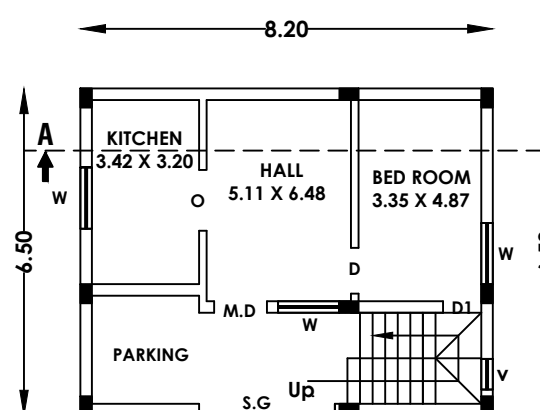

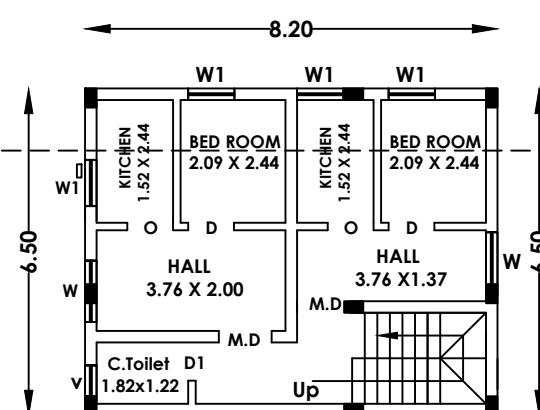
FIRST FLOOR PLAN
