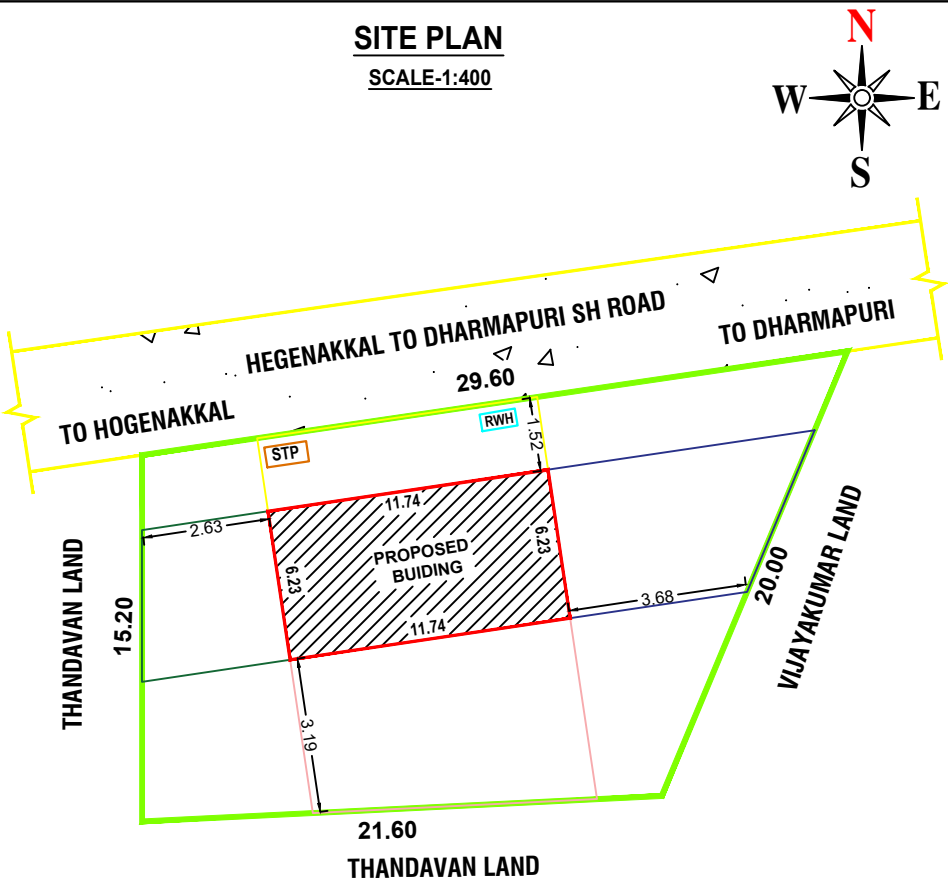

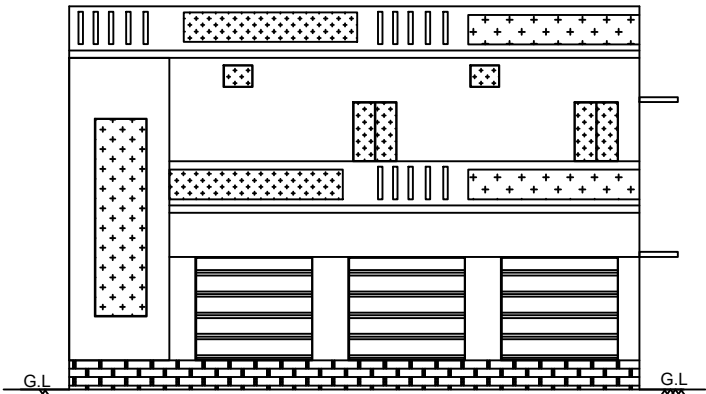

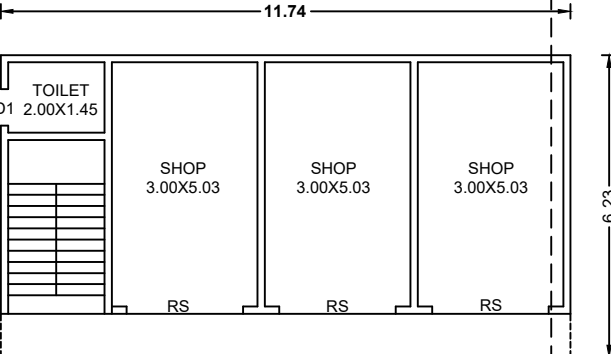
FRONT ELEVATION



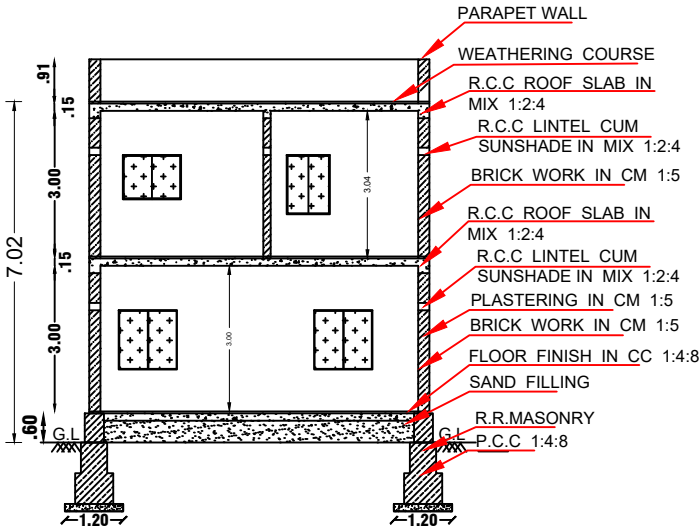
FIRST FLOOR PLAN



GROUND FLOOR PLAN

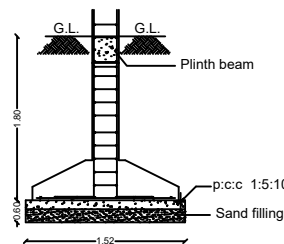

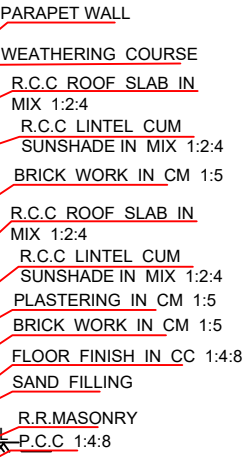

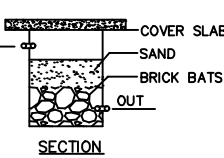

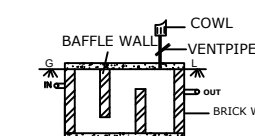
