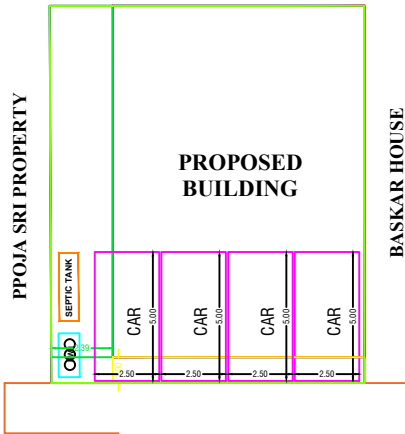

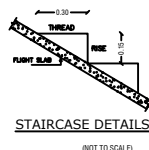

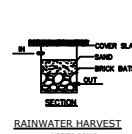

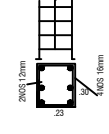
STAIRCASE DETAILS

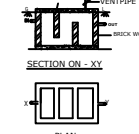

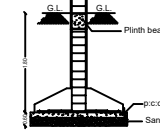
