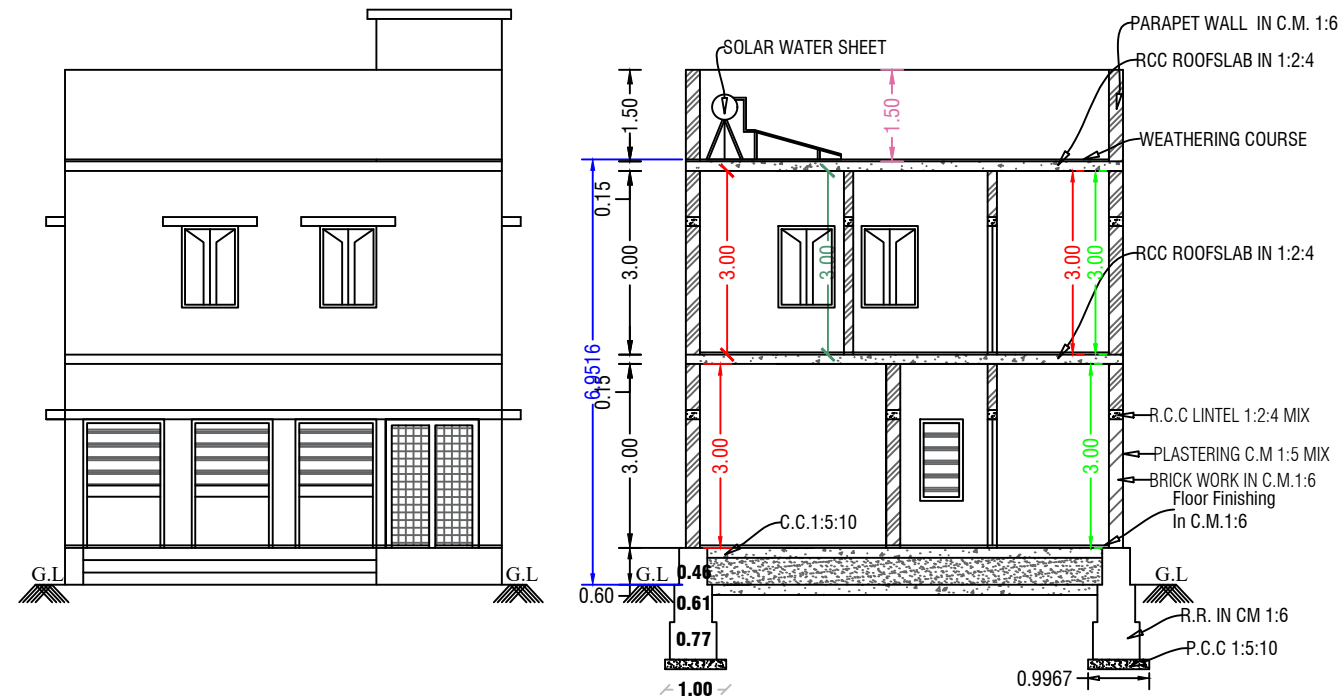

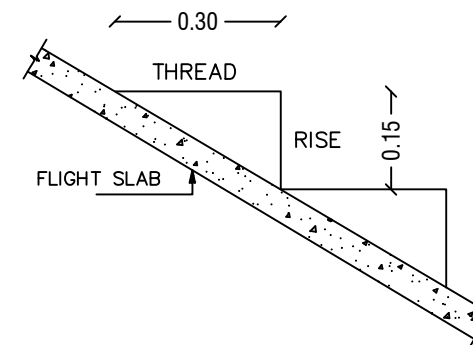

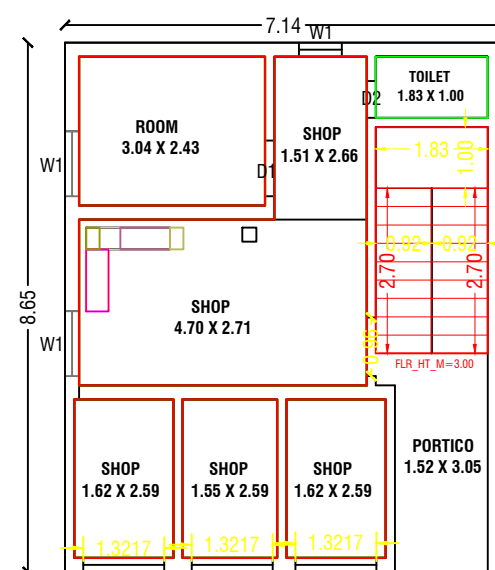

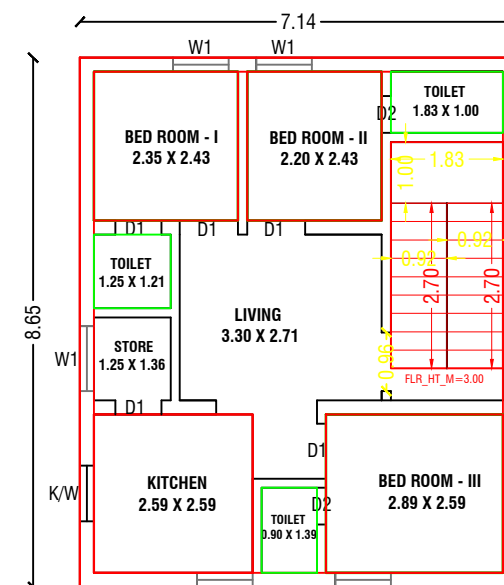

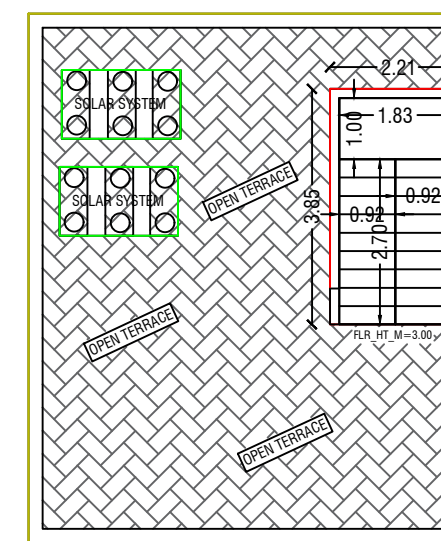

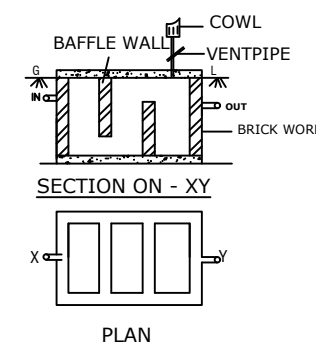
Ground Floor Plan



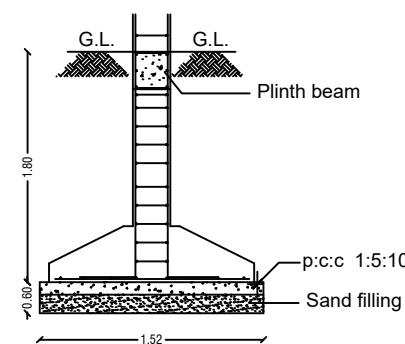
First Floor Plan



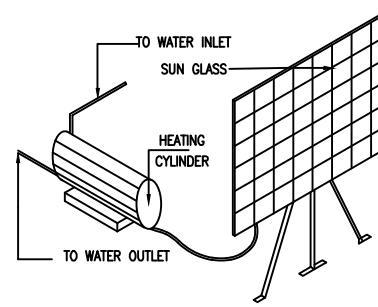
Terrace Floor Plan



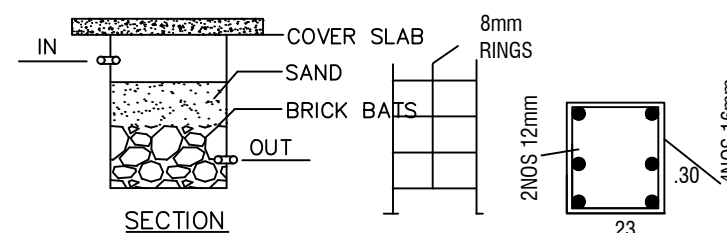
SEPTICTANK DETAILS
