ORDER:-

The online application was processed as per the prevailing rules and after perusing the records and after conducting site inspection, this

proposal has been forwarded to The Director of Town and Country Planning, Chennai to get Technical Concurrence. After the perusal of the

Director of Town and Country Planning, Chennai the applicant was directed to handover the portion of land earmarked for roads, public

purposes meant for local body and TANGEDCO vide reference 4th cited above.

1. On receipt of gift deeds soft copy vide reference 5th cited above, Technical Concurrence was issued for the Layout in Kancheepuram

District, Sriperumbudur Taluk / Town Panchayat/ Village, S.F.Nos. 1336/1, 2, 3A, 3B – Site Extent – 4.24 Acres (17158.67 sq.m) and numbered as

LP/DTCP No. 19/2025 by the Director of Town and Country Planning, Chennai as per the letter 1st cited, under section 47 (A) of Town and

Country Planning Act 1971. After obtaining the Technical Concurrence from The Director of Town and Country Planning, necessary fees are

demand to the applicant vide reference 17th cited as per GO'S and circular cited in reference 6 to 13 and on receipt of payment of charges

such as Centage, Scrutiny fees, Display board Deposit, Armed Forces Flag Day Fund etc vide reference 18th cited above, the Proposal has been

forwarded to the local body for further action subject to the following conditions:

2. The local authority shall accord permission duly following the rules /regulations/Orders issued from time to time under the respective

Acts. The approved Layout plan is enclosed herewith for taking further action in the regard. The applicant should submit the original Gift deed

of 5th cited above to the concerned local body.

3. After issuing the final approval duly following the procedure, the local body is requested to send a copy of final approval to this office.

4. Also, the local body is requested to send a copy of approved layout, to the registration department and to the department of survey and

land records for appropriate action/information

5. The sub-ordinate office is directed to send the letter of acknowledgement towards the receipt of layout drawings along with conditions.

6. If the layout is located in an area other than planning area, the local authority shall also collect the Scrutiny fee Rs-1000 /- per plot and

3% of market value of land as land use conversion charges before issuing the final approval as envisaged in Government Order under the

reference 7th cited above. The payment of charges shall be made under the following head of account.

Head of Account:

"0217 Urban Development - 60 other Urban

Development Schemes - 800 other Receipts - AS

Receipts under Land Use Conversion Charges-27"

Non Taxation fees - 09 Collections

(DPC: 0217-60-800-AS 22709)".

SPECIAL CONDITIONS:

1. With reference to the 8th, 9th and 11th cited Government orders, "The Owners / developers shall be allowed either to carry out infrastructure development works as per the standards specified by the local body concerned or to pay the estimate cost to the local body.

Concerned local body shall prescribe the standards for the provisions of basic infrastructure like roads, drains, water supply etc. for the layout,

as per existing rules. Before taking over the infrastructure developed by the owners/developers, the local bodies shall ensure the quality of the

works done by the owners / developers. Reasonable period to be prescribed for up keep/maintenance of the roads and drains by the

owners/developers. Wherever layouts develop at a slow pace, the maintenance period shall be extended till 60% of the plots developed in the layout or 5 years whichever is later".

2. (EWS) Plots reserved for Economically Weaker Section should not be amalgamated or rearranged. But in rural areas, if the EWS plots are not sold after more than 3 years, after the plot approval, as per G.O.16, Municipal Administration and Water Supply Department, Dated:

31.01.2020, should be applied in appropriate permission for amalgamation of EWS plots.

3. With reference to the 12th cited and 13th cited letter, the concern local body must issue the final approval After transfer of earmarked

road, park, Public purpose of local body areas S.F. No sub-division in favor concern local body.

4. The Tamil Nadu Government in G.O.Ms.No.112, Housing and Urban Development Department, dated 22.06.2017 have approved the Tamil

Nadu Real Estate (Regulation & Development) Act 2016, The promoter has to advertise, Market, book sell or offer for sale or invite persons to

purchase in any manner any plot, apartment or building, as the case may be, in any Real Estate Project or part of it only after registering the

Real Estate Project with the Real Estate Authority. The applicant has requested to follow the protocols as per instruction given by TNRERA

5. The local authority shall accord permission duly following the rules / regulations/ Orders issued from time to time under the respective acts.

6. The Local authority shall accord Final approval after collecting requisite fees / charges as applicable and the copy of the approval issued shall be forwarded to this office for record.

The acknowledgement of the receipt of this proceedings and drawing shall be forwarded to this office through mail.

7. The Directorate of Town and Country Planning has not legally certified the title to the ownership by granting technical clearance and

planning permission. Only the applicant's entitlement to development is verified in the documents submitted with the applicant's application

(lease deed, sale deed, gift deed, etc) Any person wishing to purchase the property must individually assert ownership of the property to the

applicant. Also, if anyone else dispute arises individual rights over it, they can settle it before the appropriate competent court. The Directorate

of Town and Country Planning is not the right organization to decide this.

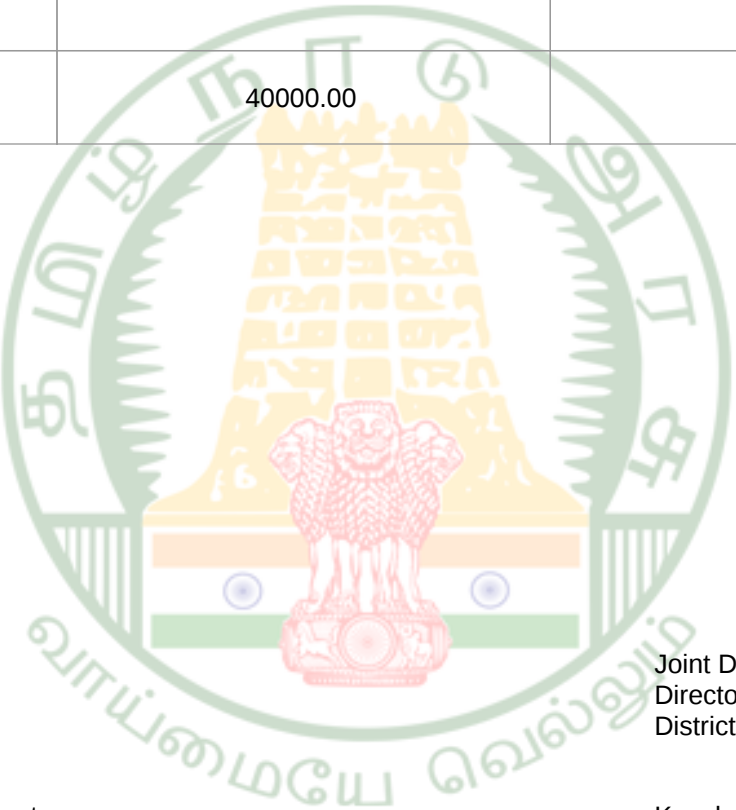
