With reference to the 1st cited letter, applicant has requested for the approval of residential Site approval in Dindigul District – Nilakottai Taluk – Sevugampatti Town Panchayat, Sevugampatti Village - S.F.No. 755A/1A2 - Extent of 0.4821 Acres (1951.00Sq.m).

In continuation with reference 2nd cited letter, OSR charges called for Residential Site approval has been issued by the Deputy Director, District Town and Country Planning Office, Dindigul District. Further the applicants Mr.M.Kalidass & 2others has paid OSR charge on 18.03.2026 and Centage charge 20.03.2026. Hence, Technical Clearance has been given for the residential Site approval with below mentioned conditions.

1. As per the condition, Technical Clearance has been given for the residential Site approval and the approved number issued as SWP/DTCP/DINDIGUL/SITE APPROVAL NO: 34/2026 in digitally signed Site approval drawing. The Technical Clearance issued Residential Site approval drawing are herewith forwarded to the Local body for further action.
2. The local body shall accord permission/approval duly following the rules/regulations issued from time to time under the respective Act provisions and also after collecting requisite fees/charges as applicable
3. After final approval in the local body, it is requested to send the approved residential Site approval map to the concerned sub-registrars of registration department and Survey & land records department for information and appropriate action.
4. As per circular cited 12th reference, it is requested to send the proceeding orders and maps to the concerned Thasildhar for updation in Tamil Nilam website
5. The acknowledgement of receipt of proceedings and drawing shall be forwarded to this office through e-mail.

Special Conditions:

1. (a) With reference to the 8th cited and 10th cited Government orders, if the located site lies in the Municipal/ Corporation areas: After collecting the necessary fees including the charges for providing amenities like roads, storm water drains and street lights from the applicants, the final Site approval sketch, permit of planning authority along with approval of Local body shall be issued to the applicant(s) directly.

b) Other than Municipal/ Corporation areas: Local body shall collect the necessary fees and issue the final Site approval sketch, permit of planning authority along with the permit of local body to the applicant (s) directly and also after ensuring that the applicant lays tar roads, provide other amenities like storm water drains, water supply facilities by constructing required OHT, providing of necessary street lights etc., as per the standards specified by the local body

2. The Tamil Nadu Government in G.O.Ms.No.112, Housing and Urban Development Department, dated 22.06.2017 have approved the Tamil Nadu Real Estate (Regulation & Development) Act 2016. The promoter has to advertise, Market, book sell or offer for sale or invite persons to purchase in any manner any plot, Apartment or building, as the case may be, in any Real Estate Project or part of it only after registering the Real Estate Project with the Real Estate Authority. The applicant has requested to follow the protocols as per instruction given by TNRERA.

3. As per G.O.79 Housing and Urban Development Department, dated: 04.05.2017, in-case of non-planning area rule 3 it has been requested to collect Rs.1000 as scrutiny fee for each plots. And under rule 9 concerned local body should collect the 3% Market Land Value as Land conversion charges, before issuing the final approval

4. According to the Circular No. 12544/14 / CB dated: 04.07.2014 stating that, The Directorate of Town and Country Planning Department has not legally certified the title to the ownership by granting technical clearance and planning permission. Only the applicant's entitlement to

development is verified in the documents submitted with the applicant's application (lease deed, sale deed, gift deed, etc). If any person wishing to purchase the property must individually assert ownership of the property to the applicant. Also, if anyone else dispute arises individual rights over it, they can settle it before the appropriate competent court. The Directorate of Town and Country Planning Department is not the right organization to decide this.

5. As per TNCDBR-2019 the details of collected fee and charges are attached.

6. Setback should be proposed as per Rule No: 35(a) & (b) of TNCDBR-2019, when building developments are being carried out in the proposed site.

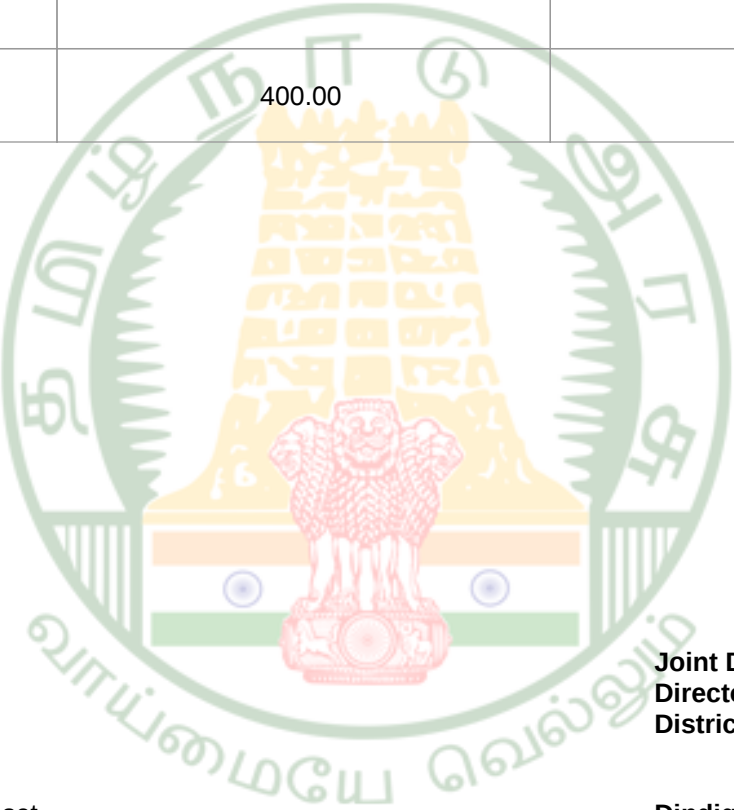
