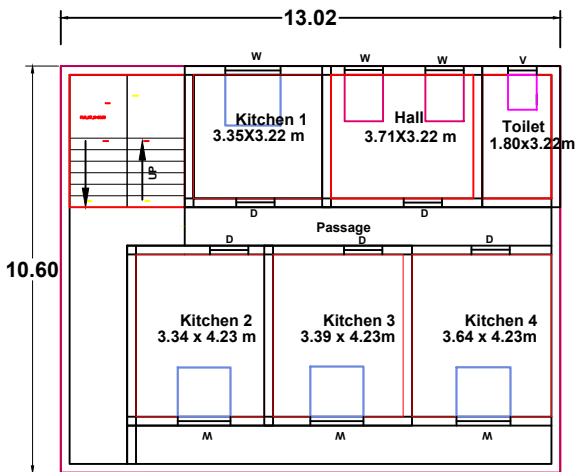

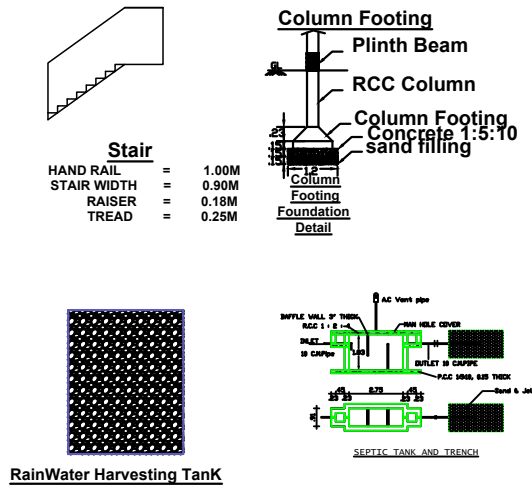


EX GROUND FLOOR PLAN
