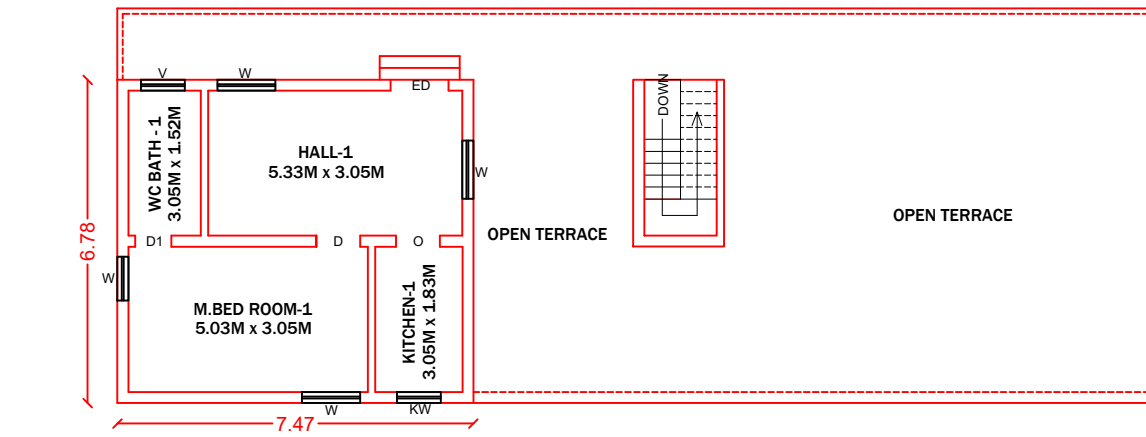

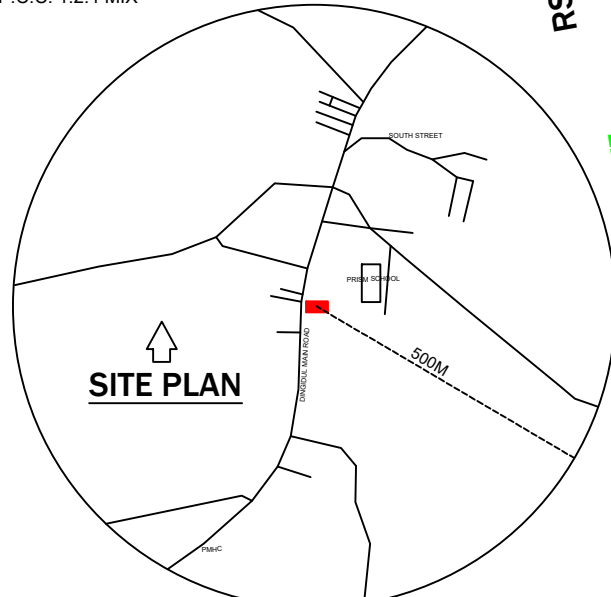

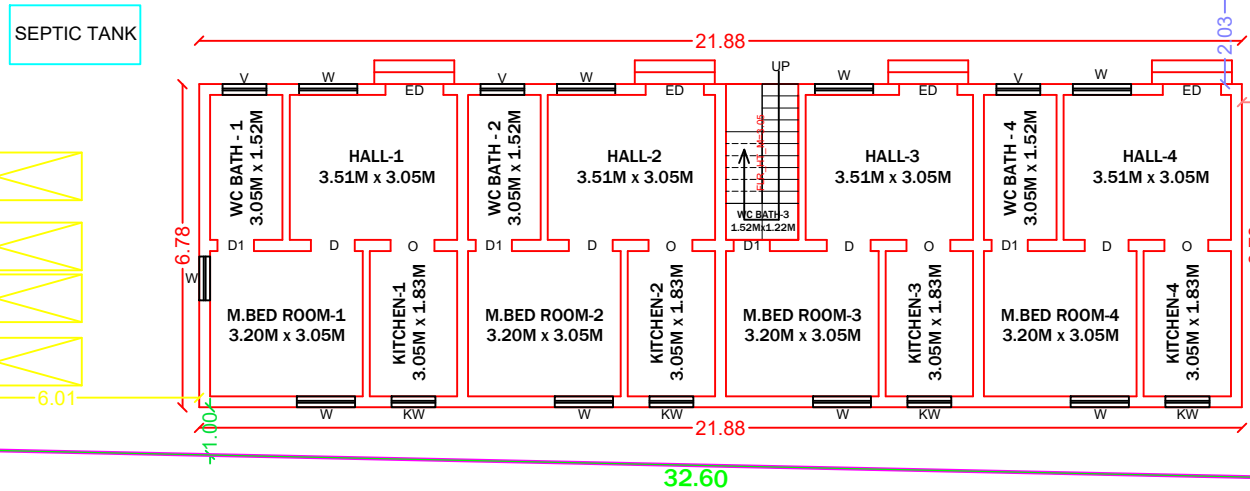
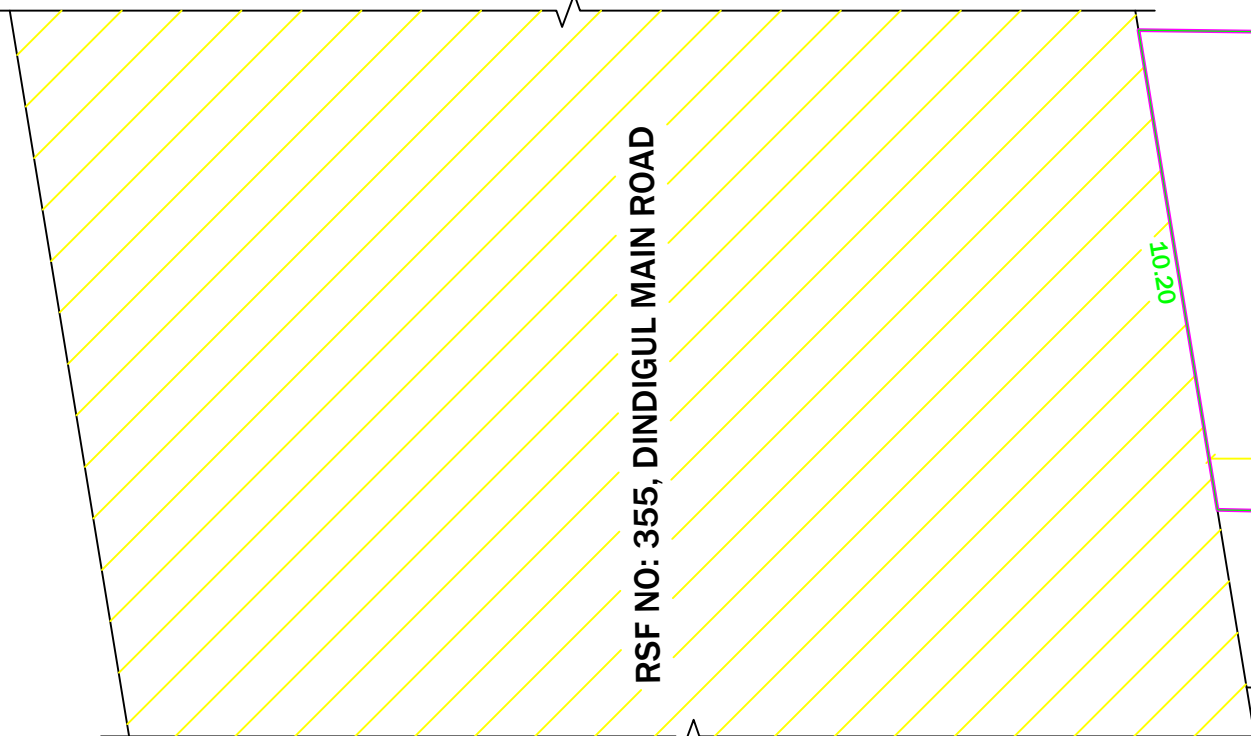


FIRST FLOOR PLAN

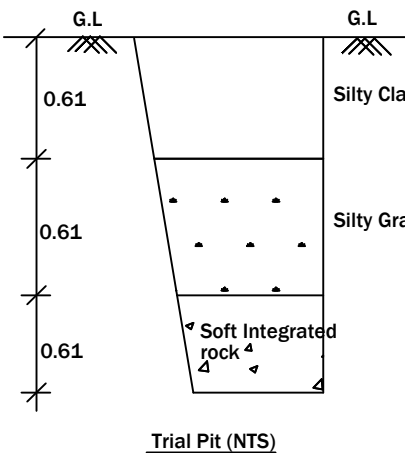
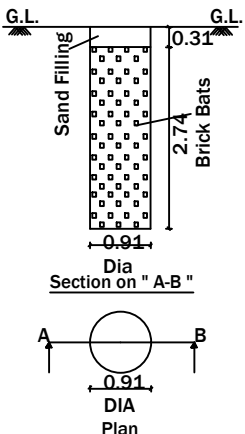

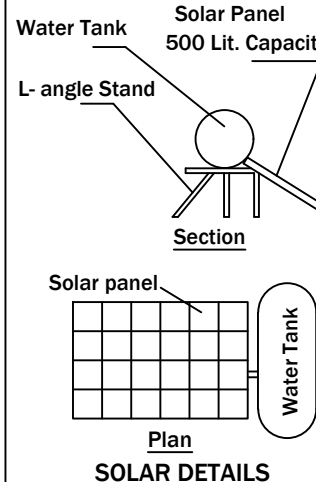

Percolation & Collection Pit



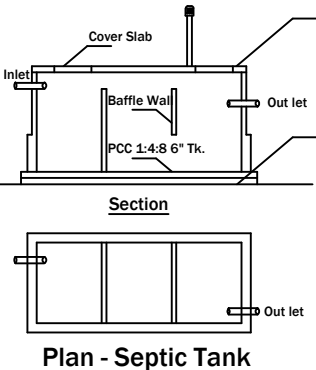

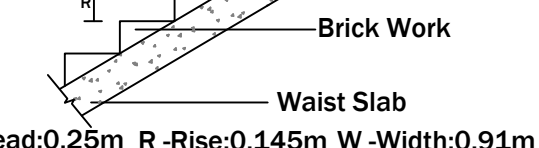


Plan - Septic Tank

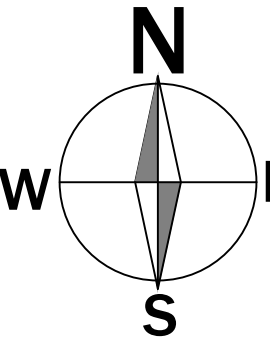
