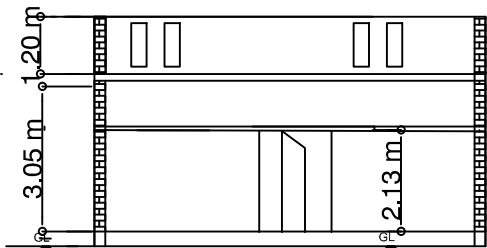

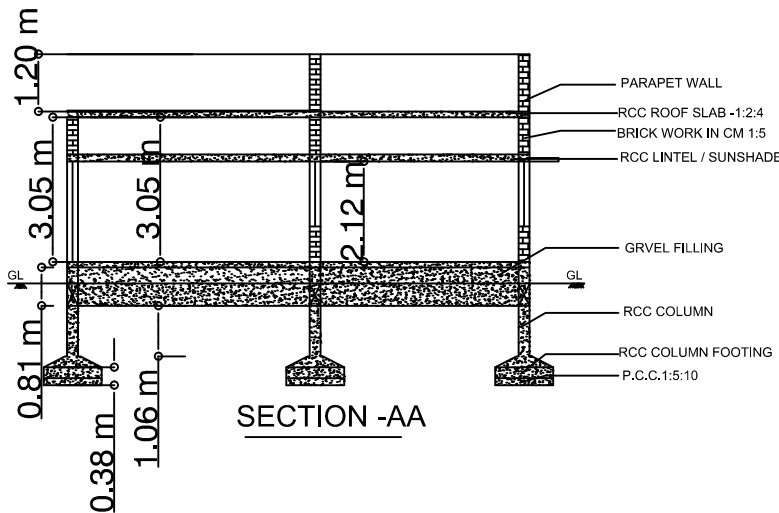

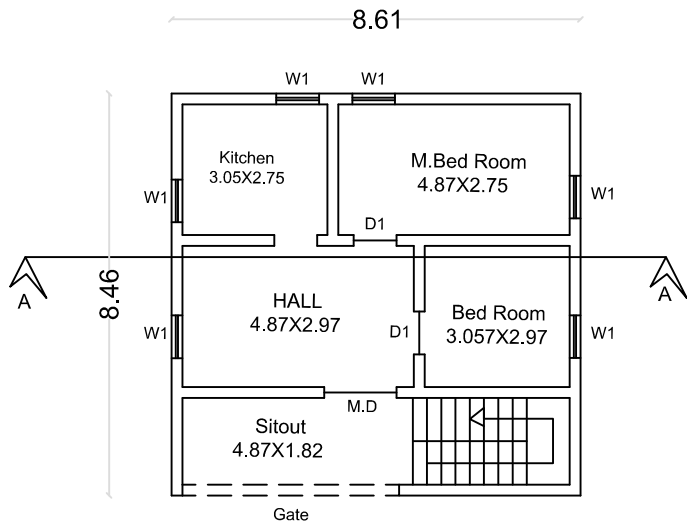

ELEVATION

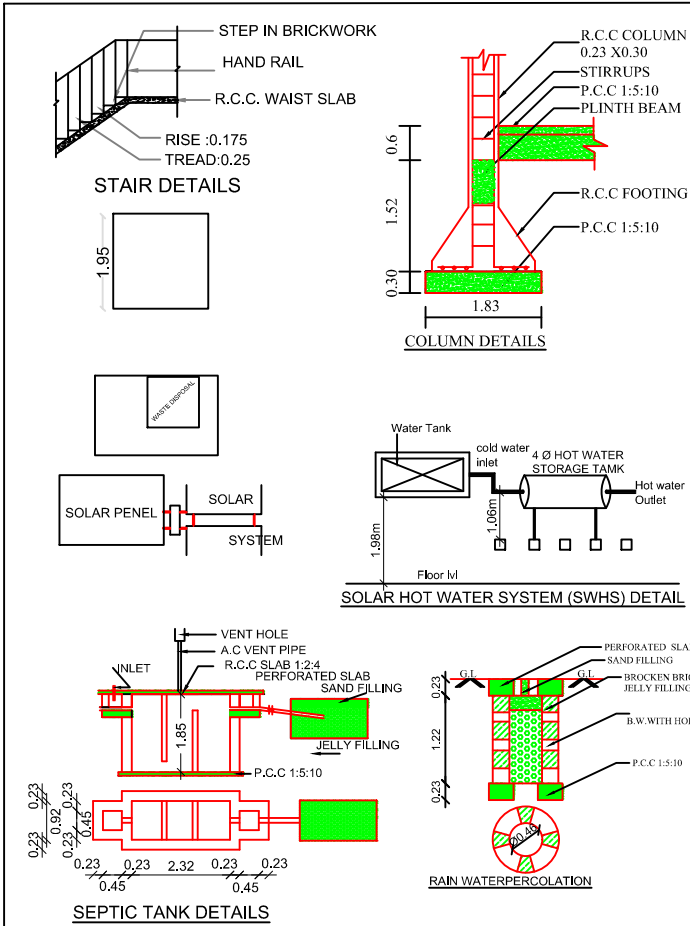

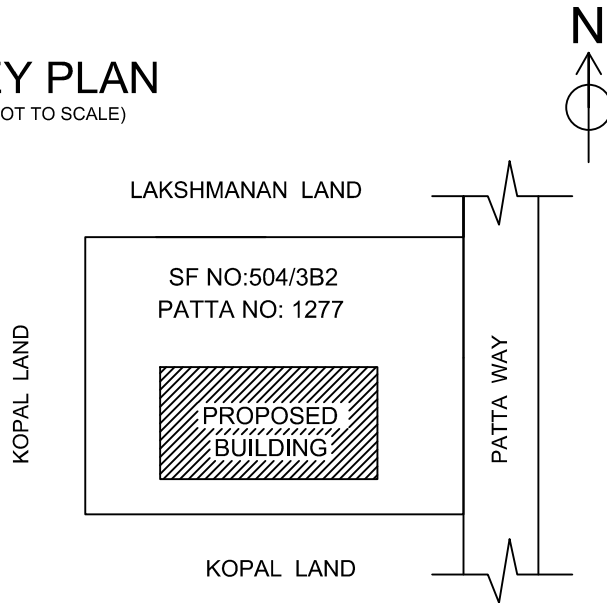


GROUND FLOOR PLAN
