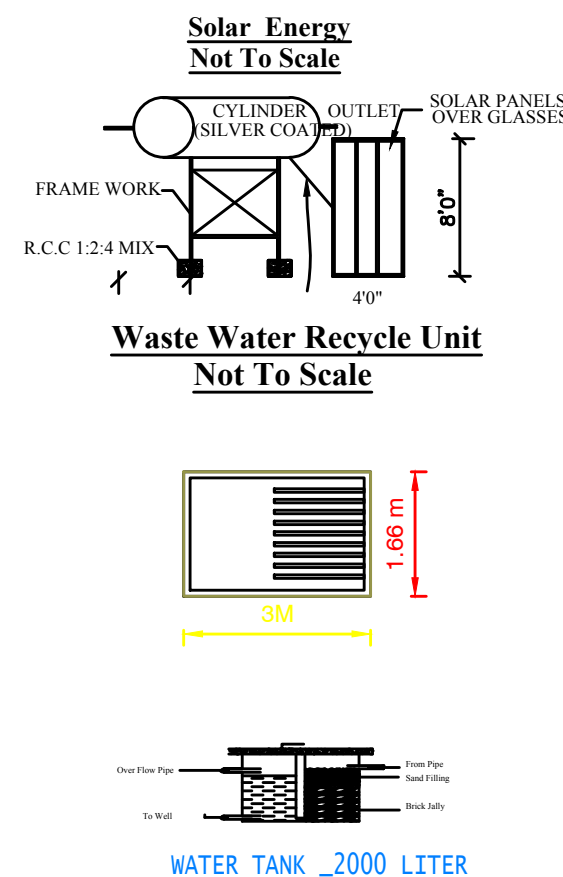

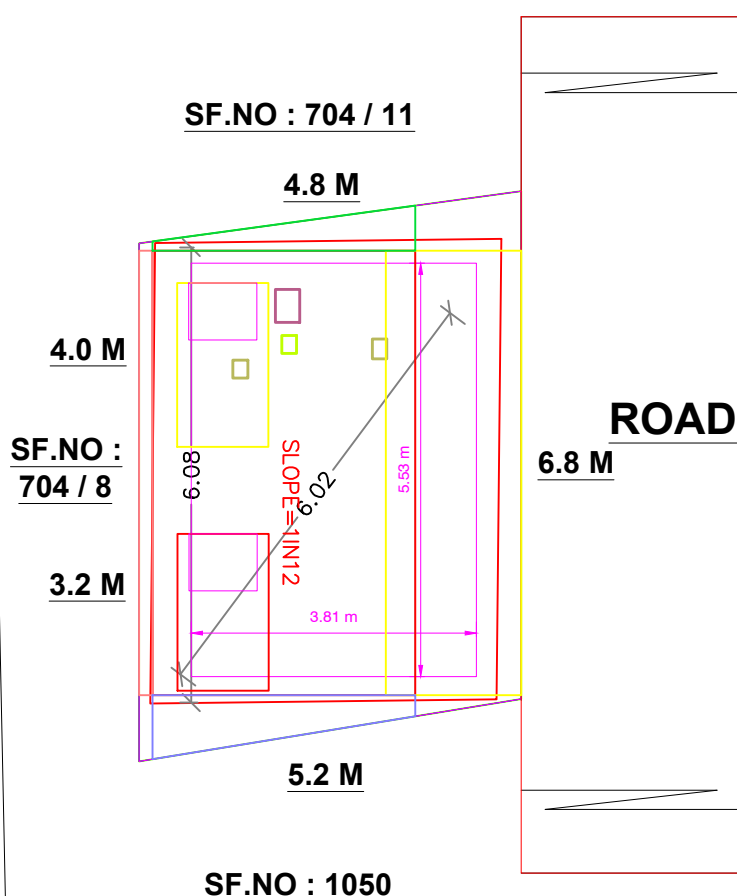

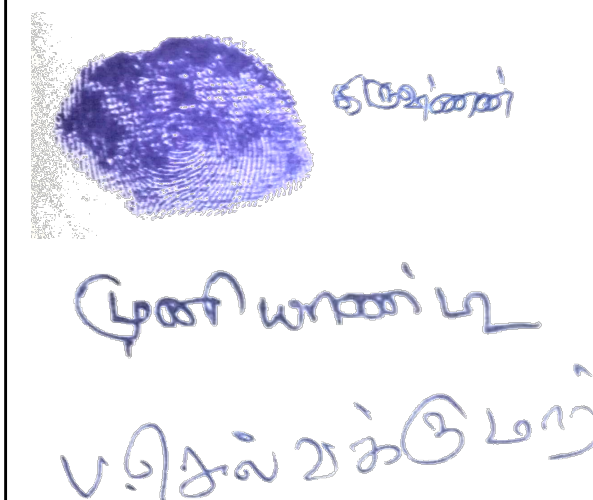


Septic Tank With U Trap
