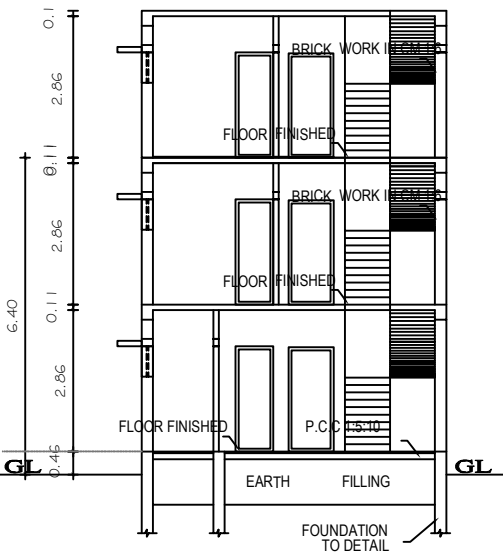

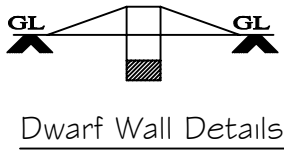

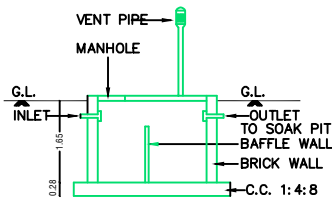

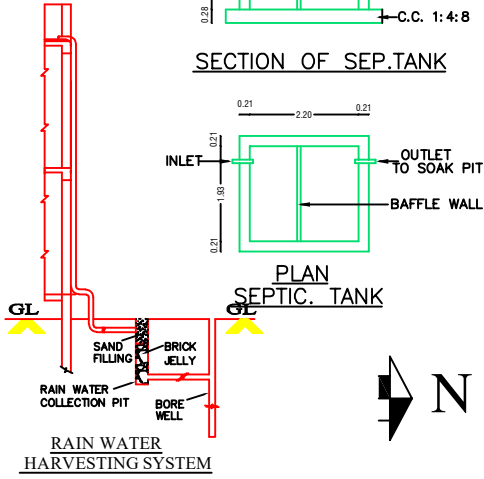

Dwarf Wall Details

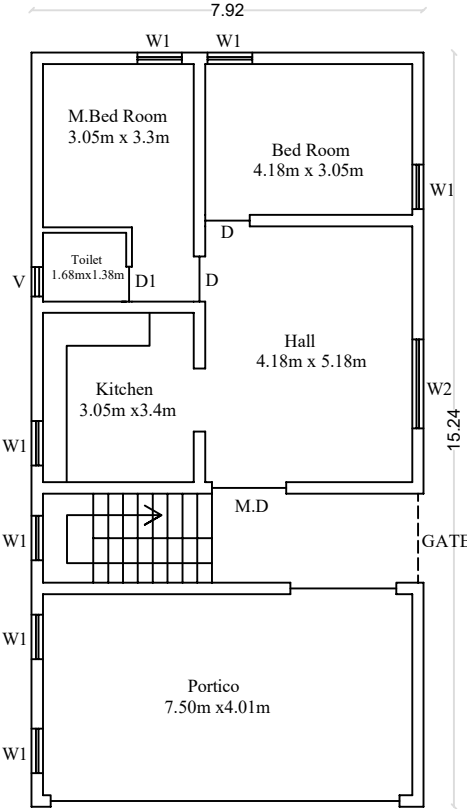


SECTION OF SEP. TANK

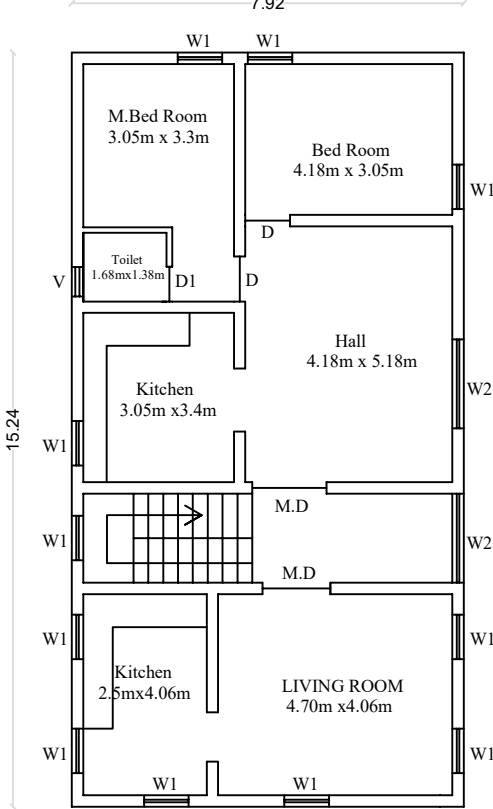


PLAN SEPTIC. TANK

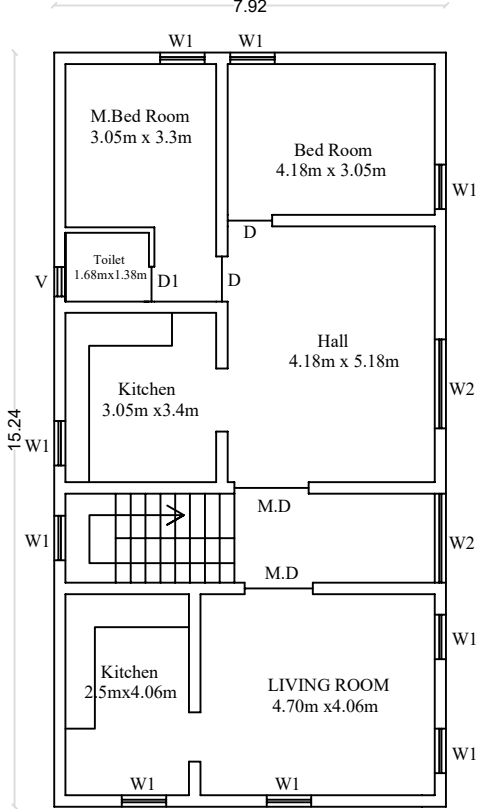
RAIN WATER HARVESTING SYSTEM



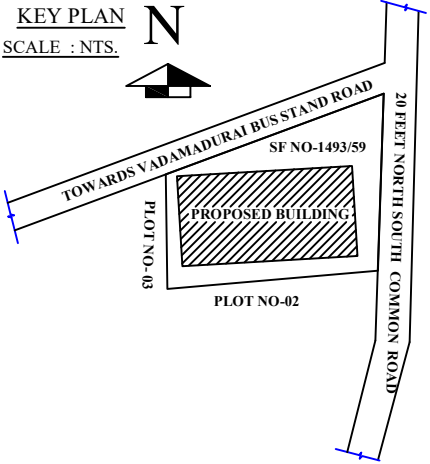
PRO. GROUND FLOOR PLAN.
