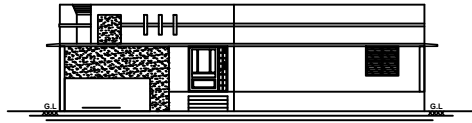

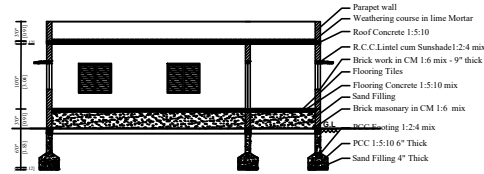

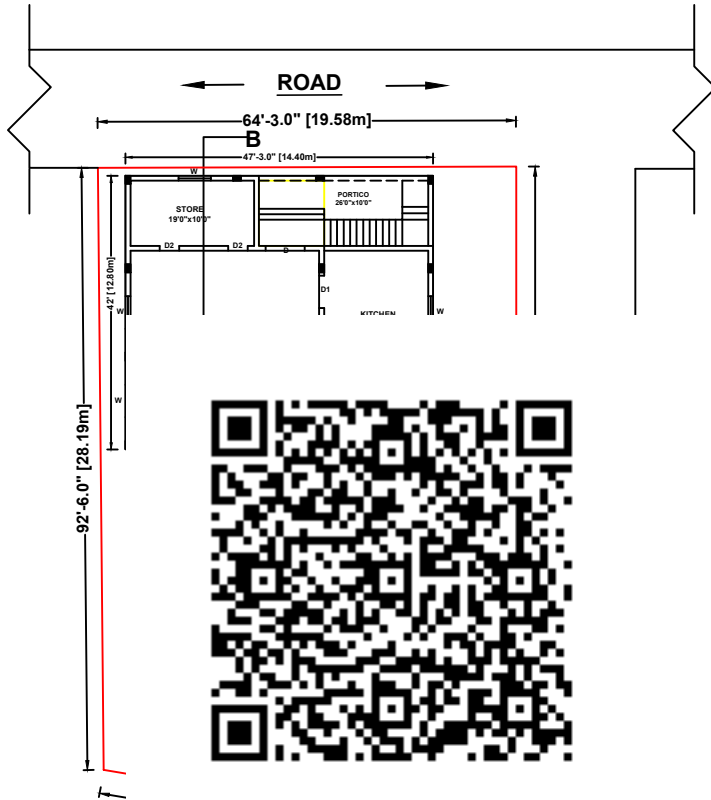

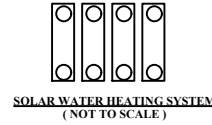
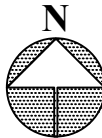
CROSS SECTION ON "AB"



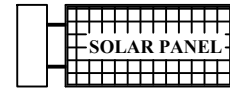
GROUND FLOOR PLAN



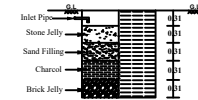
STAIR CASE DETAIL

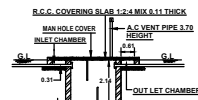
SOLAR WATER HEATING SYSTEM
(NOT TO SCALE)



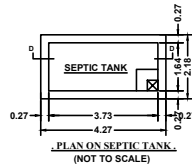
PLAN ON SOLAR WATER HEATER

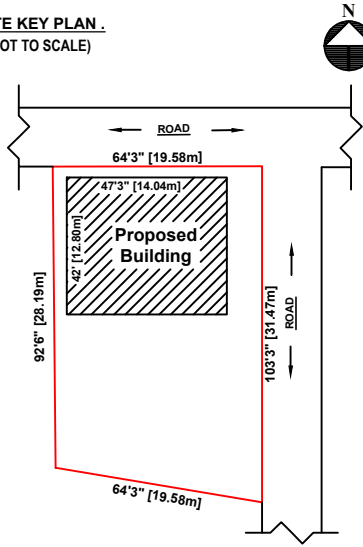
RAIN WATER HARVESTING DETAIL
