. SITE PLAN . **. NOT TO SCALE .**

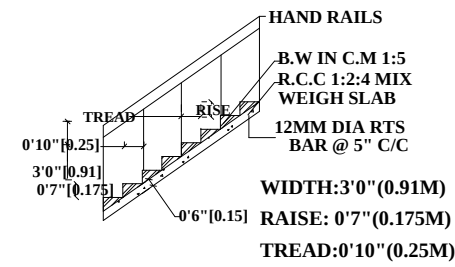

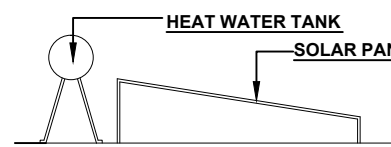
