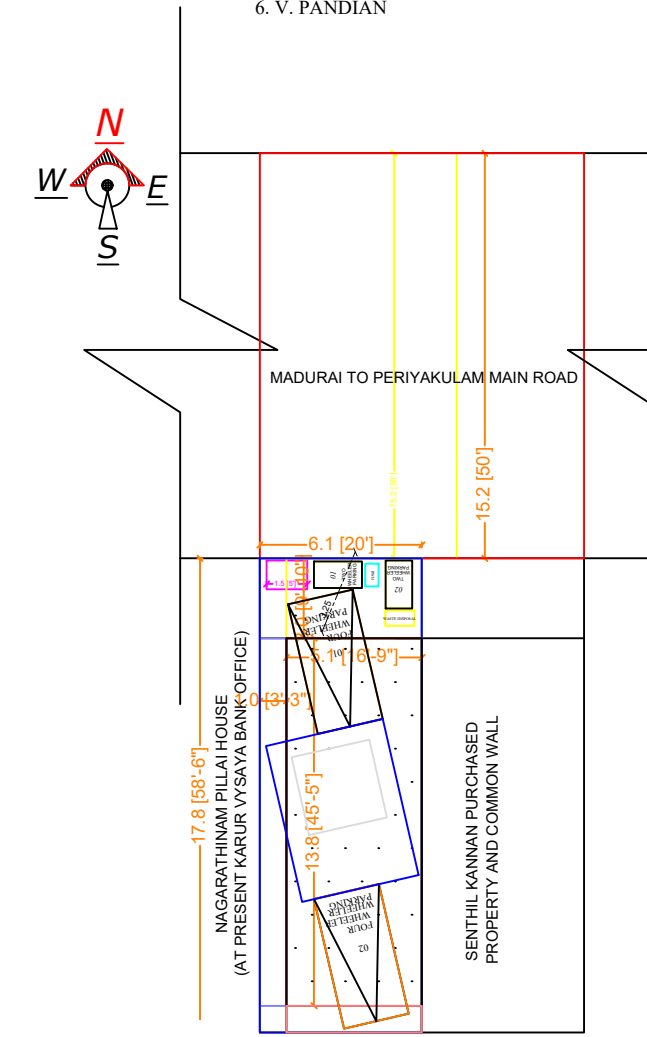

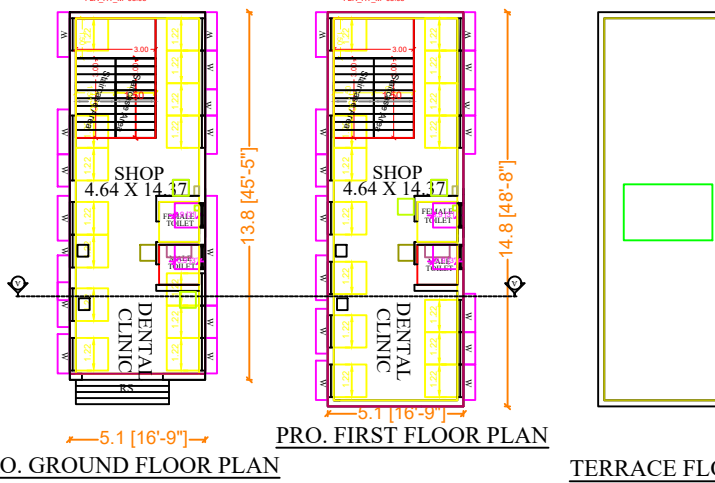

KEY/SITE PLAN FOR SUR. NO. 480/1, 480/2A, 490/2B1A

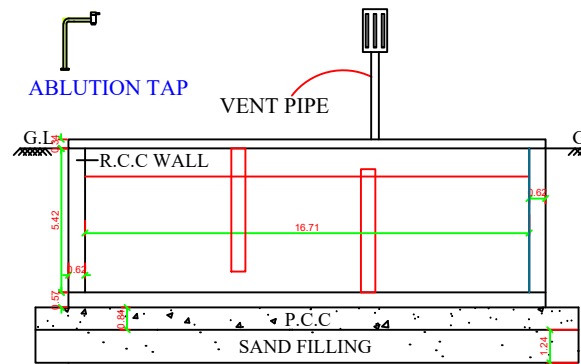

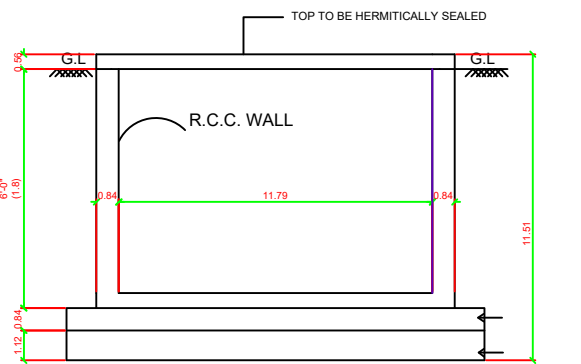

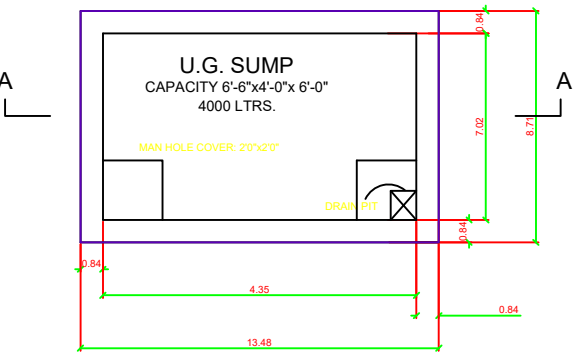

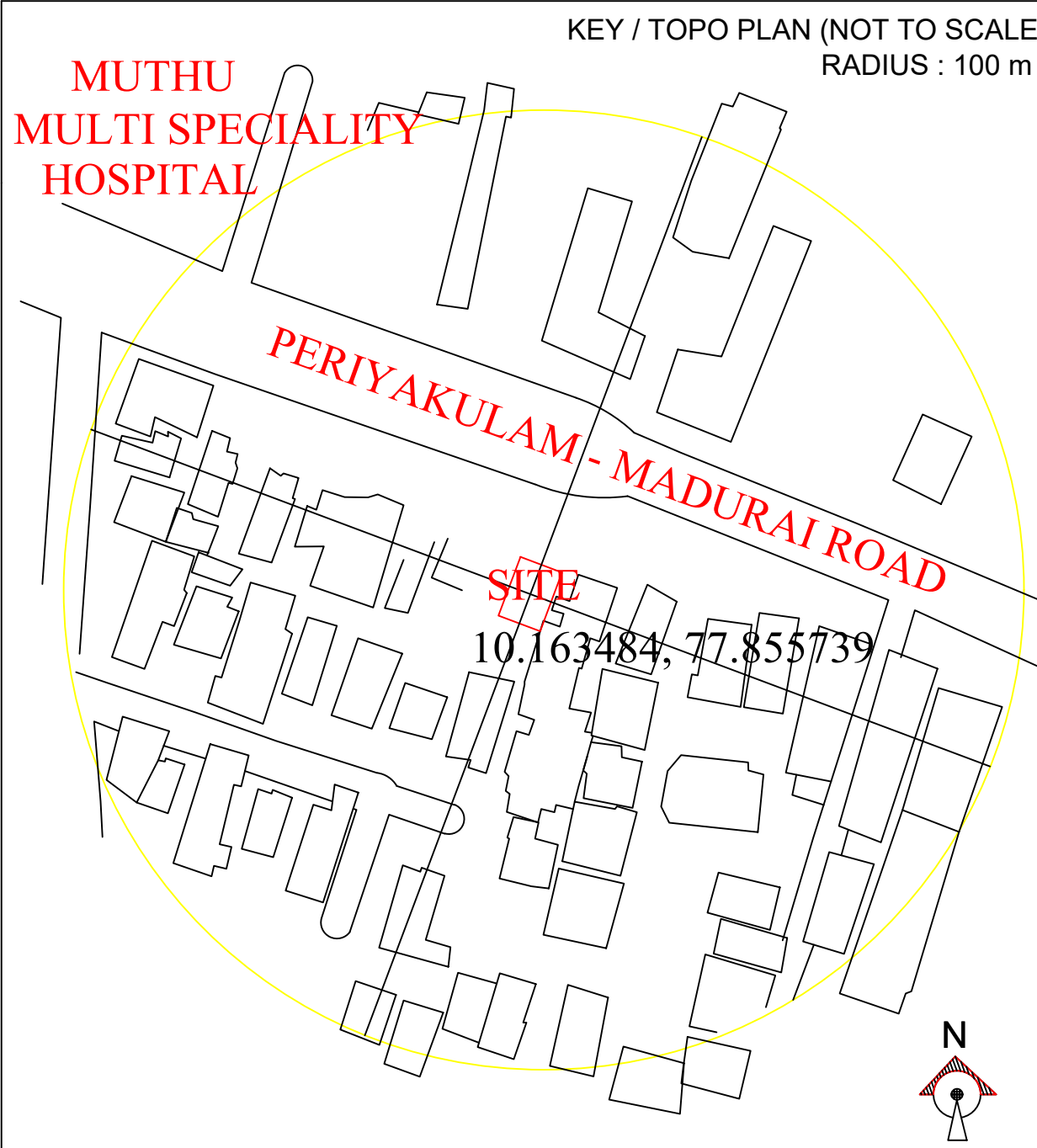
PLAN OF SEPTIC TANK
