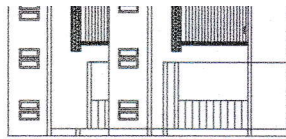
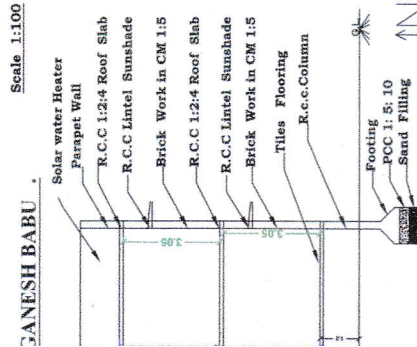

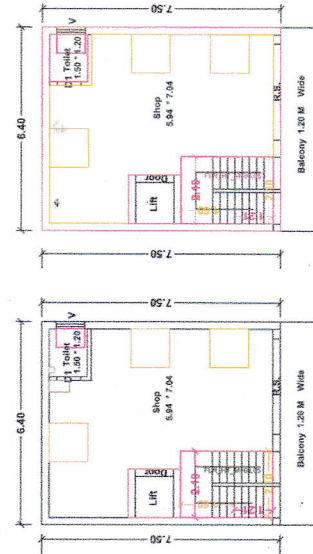
PLAN SHOWING THE DEMOLISHED THE EXISTING BUILDING AND

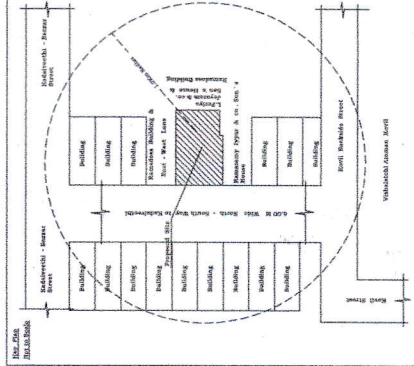

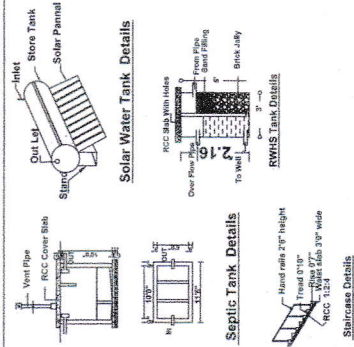
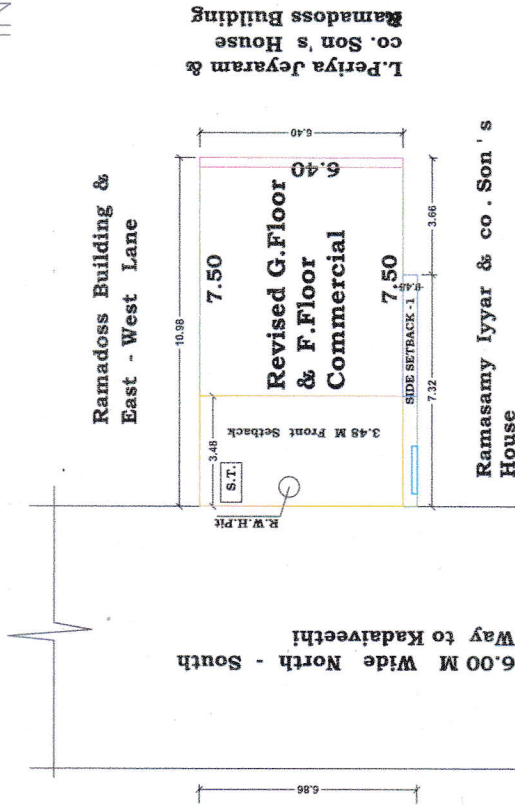


PLAN - Revised
