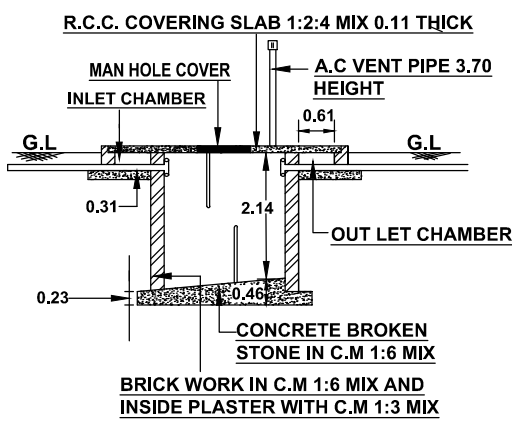

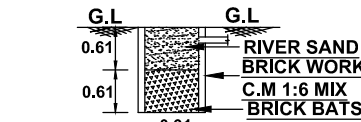
. GROUND FLOOR PLAN .



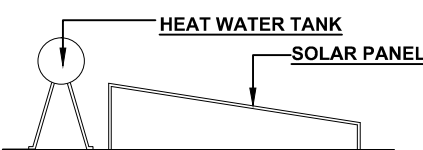
. PROPOSED FIRST FLOOR PLAN .



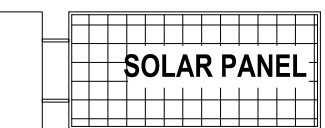

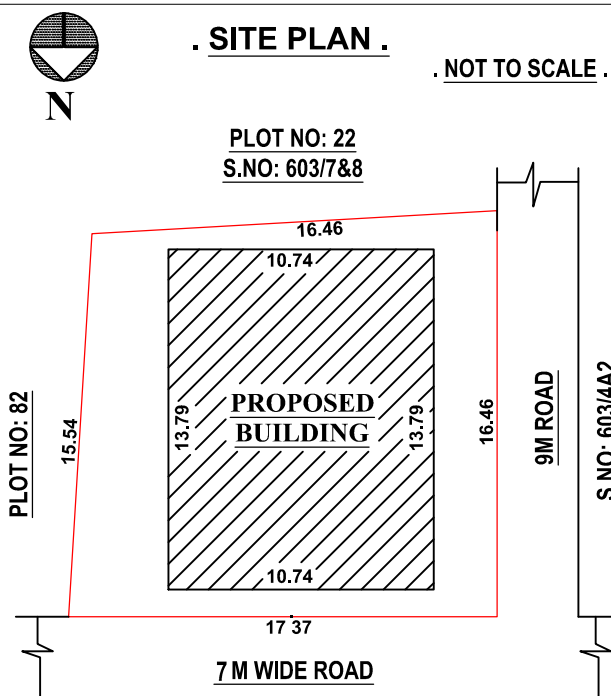

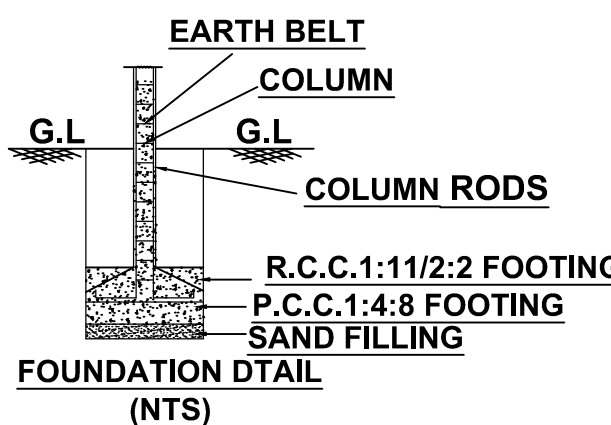
