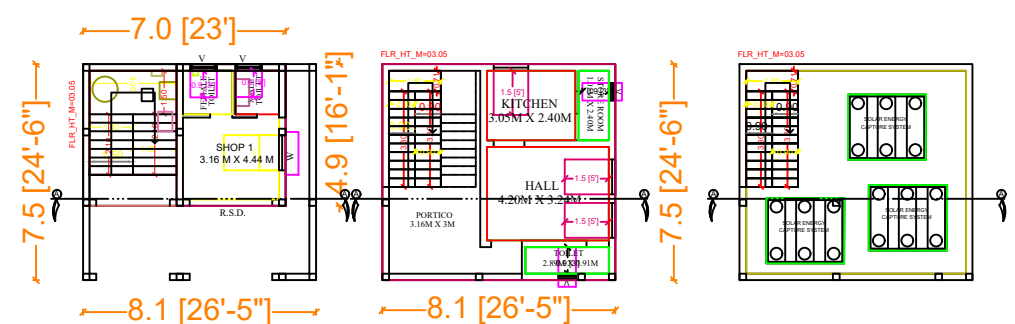

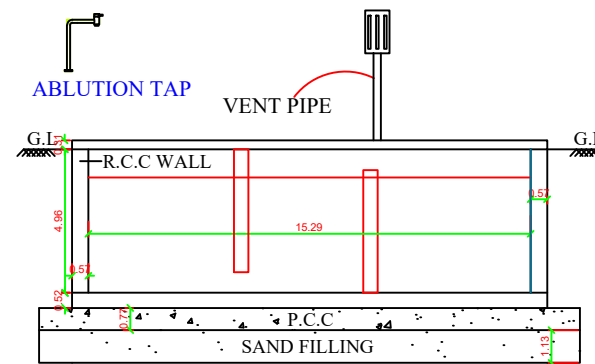

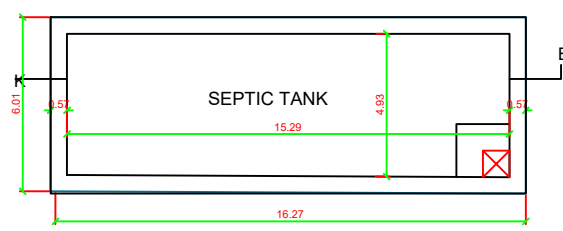

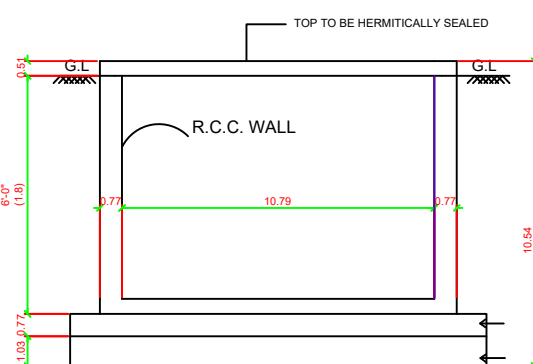

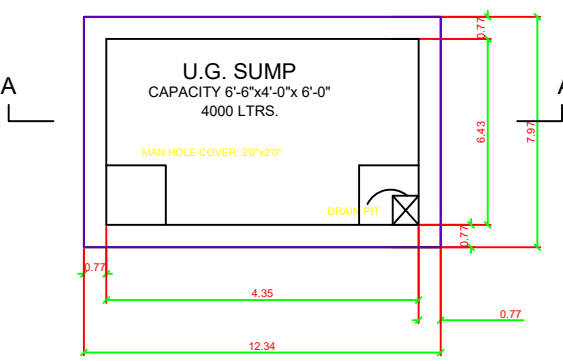

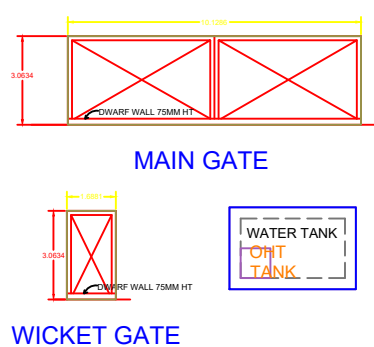


SUMP DETAIL



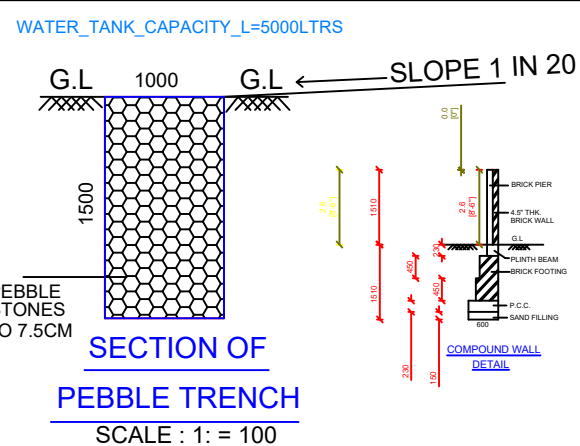
TYPICAL SECTION OF

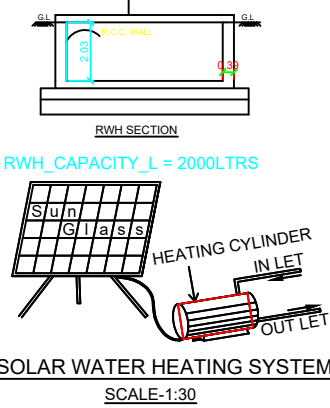

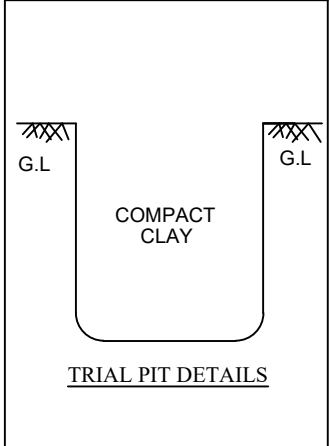

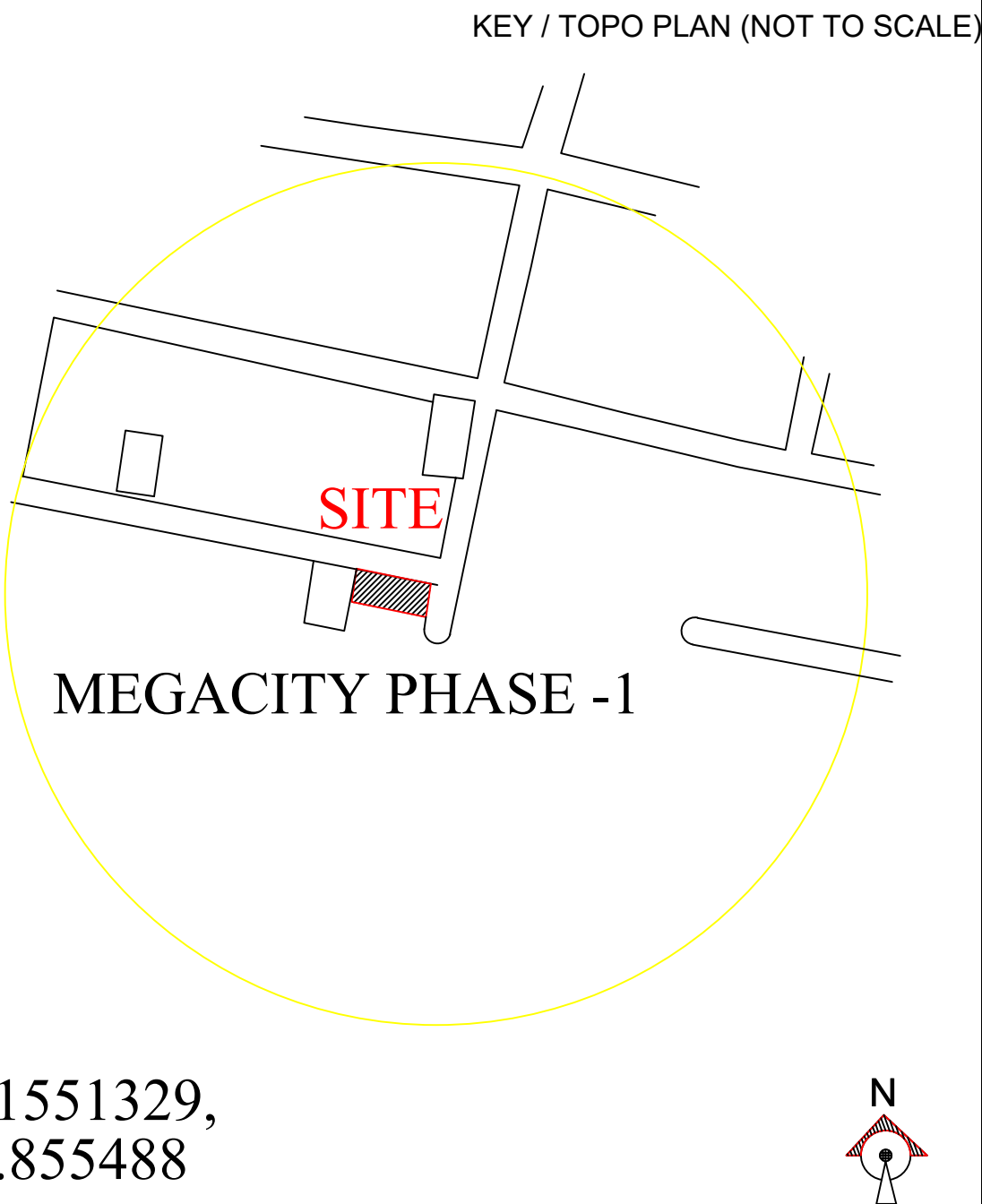
SOLAR WATER HEATING SYSTEM
