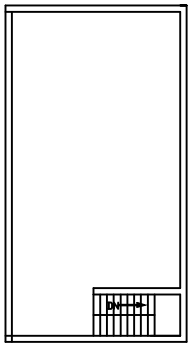

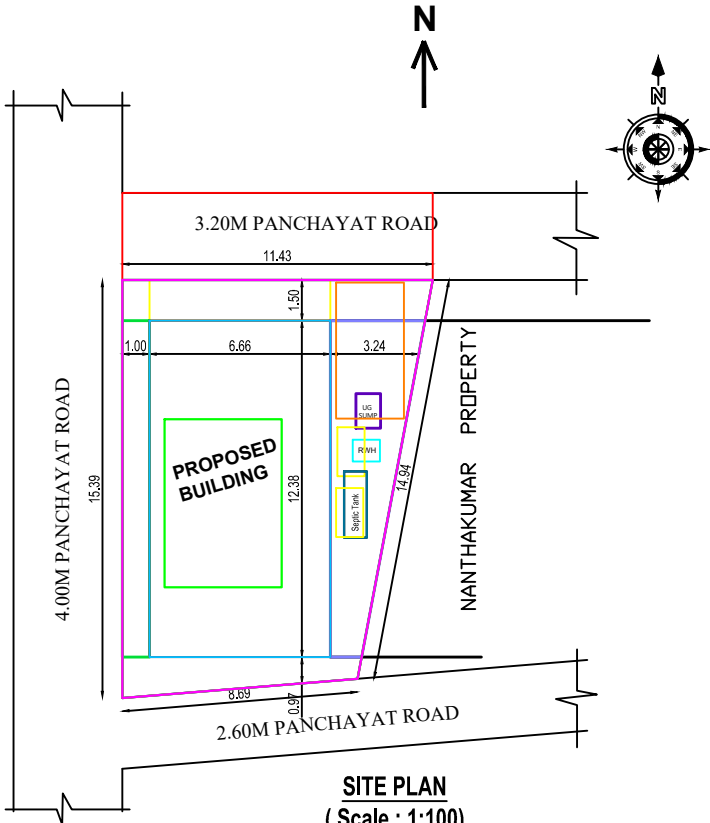

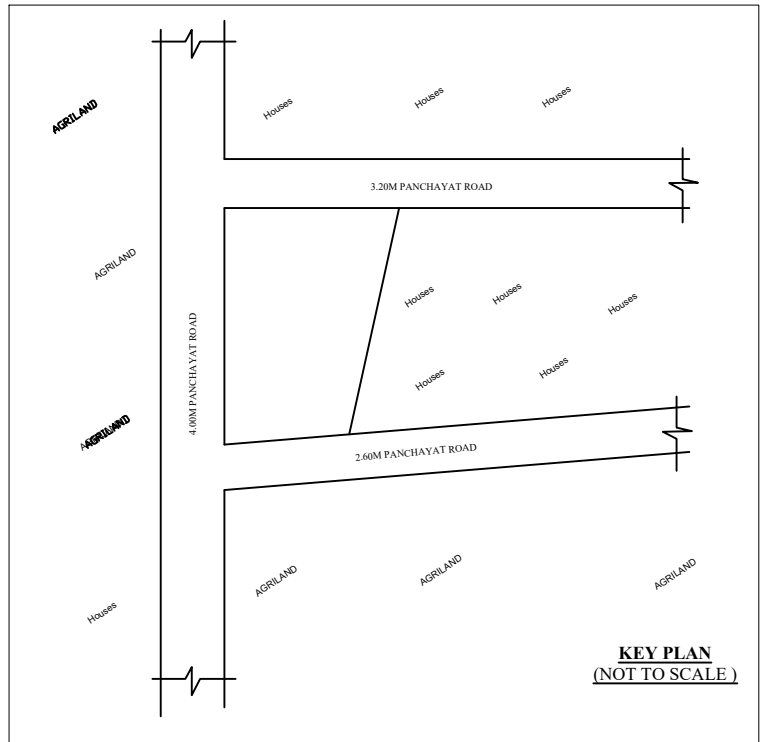
GROUND FLOOR PLAN

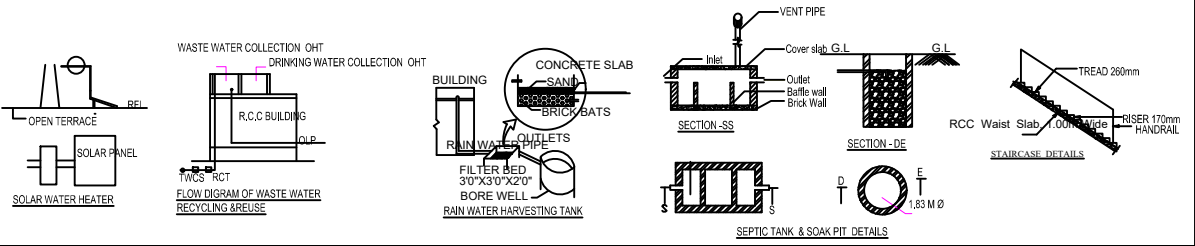
