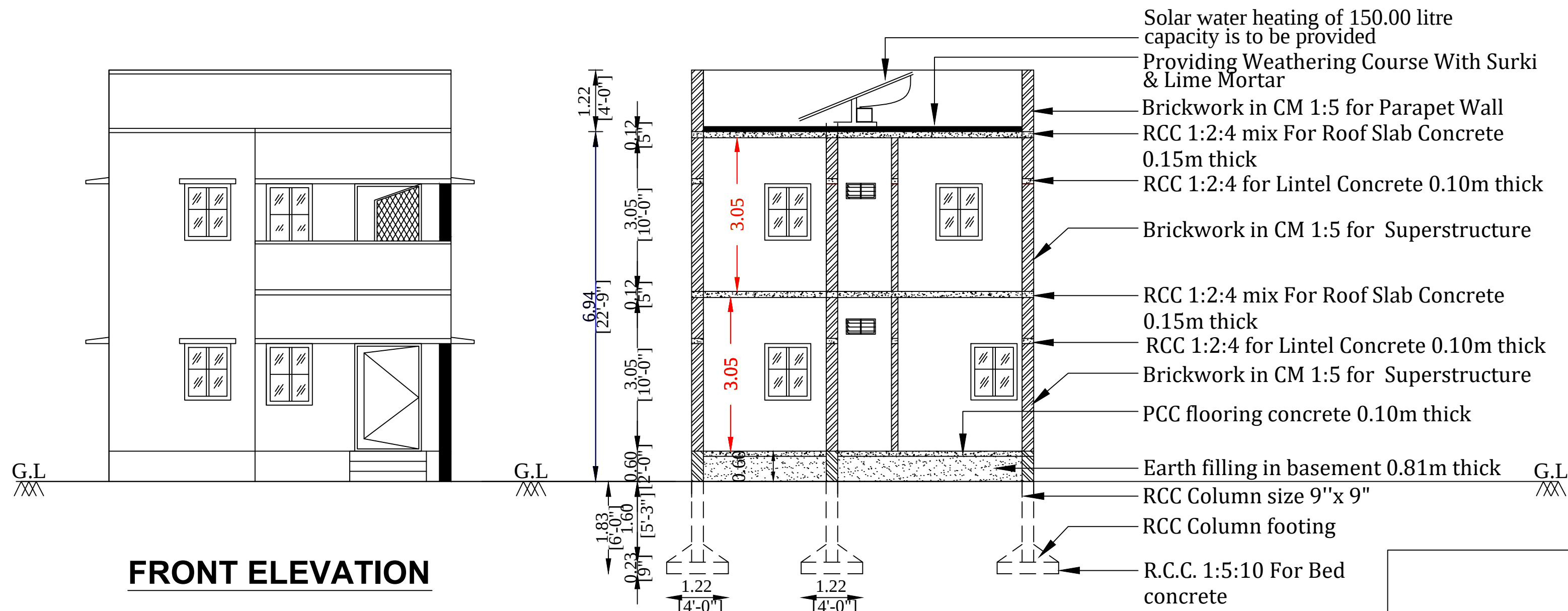

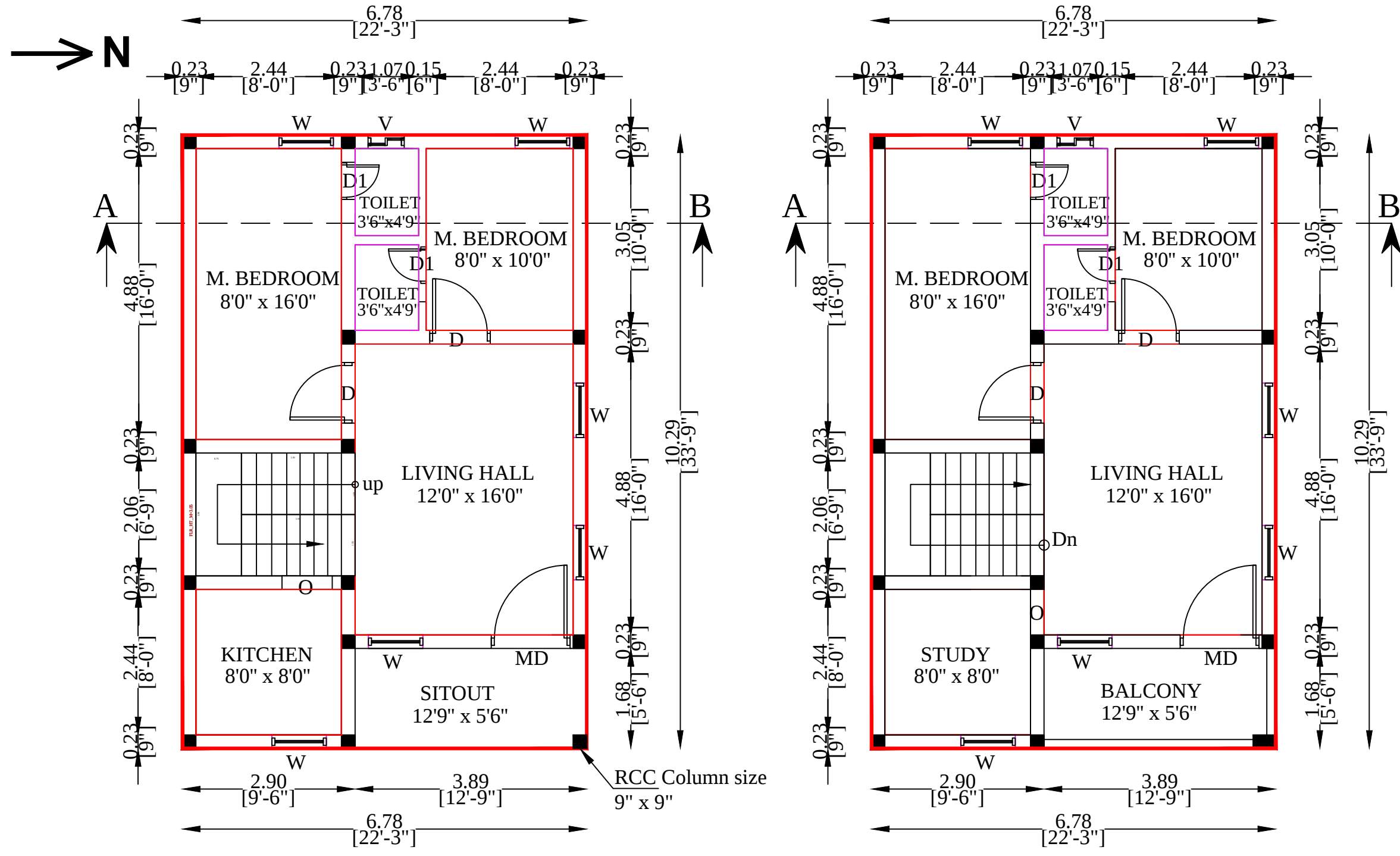

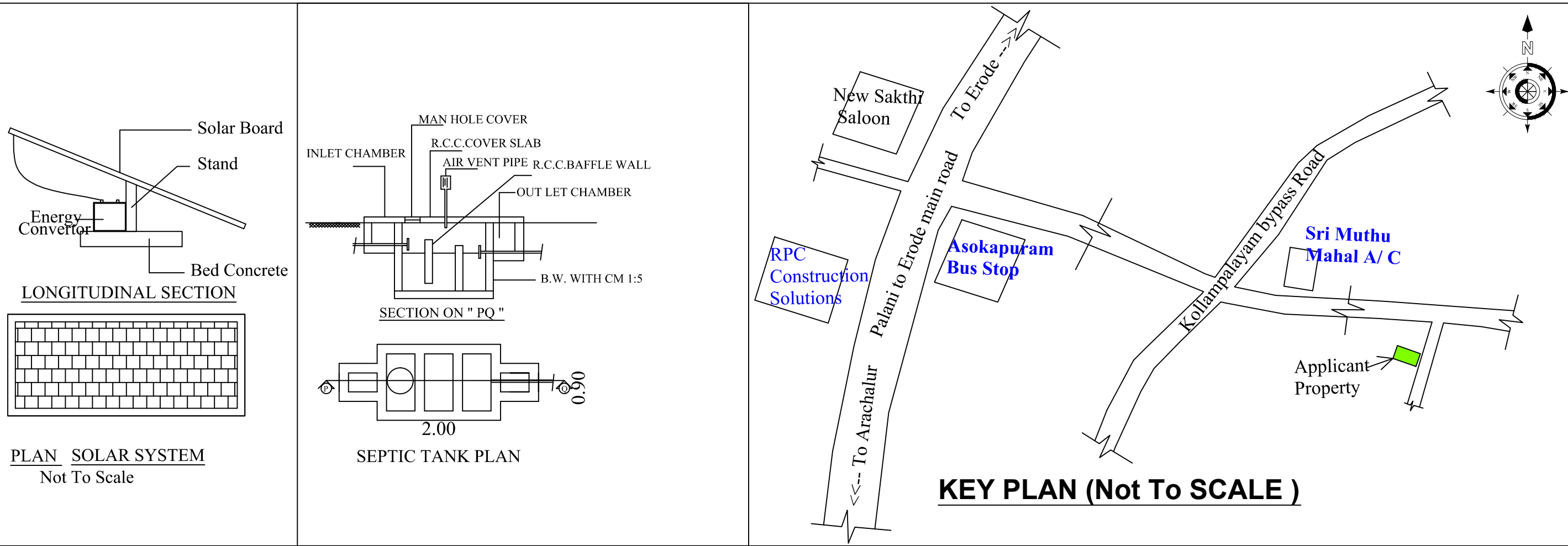
FRONT ELEVATION

GROUND FLOOR PLAN

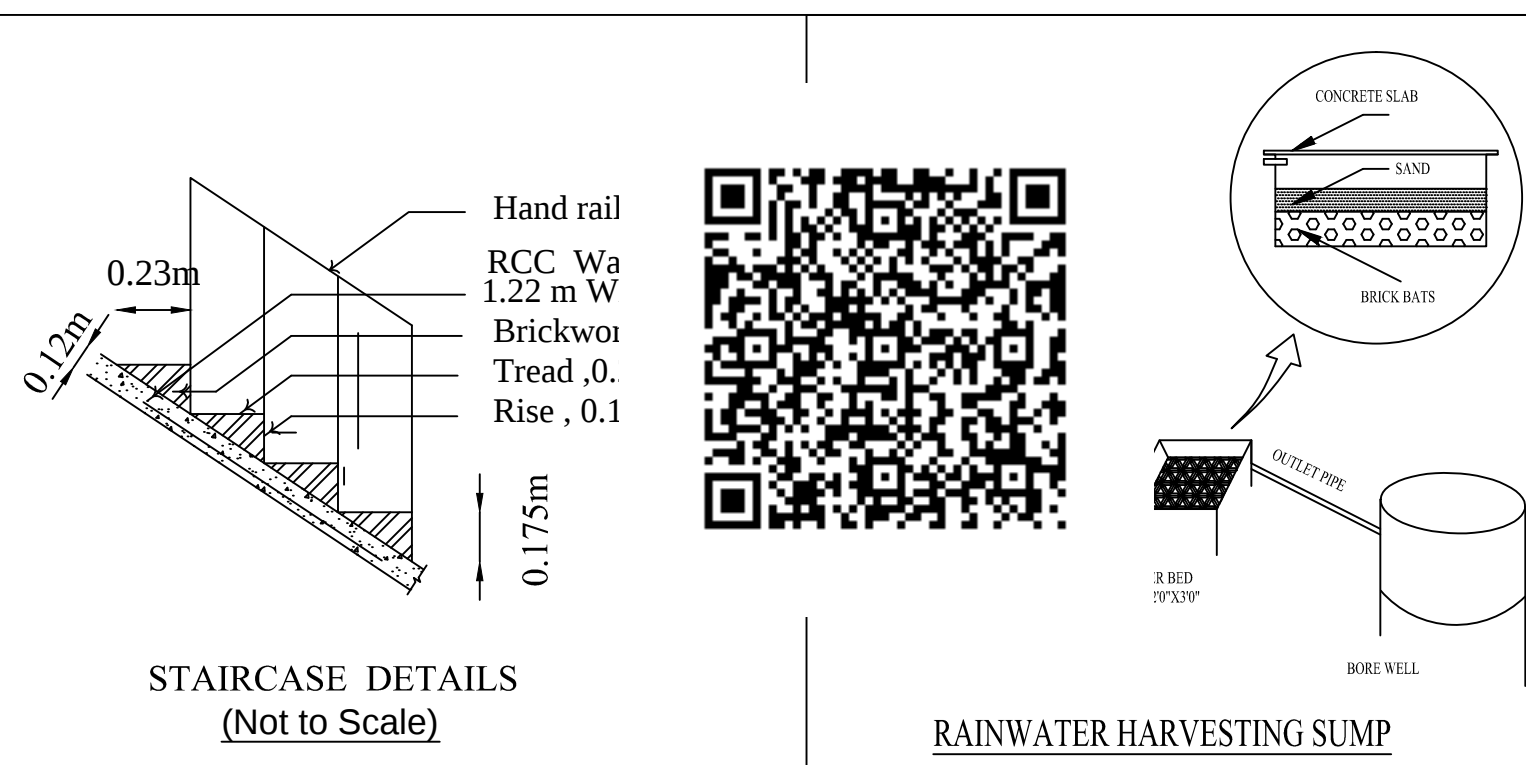
FIRST FLOOR PLAN

Not To Scale

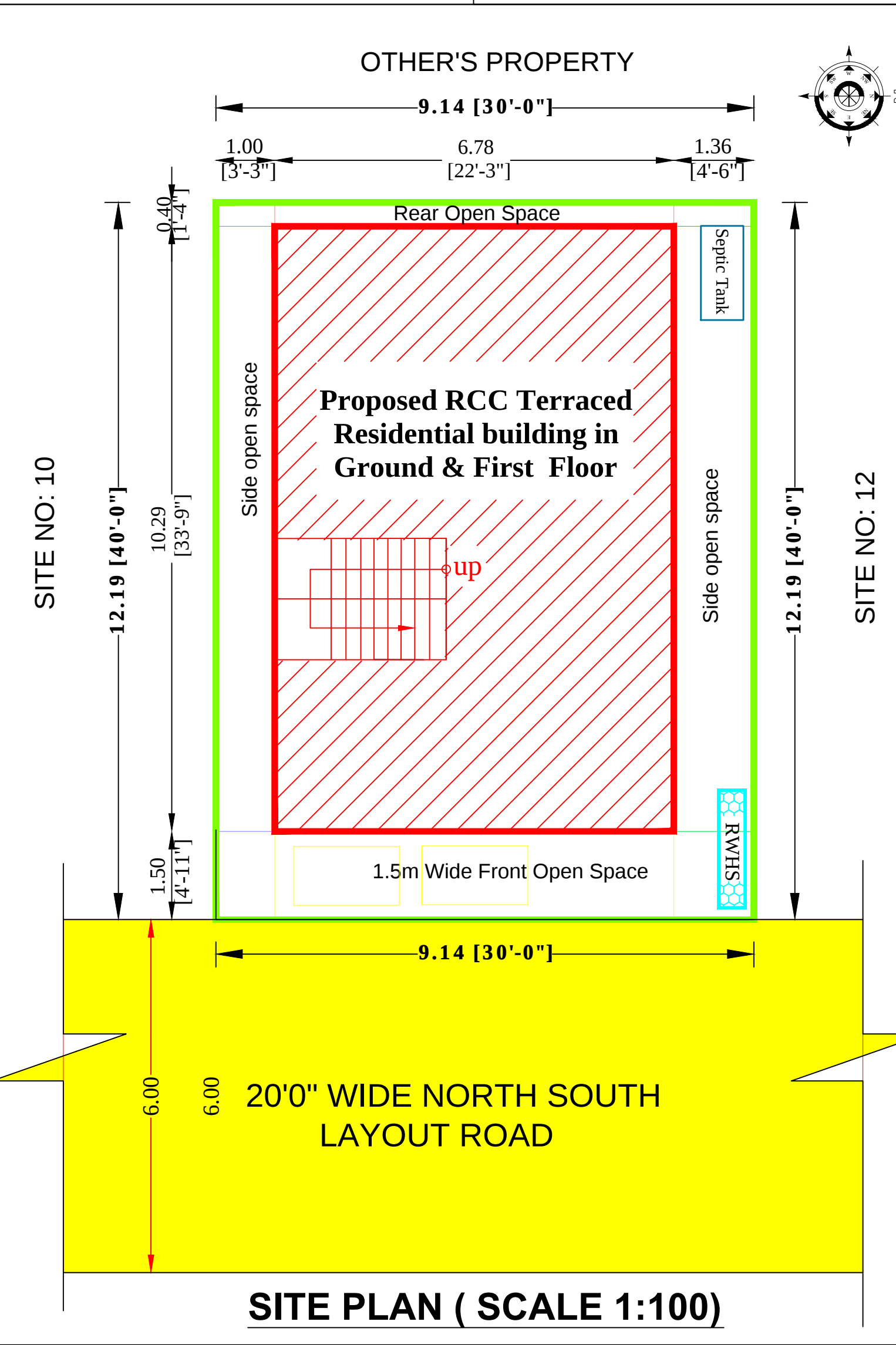
SEPTIC TANK PLAN

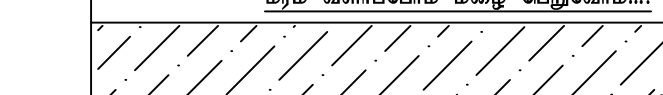
