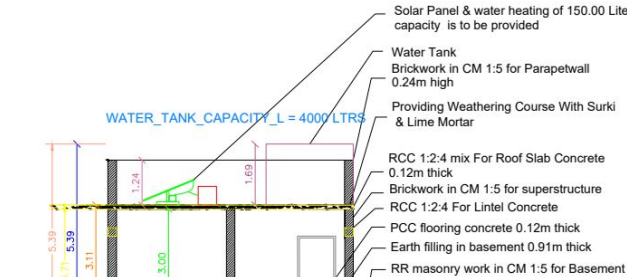

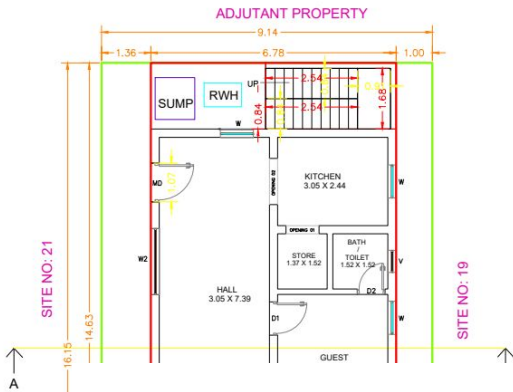
KEY PLAN (NOT TO SCALE)



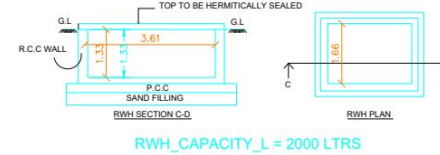

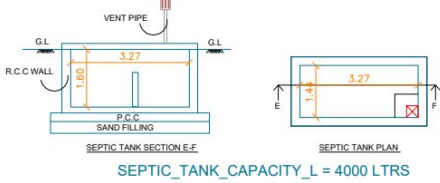


RAIN WATER HARVESTING TANK DETAILS



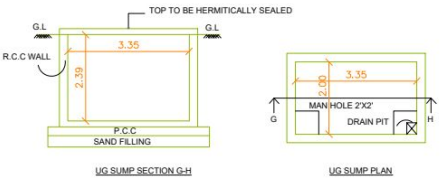

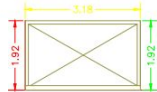

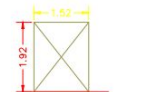
