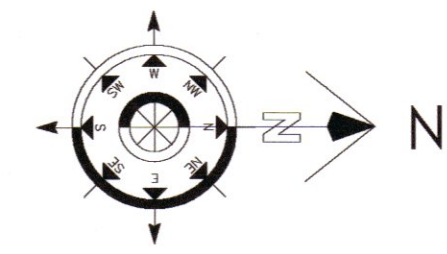
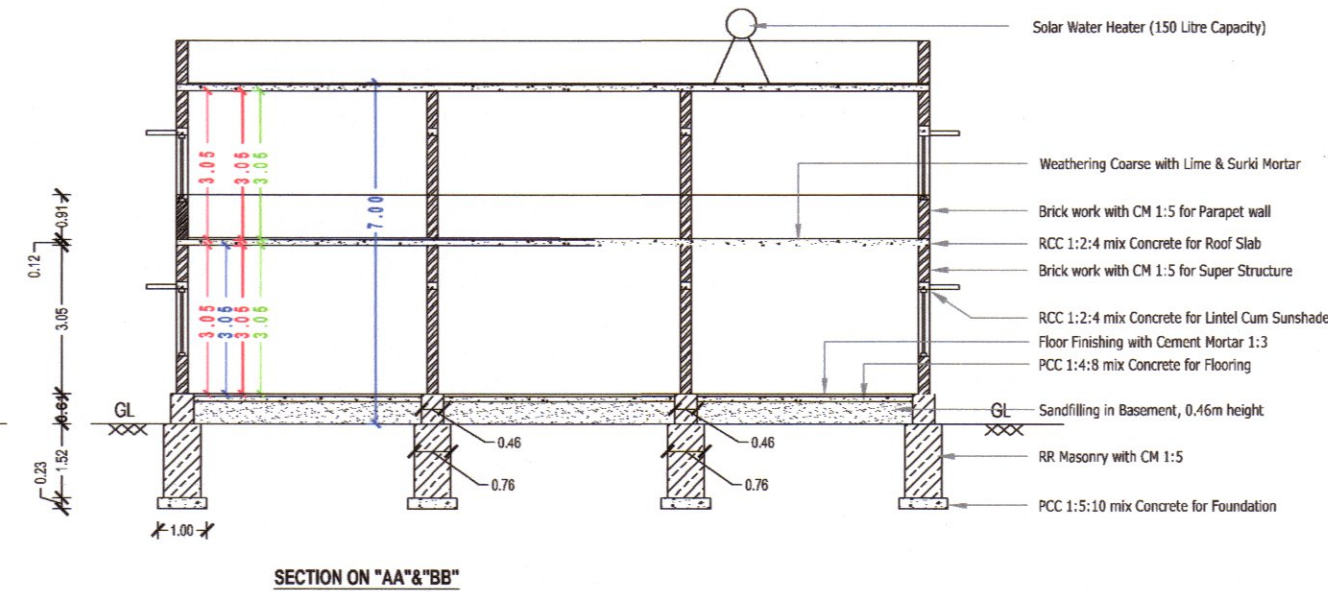
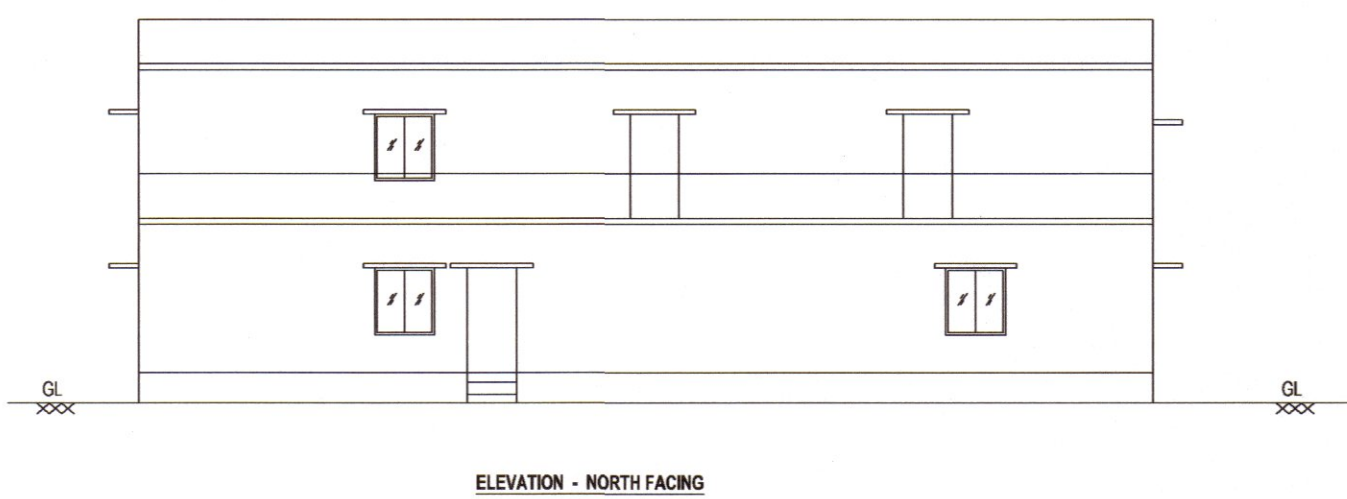

(SCALE 1:100)

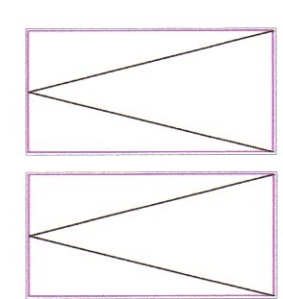

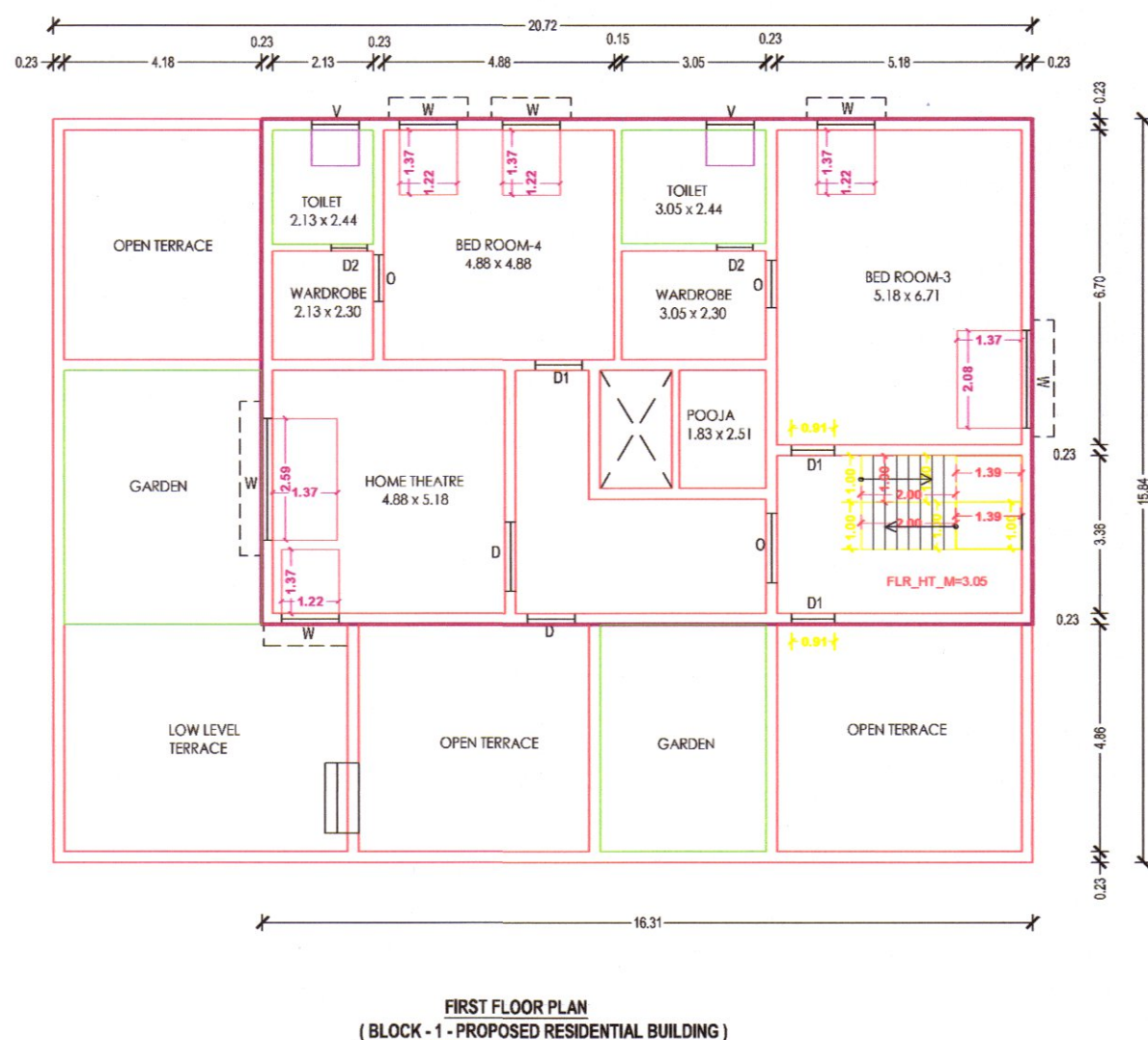

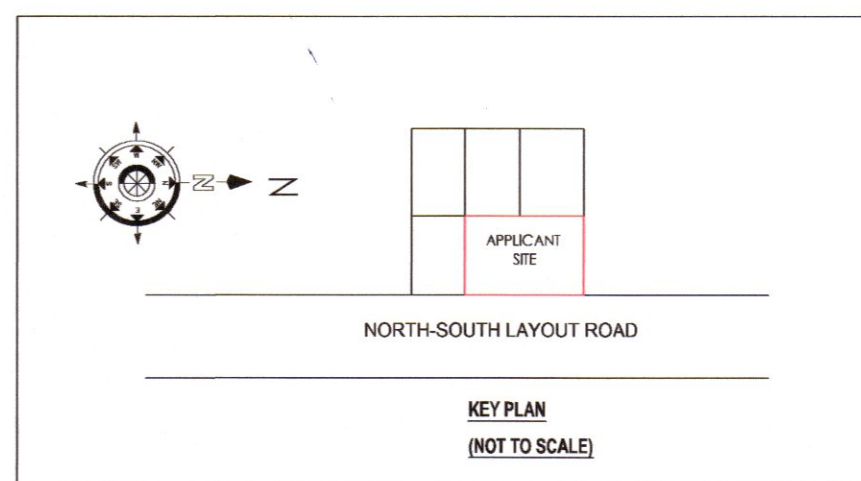

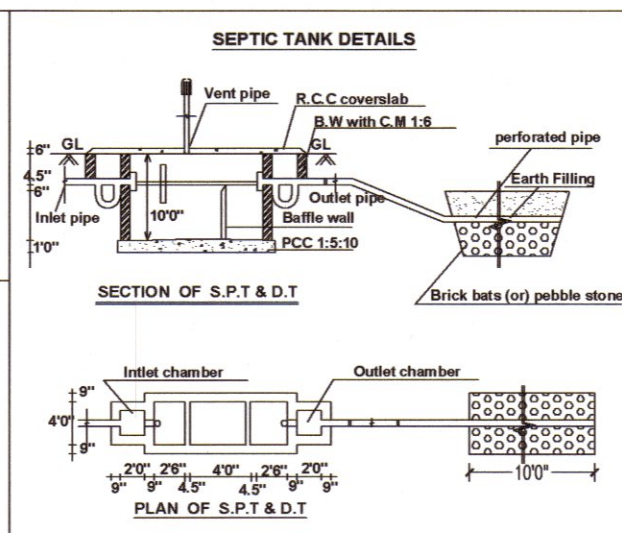
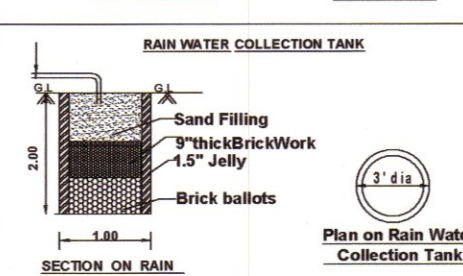
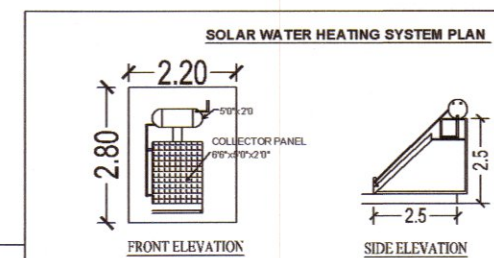
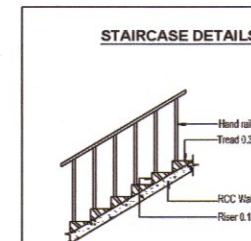
FIRST FLOOR PLAN
