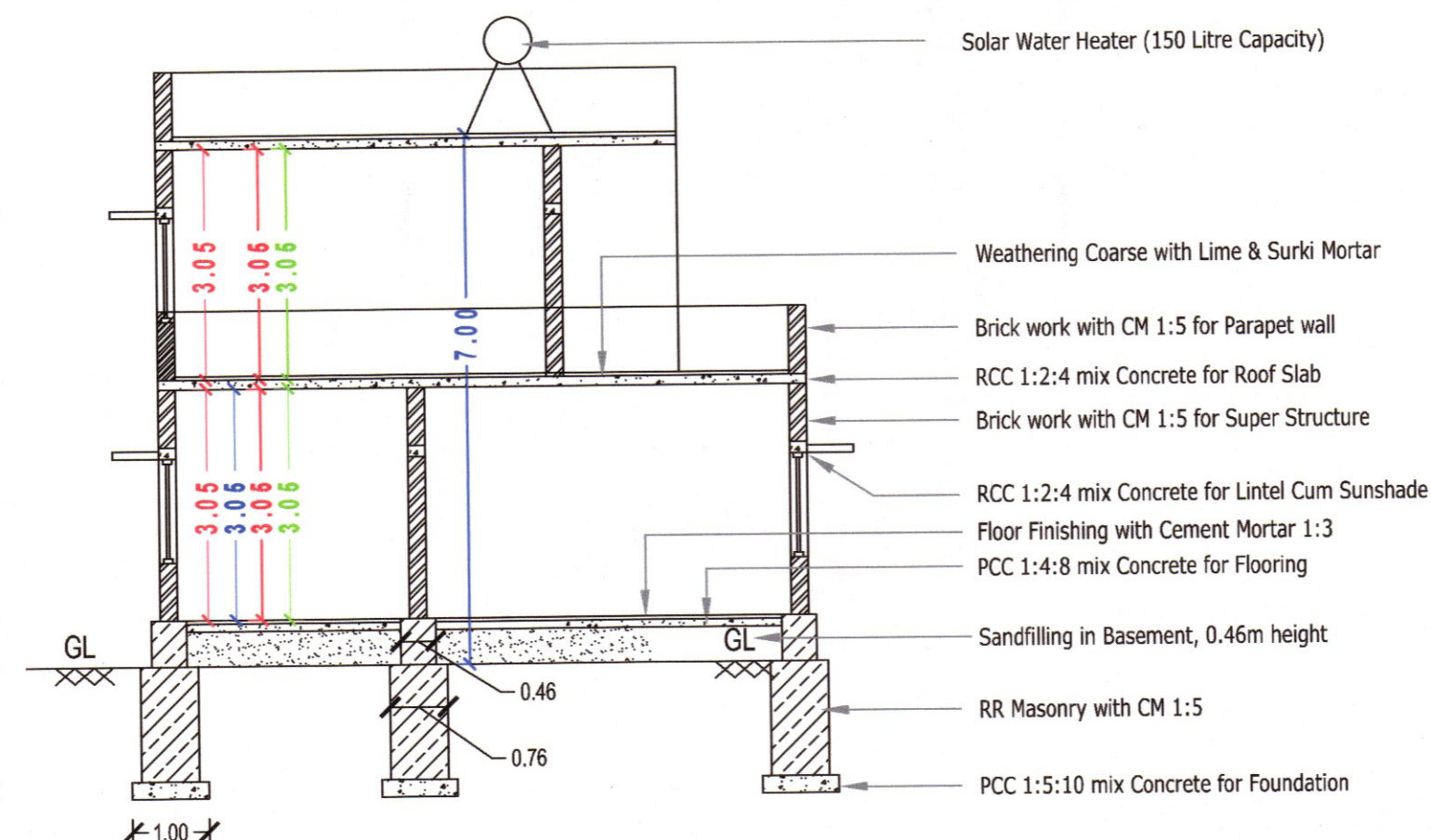

(BLOCK - 1 - PROPOSED RESIDENTIAL BUILDING)



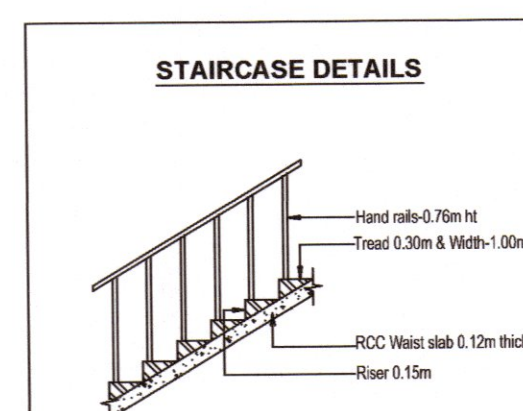
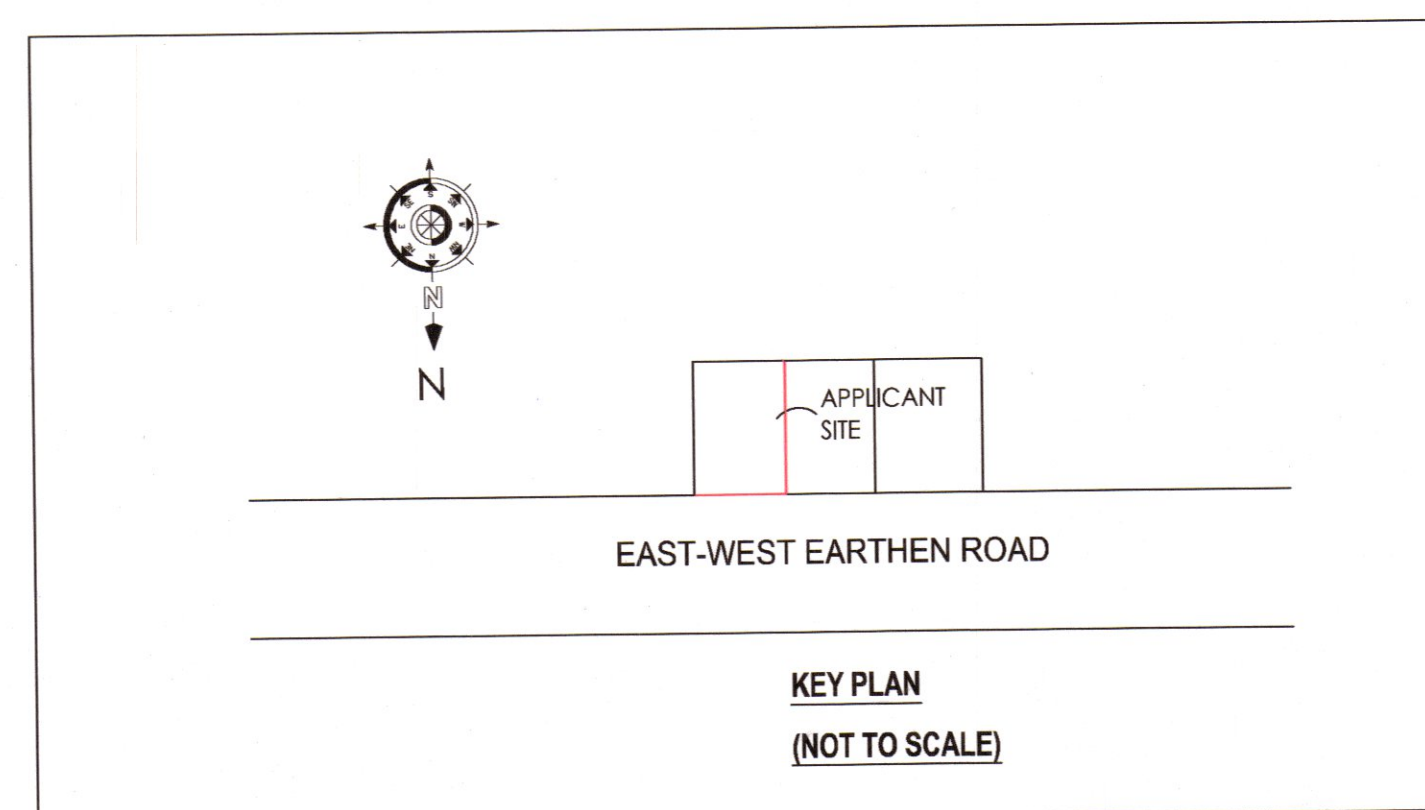
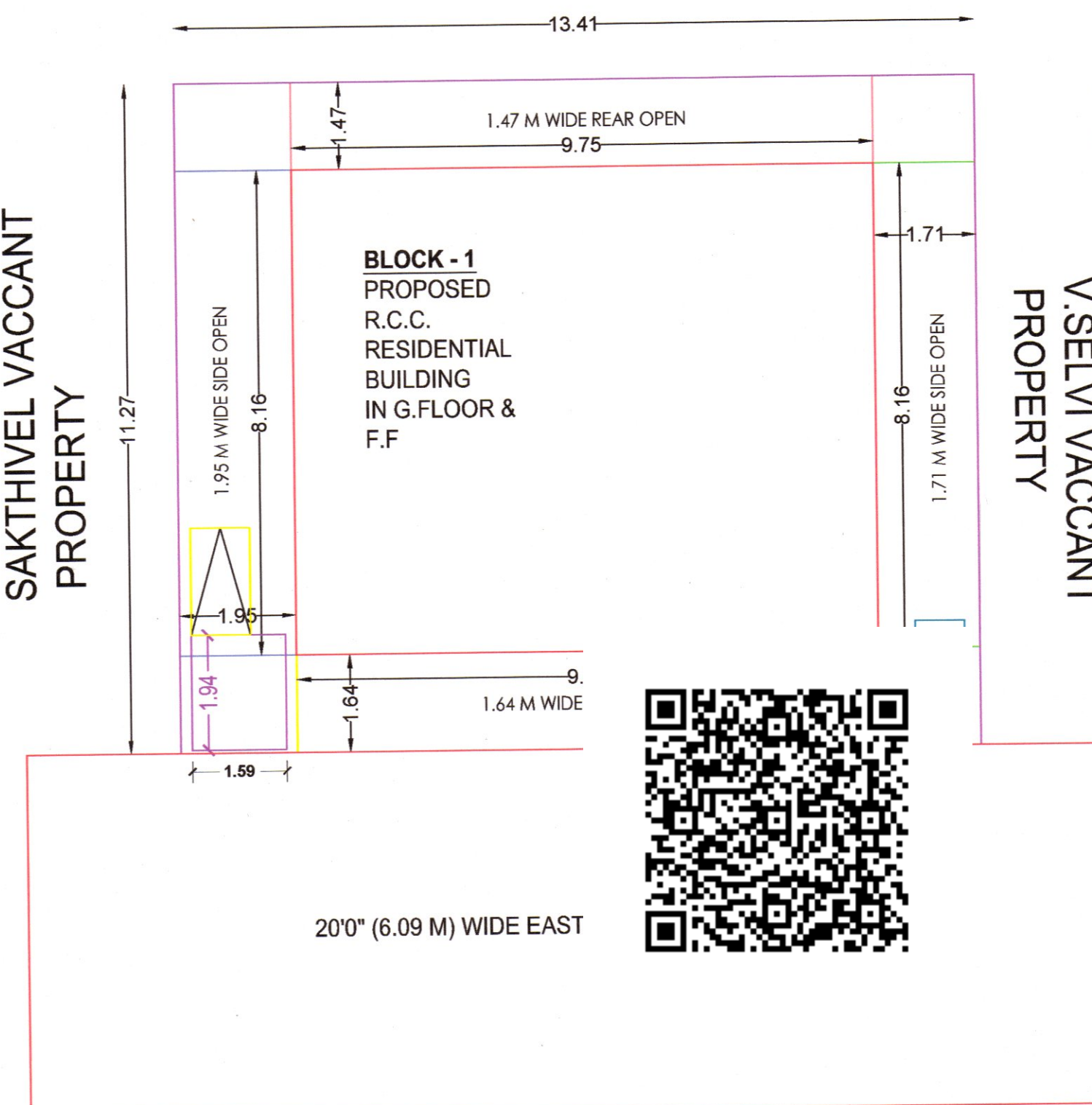
GROUND FLOOR PLAN
(BLOCK - 1 - PROPOSED RESIDENTIAL BUILDING)



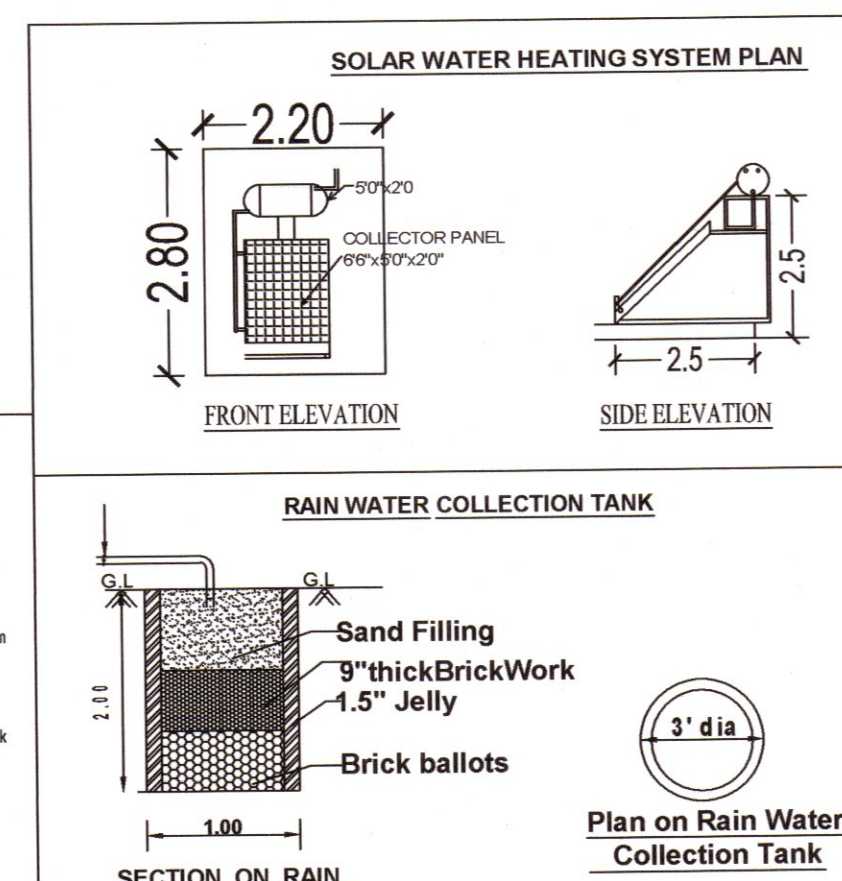

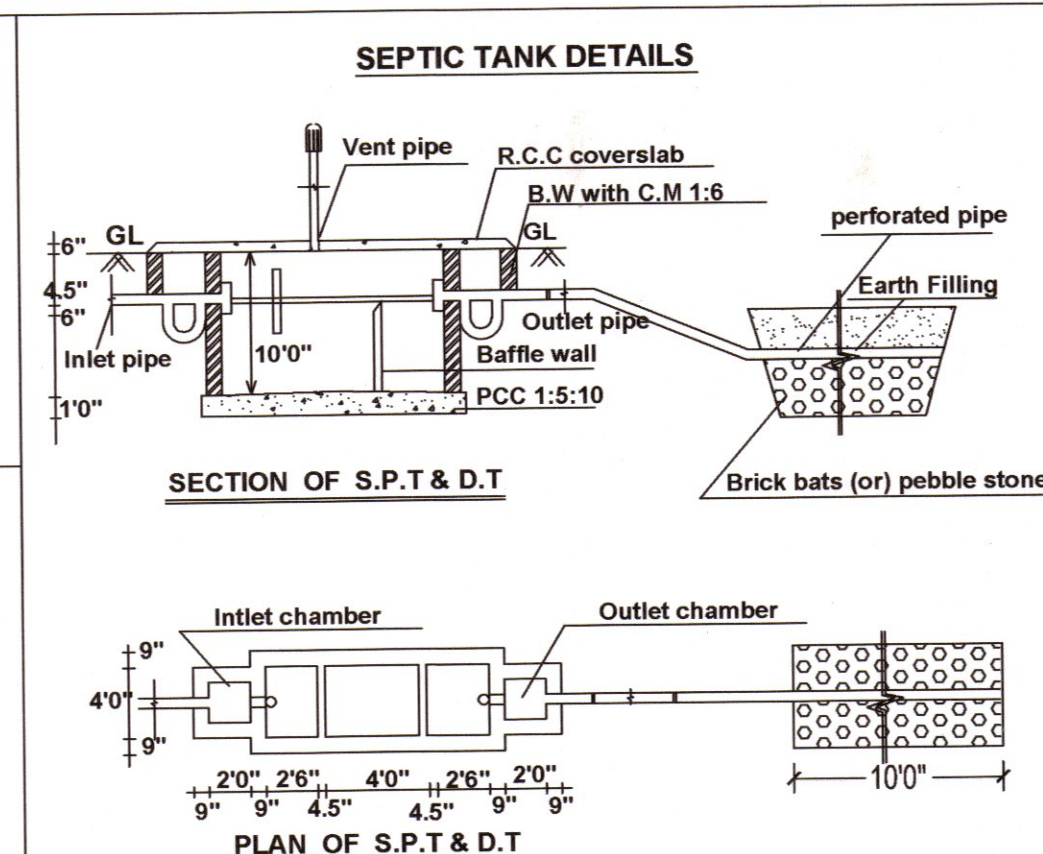

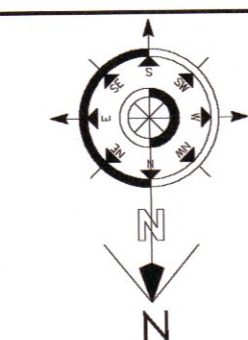
