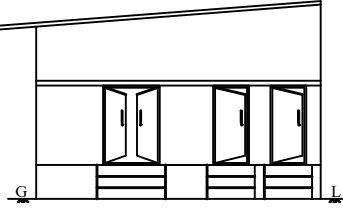

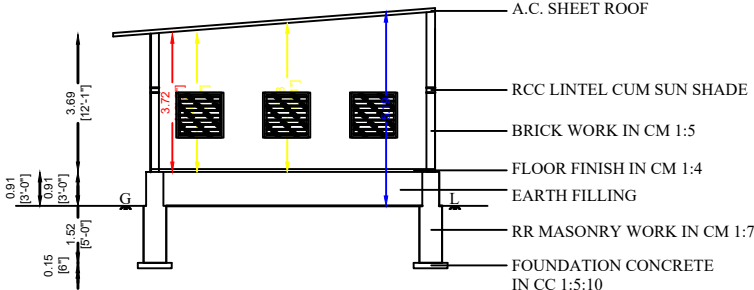
PLAN SHOWING THE PROPOSED CONSTRUCTION OF A.C. SHEET ROOF GODOWN GROUND FLOOR

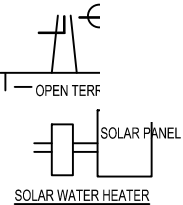

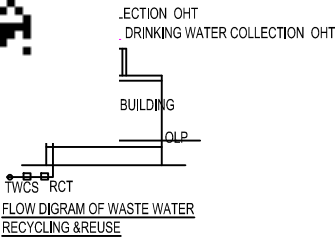


SITE PLAN (Scale : 1:100)

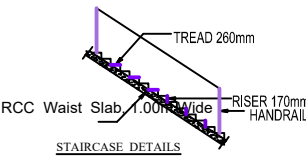

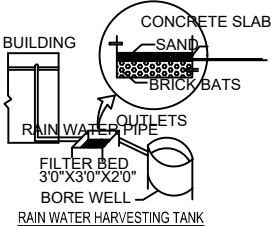

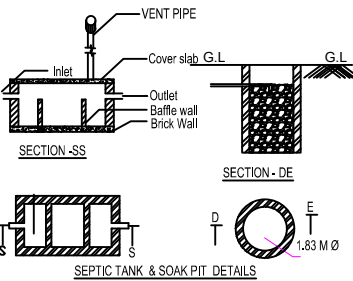
