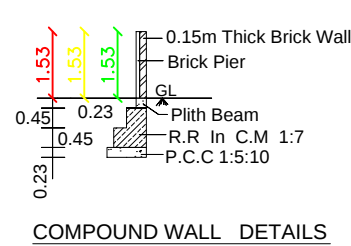

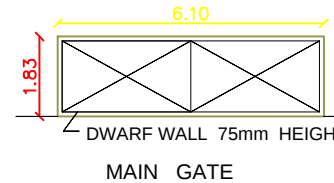
TERRACE FLOOR PLAN



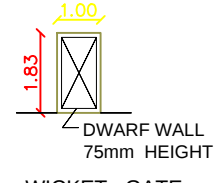
