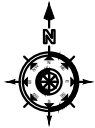

GROUND FLOOR

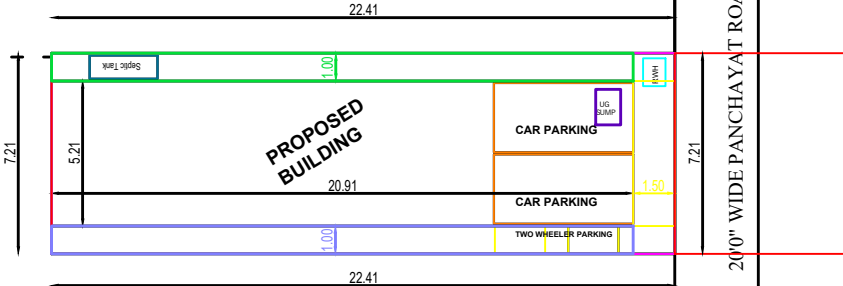


KEY PLAN

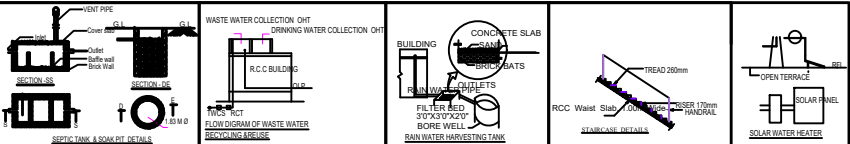
