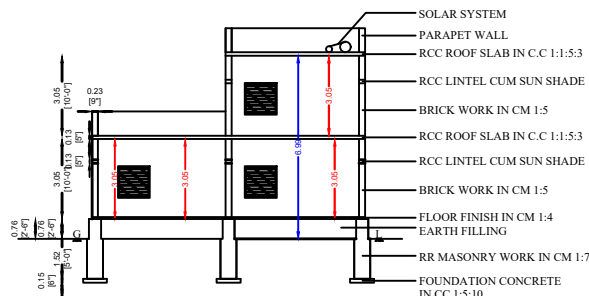

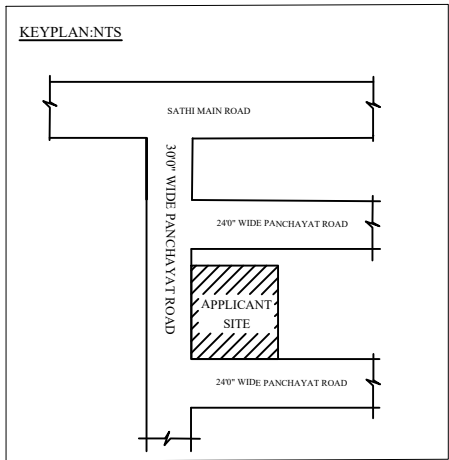

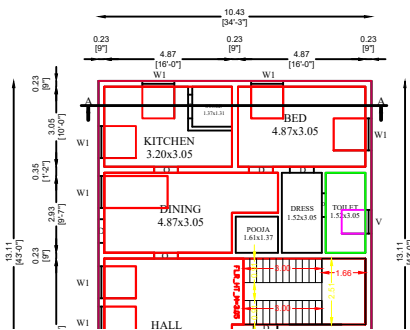

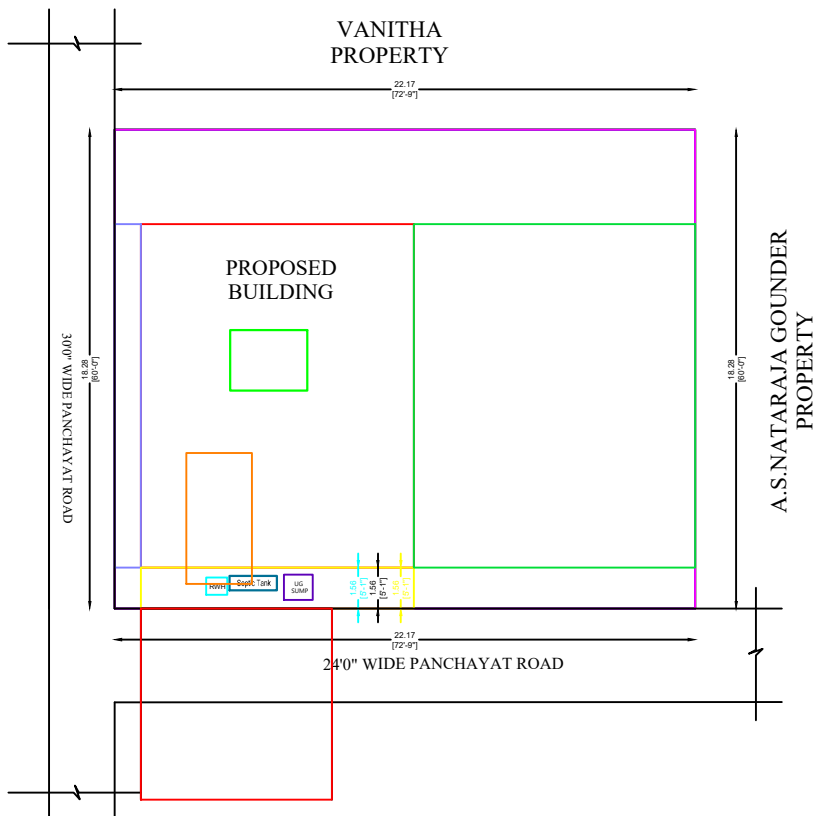

SITE PLAN ( Scale : 1:100)

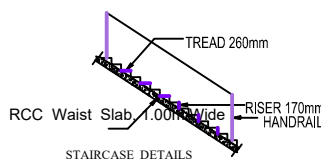

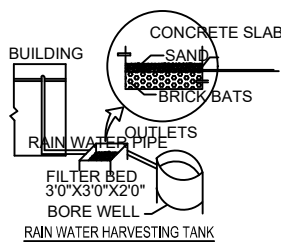
SOLAR WATER HEATER

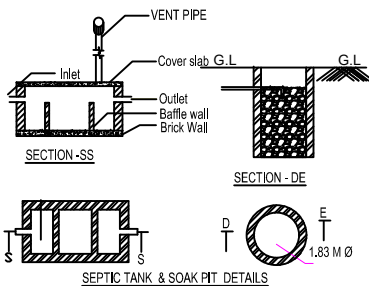
