MODAKKURICHI VILLAGE AND TOWN PANCHAYAT, MODAKKURICHI TALUK, ERODE DISTRICT.

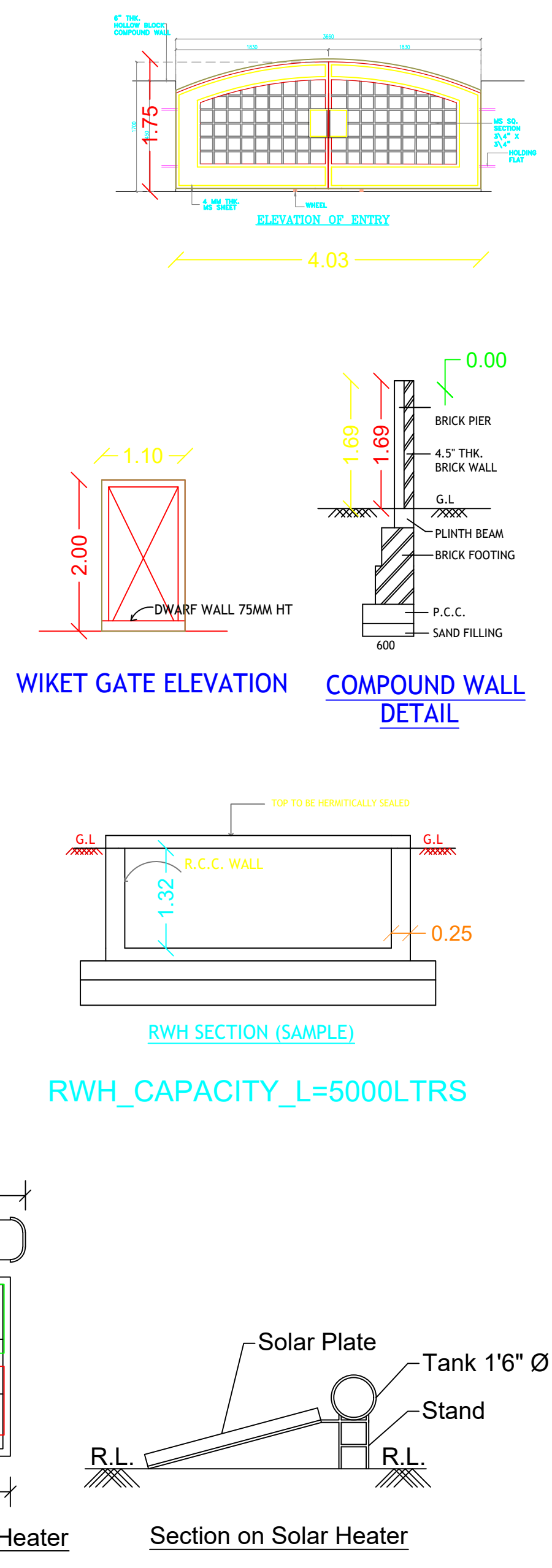
