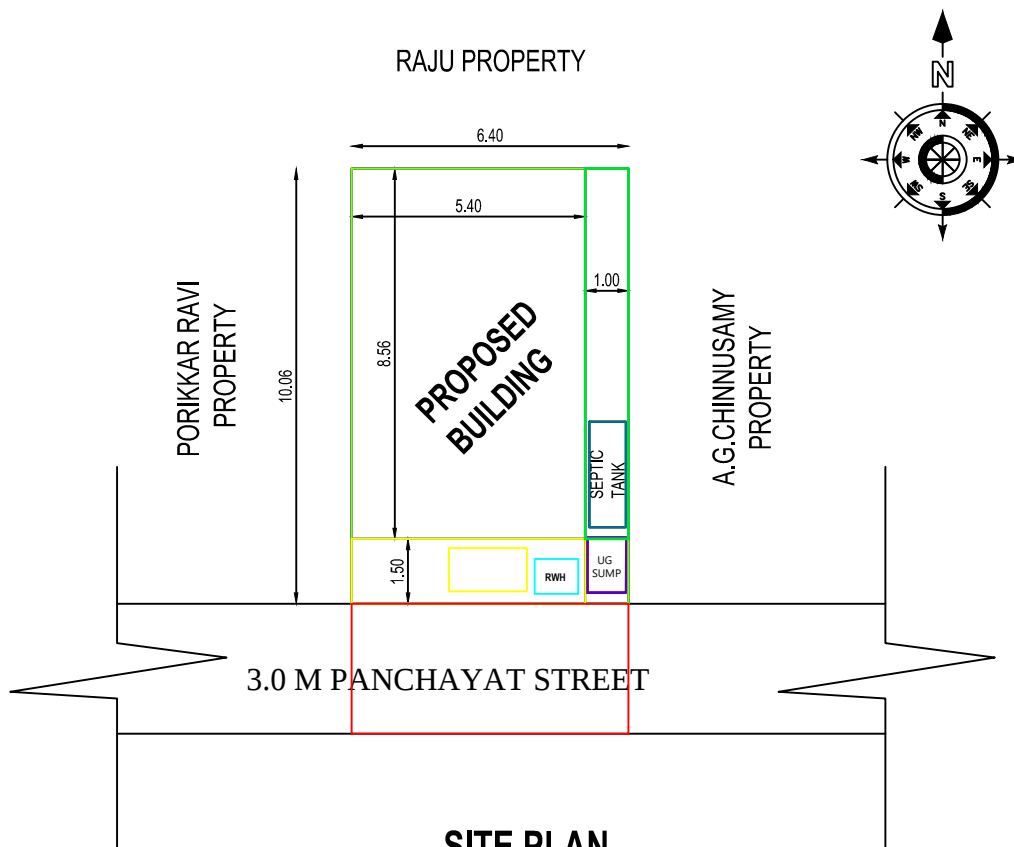

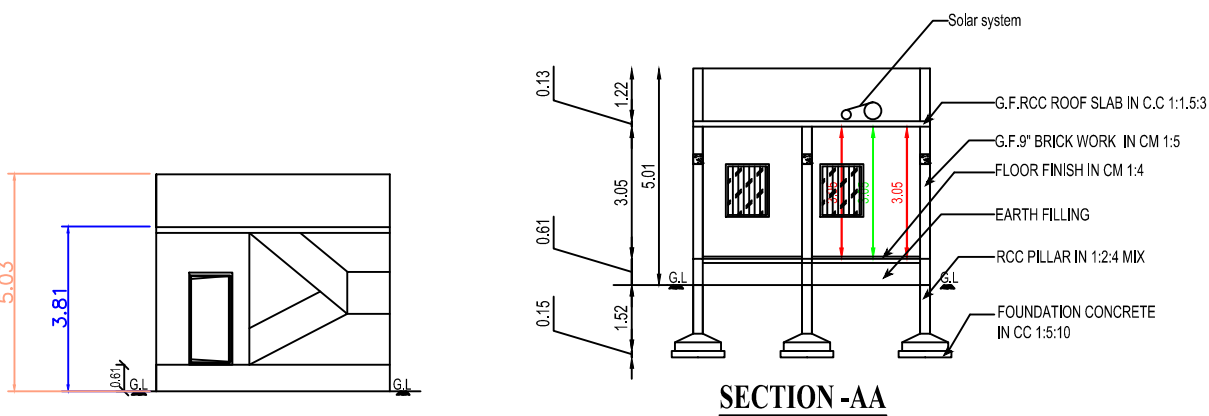

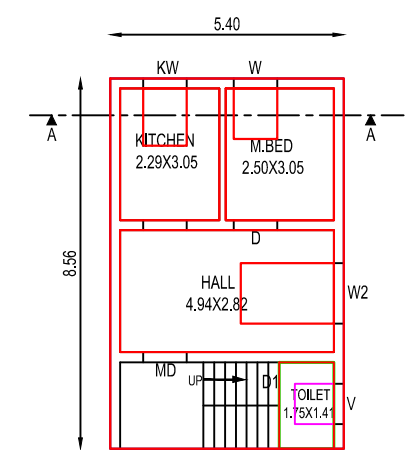


SITE PLAN

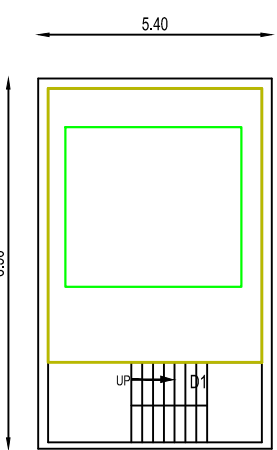

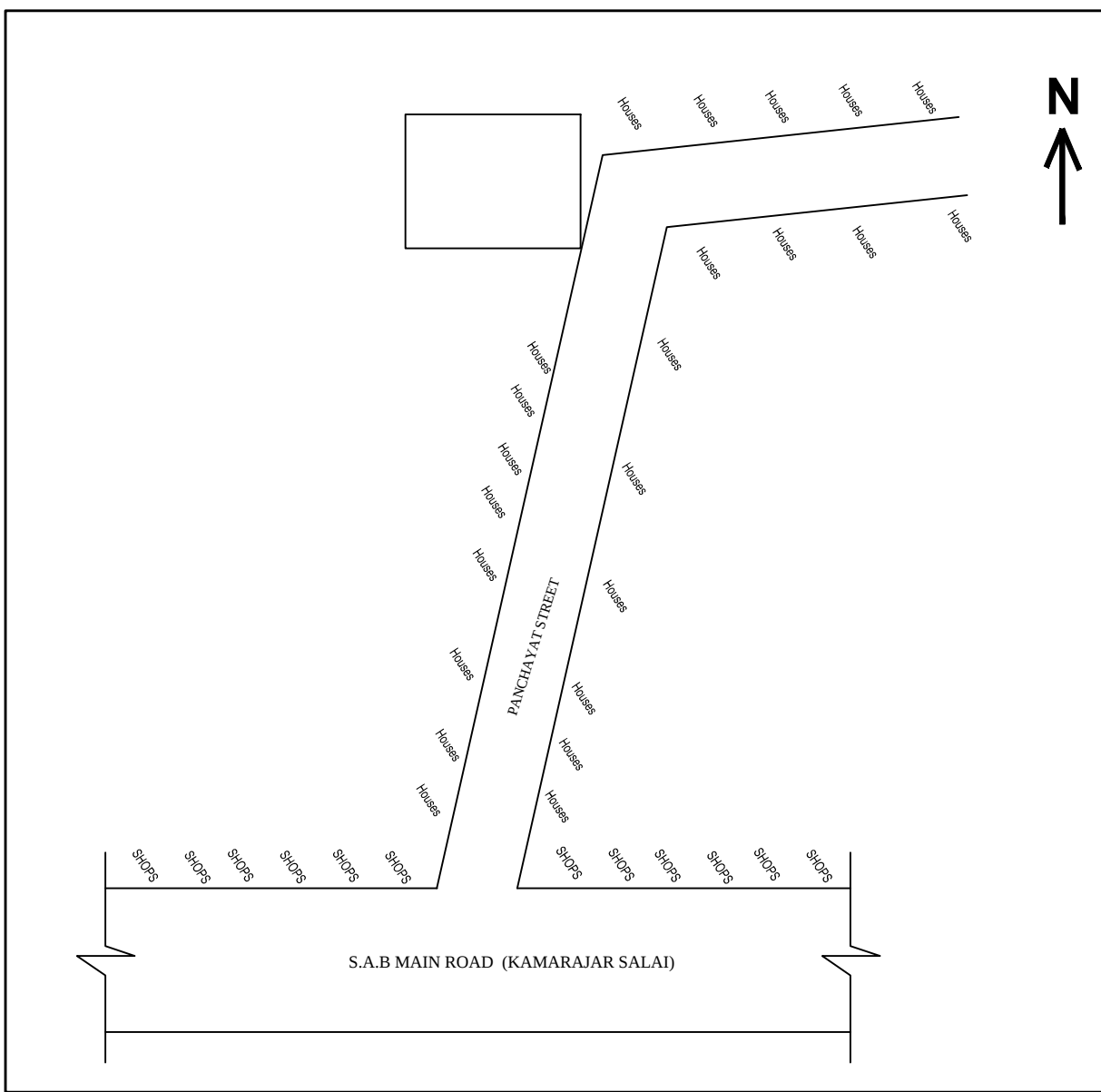
