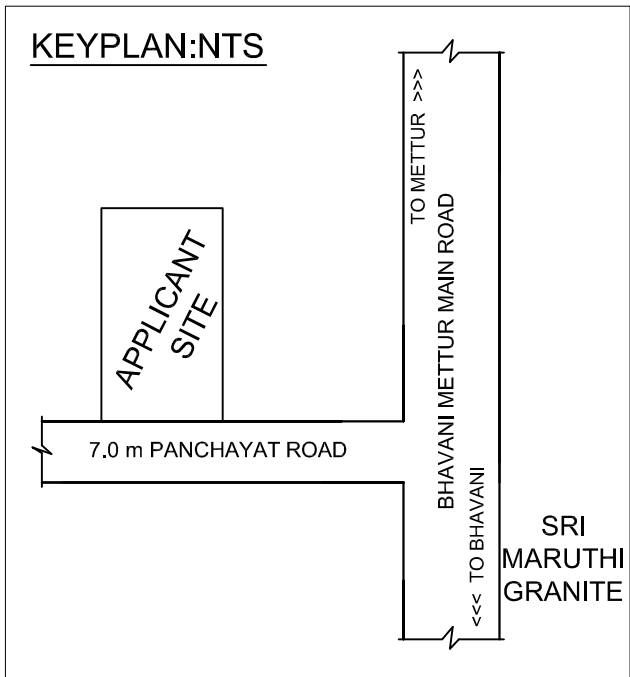

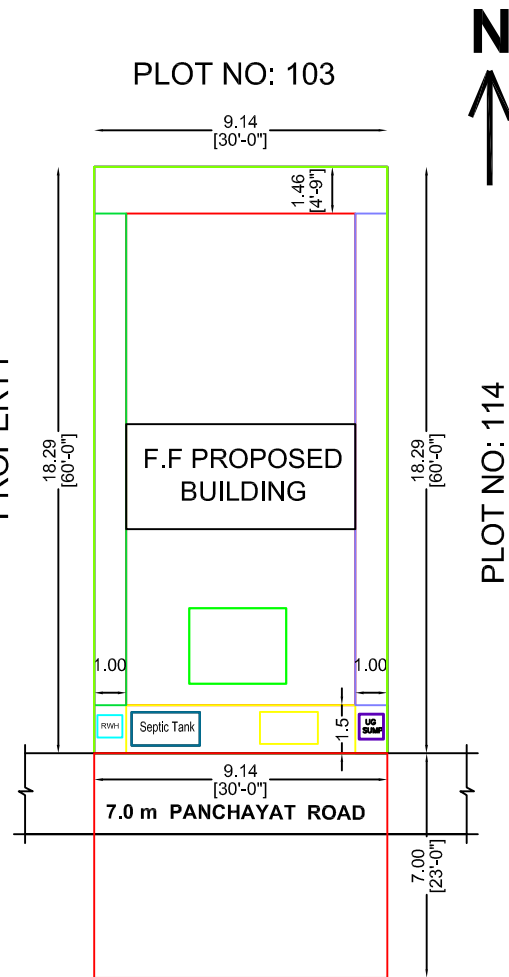
GROUND FLOOR PLAN

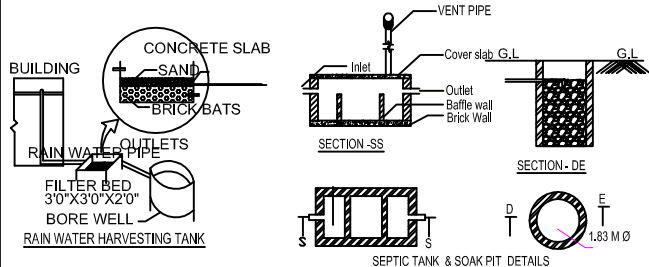
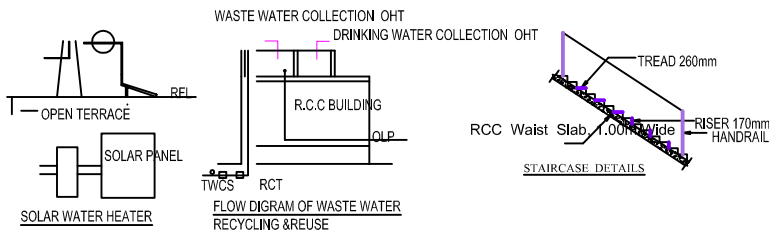
