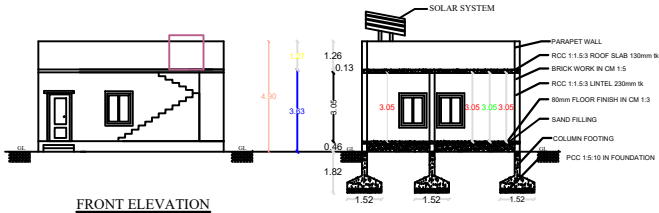

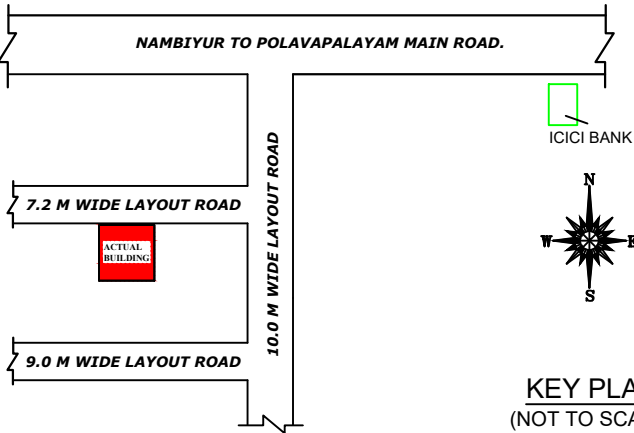
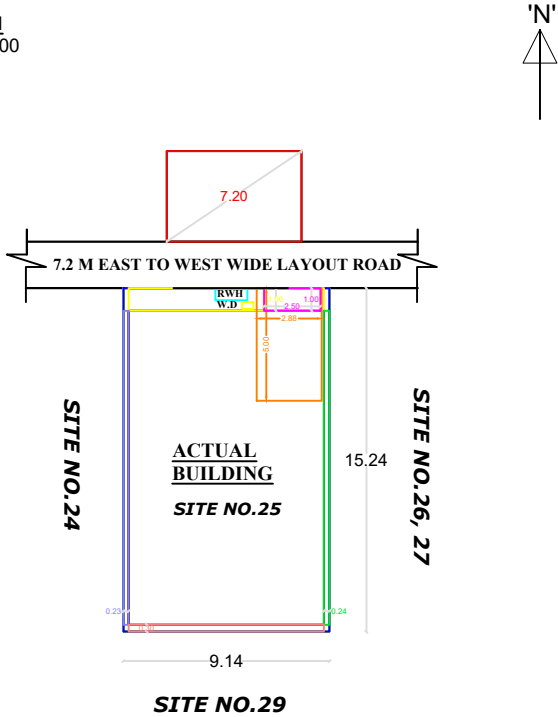


FRONT ELEVATION

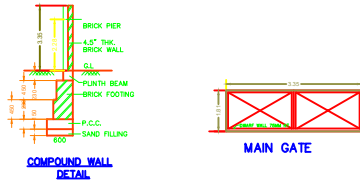
