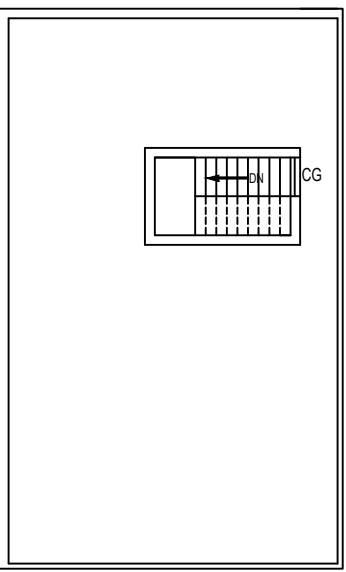

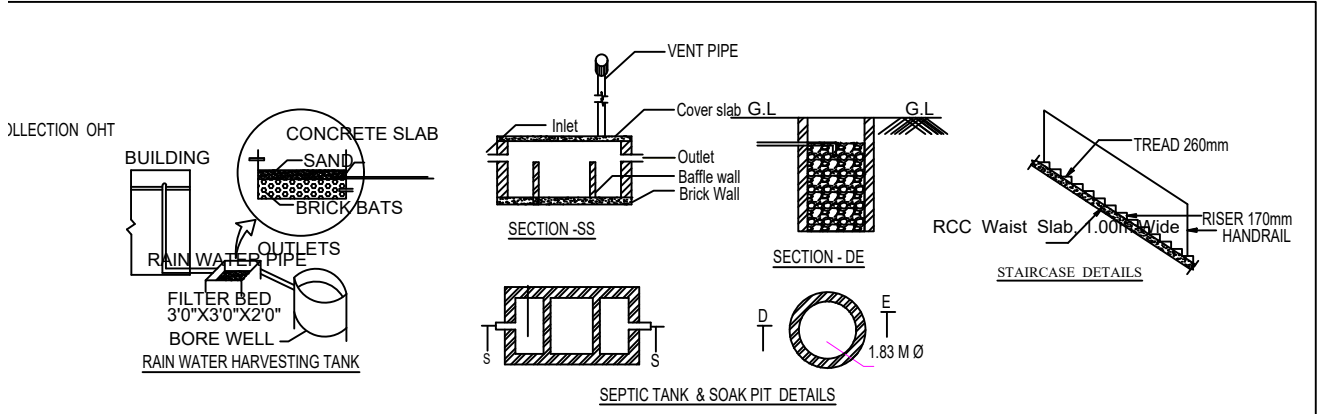
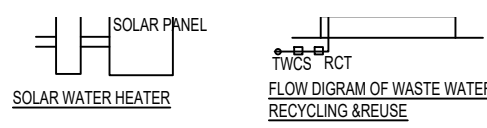

( Scale : 1:100 )

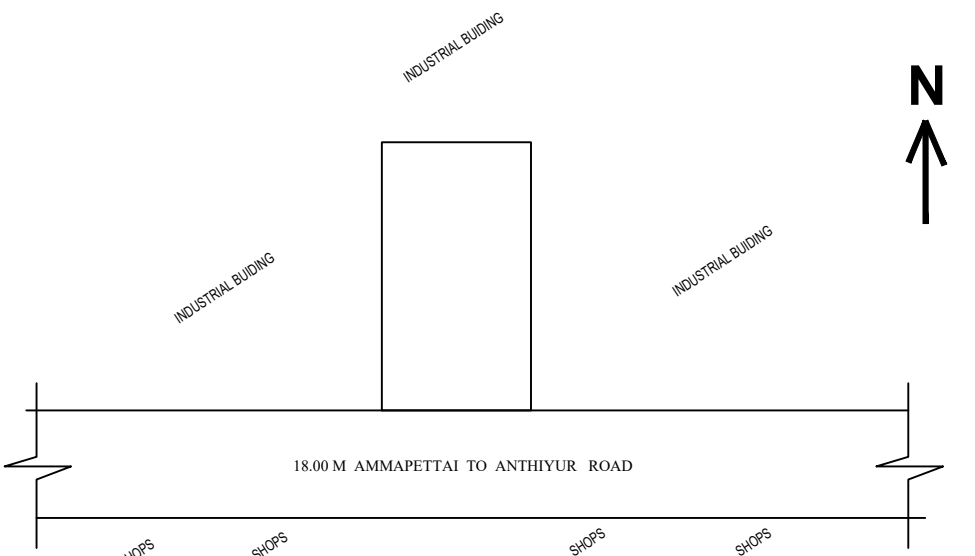


TERRACE FLOOR PLAN
