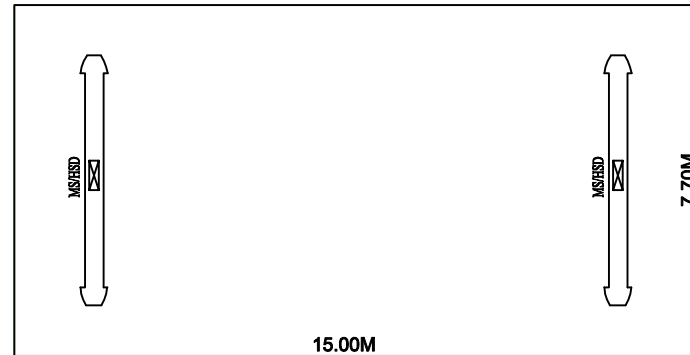

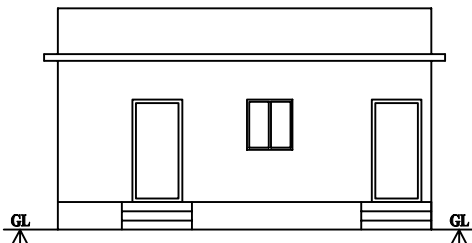

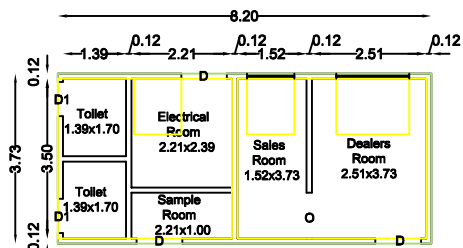

CANOPY BLOCK



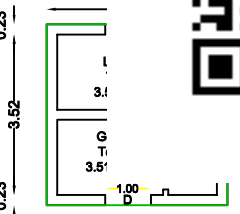

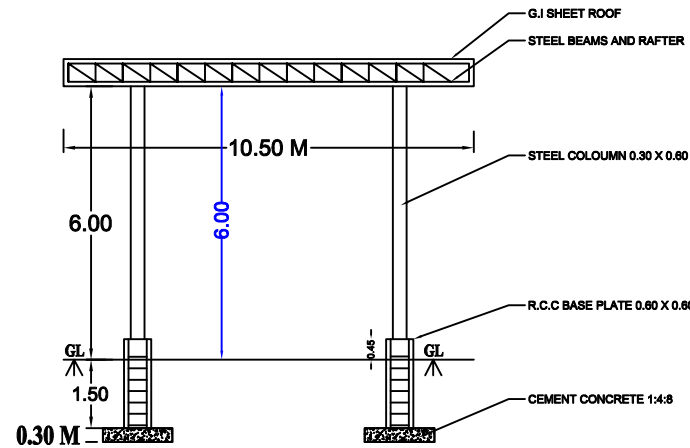

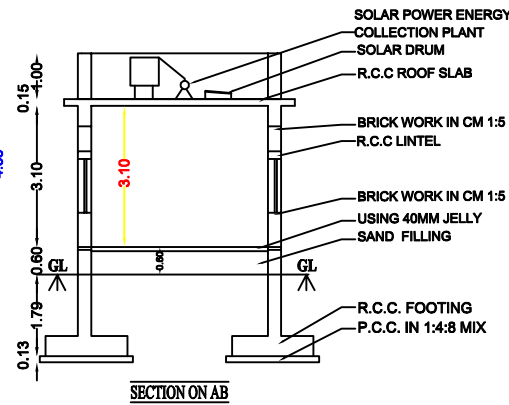

TOILET BLOCK



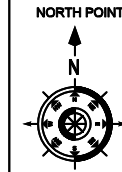

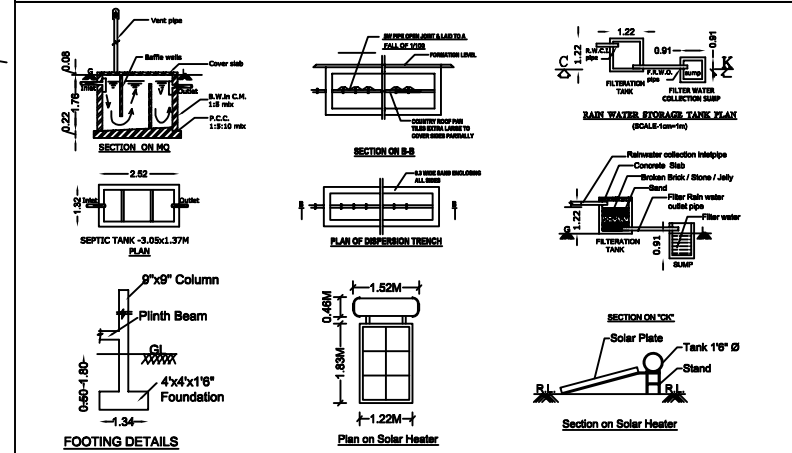


SITE PLAN
