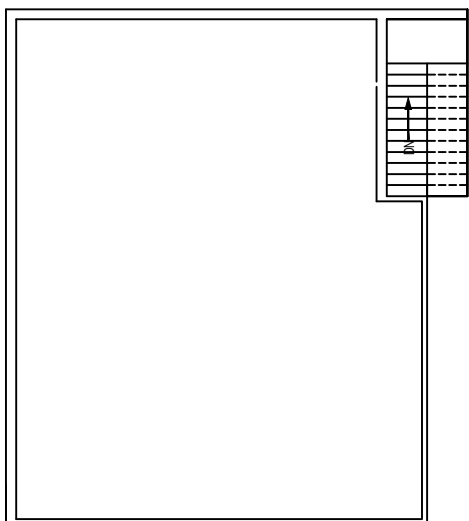

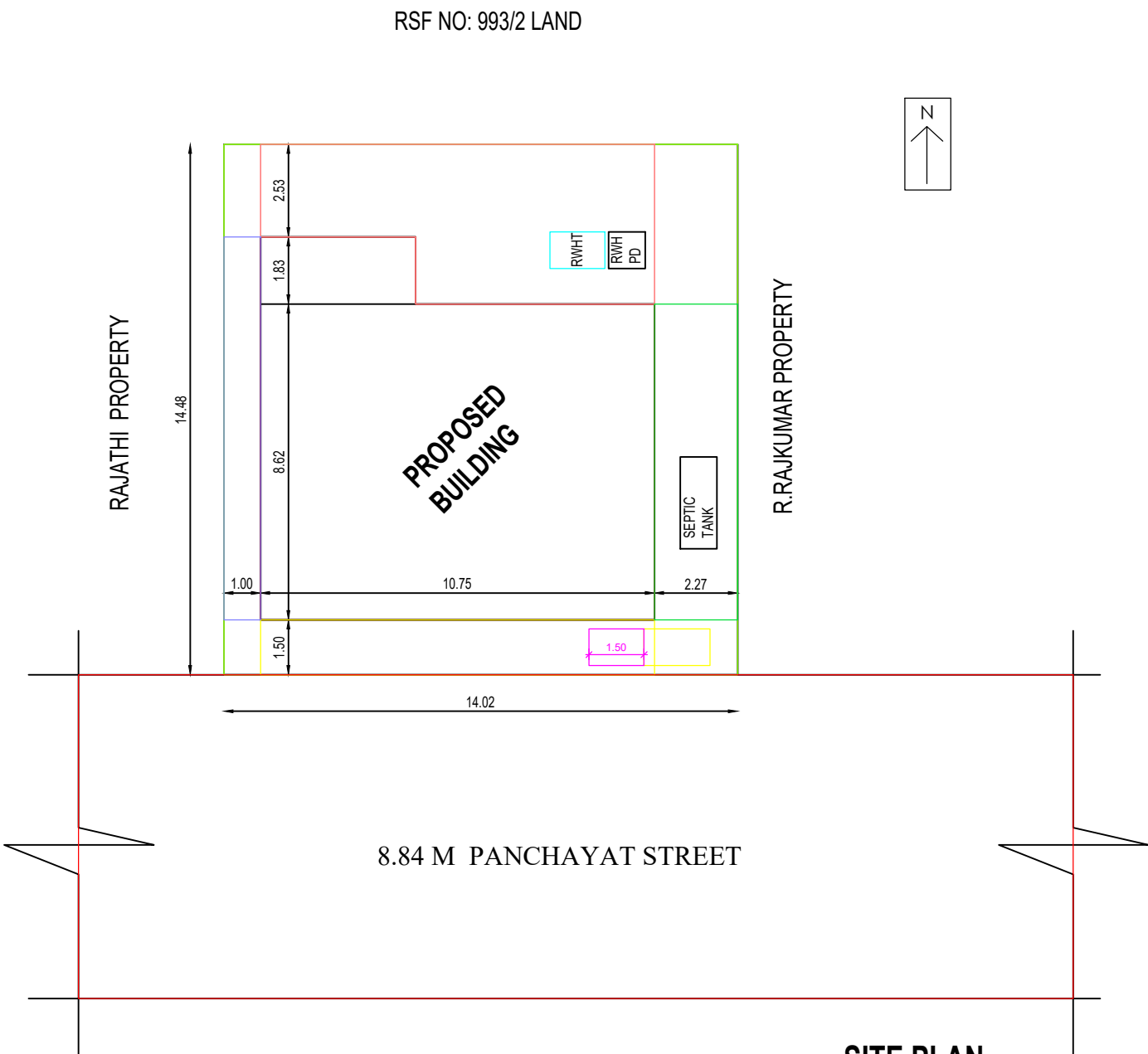

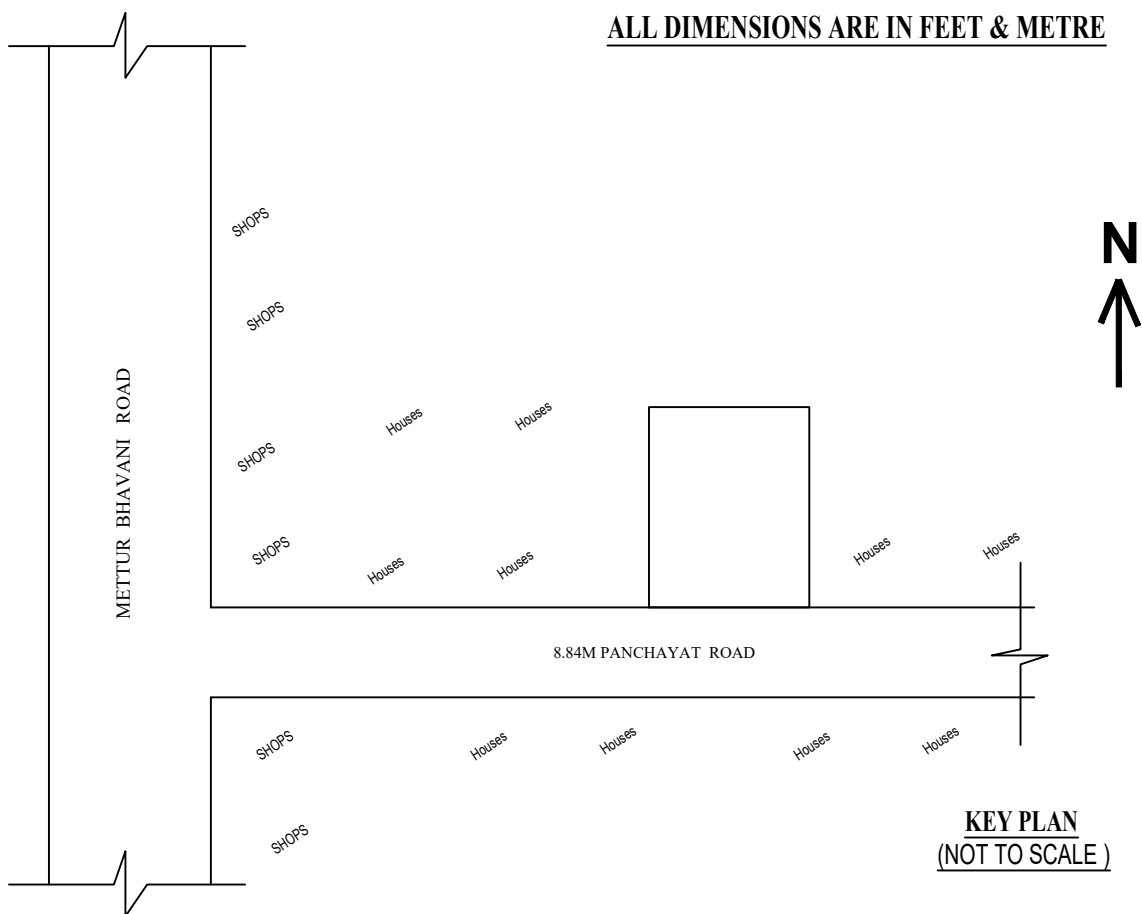
GROUND FLOOR PLAN

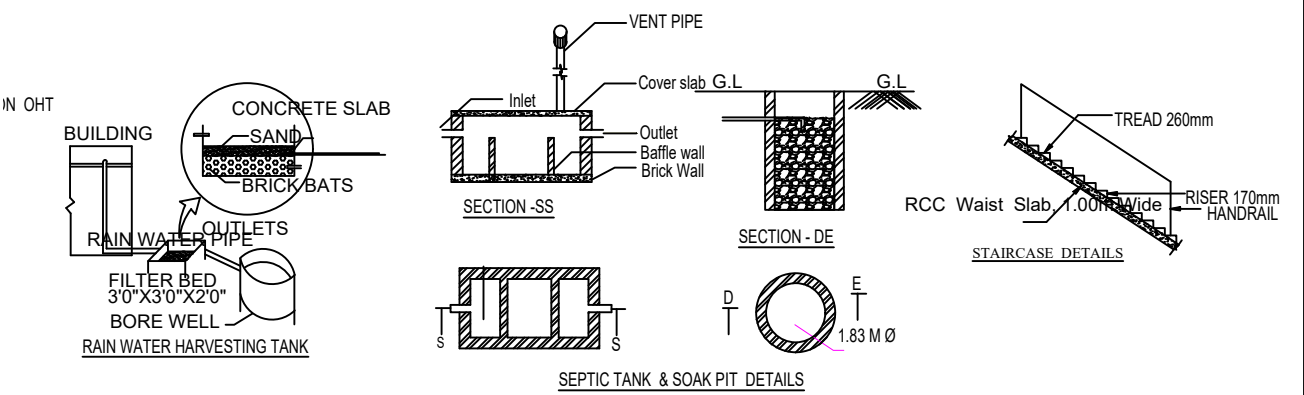
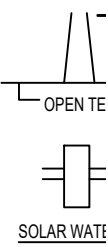
