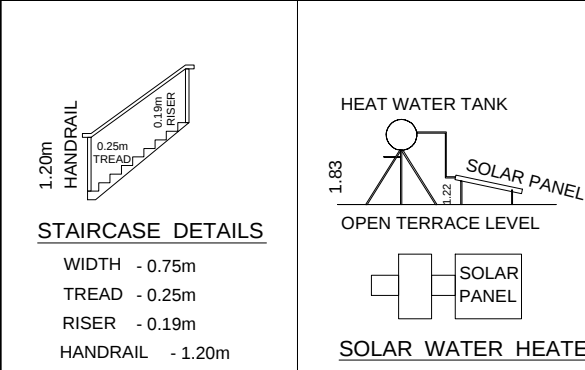
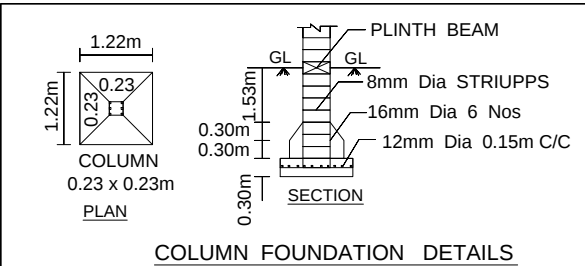
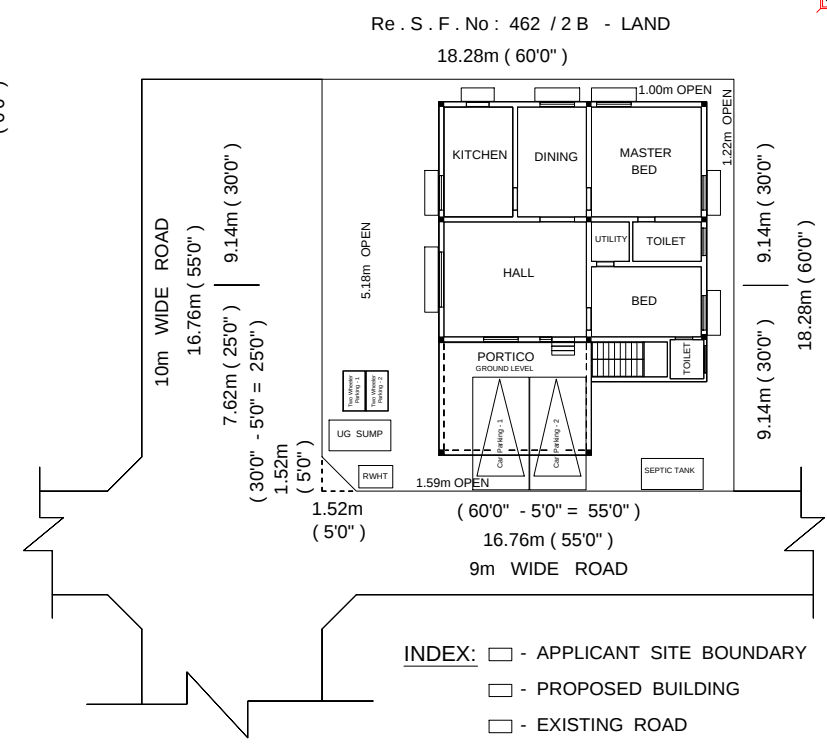


SITE, PLAN, ELEVATION
